SUBSTITUTE FOR

HOUSE BILL NO. 5439

A bill to amend 1974 PA 258, entitled "Mental health code,"

(MCL 330.1001 to 330.2106) by adding section 151.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 151. (1) AS USED IN THIS SECTION:
- 2 (A) "PSYCHIATRIC FACILITY" MEANS A PSYCHIATRIC HOSPITAL OR
- 3 PSYCHIATRIC UNIT LICENSED UNDER SECTION 134.
- 4 (B) "REGISTRY" MEANS THE INPATIENT PSYCHIATRIC BED REGISTRY
- 5 CREATED IN SUBSECTION (2).
- 6 (2) THE DEPARTMENT SHALL ESTABLISH AND ADMINISTER AN
- 7 ELECTRONIC INPATIENT PSYCHIATRIC BED REGISTRY. THE REGISTRY SHALL
- 8 BE A WEB-BASED RESOURCE TO IDENTIFY AVAILABLE PSYCHIATRIC BEDS IN
- 9 THIS STATE CATEGORIZED BY PATIENT GENDER, ACUITY, AGE, AND

- 1 DIAGNOSIS. THE REGISTRY MUST BE ACCESSIBLE THROUGH THE DEPARTMENT'S
- 2 WEBSITE.
- 3 (3) THE DEPARTMENT MAY, BY CONTRACT, DELEGATE CREATING,
- 4 OPERATING, AND MAINTAINING THE REGISTRY TO A PRIVATE ENTITY.
- 5 (4) PSYCHIATRIC FACILITIES AND OTHER PROVIDERS DETERMINED BY
- 6 THE DEPARTMENT MUST PROVIDE THE DEPARTMENT WITH THE NUMBER OF
- 7 INPATIENT PSYCHIATRIC BEDS AVAILABLE IN THOSE FACILITIES AT THE
- 8 TIME THE INFORMATION IS PROVIDED. THE INFORMATION MUST BE PROVIDED
- 9 BY THE PSYCHIATRIC FACILITIES AND OTHER PROVIDERS ON A BASIS AS
- 10 CLOSE TO REAL TIME AS POSSIBLE. PSYCHIATRIC FACILITIES AND OTHER
- 11 PROVIDERS MUST PROVIDE THE DEPARTMENT WITH THIS INFORMATION AS
- 12 SPECIFIED UNDER SUBSECTION (7).
- 13 (5) THE REGISTRY SHALL BE MADE ACCESSIBLE TO PREPAID INPATIENT
- 14 HEALTH PLANS, LICENSED HEALTH PLANS, COMMUNITY MENTAL HEALTH
- 15 SERVICES PROGRAMS, ACUTE CARE HOSPITALS, PSYCHIATRIC FACILITIES,
- 16 AND EMPLOYEES AND CAREGIVERS WITH OTHER APPROPRIATE PROVIDERS.
- 17 (6) THE DEPARTMENT SHALL CREATE A COMMITTEE TO PROVIDE
- 18 GUIDANCE ON CREATING, OPERATING, AND MAINTAINING THE REGISTRY. THE
- 19 COMMITTEE SHALL INCLUDE REPRESENTATIVES FROM THE FOLLOWING GROUPS:
- 20 (A) THE DEPARTMENT.
- 21 (B) THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS.
- 22 (C) PSYCHIATRIC FACILITIES.
- 23 (D) END USERS OF THE REGISTRY AS DESCRIBED UNDER SUBSECTION
- 24 (5).
- 25 (E) CONSUMERS, FAMILIES, AND ADVOCATES.
- 26 (F) LAW ENFORCEMENT.
- 27 (7) THE DEPARTMENT SHALL ESTABLISH REQUIREMENTS FOR

- PSYCHIATRIC FACILITIES AND OTHER PROVIDERS AS DETERMINED BY THE 1
- 2 DEPARTMENT TO REPORT INFORMATION TO THE DEPARTMENT IN CONSULTATION
- 3 WITH THE COMMITTEE ESTABLISHED UNDER SUBSECTION (6).
- 4 (8) THE DEPARTMENT SHALL PROVIDE QUARTERLY REPORTS ON THE
- PROGRESS OF IMPLEMENTING THE REGISTRY BEGINNING ON THE FIRST 5
- QUARTER AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- THIS SECTION. THE DEPARTMENT MUST PROVIDE THESE QUARTERLY REPORTS 7
- TO THE CHAIRS OF THE HOUSE AND SENATE COMMITTEES ON HEALTH POLICY 8
- AND THE CHAIRS OF THE HOUSE AND SENATE APPROPRIATIONS SUBCOMMITTEES 9
- FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES. 10
- (9) THE DEPARTMENT, IN CONSULTATION WITH THE COMMITTEE 11
- 12 ESTABLISHED UNDER SUBSECTION (6), MAY ESTABLISH A POLICY FOR THE
- SECONDARY USE OF REGISTRY DATA. 13
- 14 Enacting section 1. This amendatory act takes effect 90 days
- 15 after the date it is enacted into law.
