SUBSTITUTE FOR

HOUSE BILL NO. 5601

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1538g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1538G. (1) THE SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL
- 2 NOT APPROVE A TEACHER PREPARATION INSTITUTION UNDER SECTION 1538A
- 3 AND R 390.1151 TO R 390.1153 OF THE MICHIGAN ADMINISTRATIVE CODE
- 4 UNLESS THE TEACHER PREPARATION INSTITUTION MEETS BOTH OF THE
- 5 FOLLOWING:
- 6 (A) REQUIRES STUDENTS ENROLLED IN A TEACHER PREPARATION
- 7 PROGRAM AT THE TEACHER PREPARATION INSTITUTION TO ENGAGE IN AT
- 8 LEAST 400 HOURS OF CUMULATIVE K-12 CLASSROOM EXPERIENCE OR
- 9 PRACTICUM EXPERIENCE, OR BOTH, IN ADDITION TO ANY STUDENT TEACHING
- 10 REQUIREMENTS.

- (B) COUNTS A STUDENT'S CLINICAL EXPERIENCE AND SUBSTITUTE 1
- 2 TEACHING EXPERIENCE TOWARD THE REQUIREMENT UNDER SUBDIVISION (A).
- (2) BEGINNING JULY 1, 2019, IF THE SUPERINTENDENT OF PUBLIC 3
- 4 INSTRUCTION APPROVED A TEACHER PREPARATION INSTITUTION UNDER
- SECTION 1538A AND R 390.1151 TO 390.1153 OF THE MICHIGAN 5
- ADMINISTRATIVE CODE BEFORE THE EFFECTIVE DATE OF THIS SECTION AND
- THE TEACHER PREPARATION INSTITUTION DID NOT MEET THE REQUIREMENTS 7
- UNDER THIS SECTION AT THE TIME THE APPROVAL WAS ISSUED, THE 8
- SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL REVOKE THE APPROVAL. IF 9
- 10 THE SUPERINTENDENT OF PUBLIC INSTRUCTION REVOKES AN APPROVAL UNDER
- 11 THIS SUBSECTION, THE TEACHER PREPARATION INSTITUTION MAY REAPPLY
- 12 FOR APPROVAL, IN A FORM AND MANNER PRESCRIBED BY THE SUPERINTENDENT
- OF PUBLIC INSTRUCTION. 13
- 14 Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 15
