



HOUSE BILL No. 5739

March 21, 2018, Introduced by Rep. Marino and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled
"Income tax act of 1967,"
by amending section 435 (MCL 206.435), as amended by 2016 PA 184.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 435. (1) Except as otherwise provided under this section,
2 ~~for the 2008 tax year and each tax year after the 2008 tax year, an~~
3 individual may designate in a manner and form as prescribed by the
4 department pursuant to subsection (2) on his or her annual return
5 that contributions of \$5.00, \$10.00, or more of his or her refund
6 be credited to any of the following:

5 **(F) ~~(j)~~**—For the 2016 tax year and each tax year after the 2016
 6 tax year, the American Red Cross Michigan fund created in section 5
 7 of the American Red Cross Michigan fund act, **2016 PA 183, MCL**
 8 **206.1035.**

9 **(G) FOR THE 2018 TAX YEAR AND EACH TAX YEAR AFTER THE 2018 TAX**
 10 **YEAR, THE KIWANIS FUND CREATED IN SECTION 5 OF THE KIWANIS FUND**
 11 **ACT.**

12 (2) Subject to the limitations provided under this subsection,
 13 the department shall establish and utilize a separate contributions
 14 schedule that incorporates each contribution designation authorized
 15 under this section that remains in effect and available for each
 16 tax year and shall revise the state individual income tax return
 17 form to include a separate line for the total contribution
 18 designations made under the separate contributions schedule. The
 19 contribution designations authorized under sections 437, 438, and
 20 440 shall be incorporated into the contributions schedule for the
 21 2010 tax year and shall remain on the schedule until the
 22 contribution designation expires by law or is otherwise no longer
 23 available as determined by the department pursuant to subsection
 24 (3). A contribution designation that is enacted after November 1,
 25 2007 shall be incorporated as soon as practical on the
 26 contributions schedule, and each new contribution designation shall
 27 be listed on the schedule in alphabetical order. The separate

1 contributions schedule required under this section shall include
2 not more than 10 separate contribution designations in any single
3 tax year.

4 (3) The department shall cease to include a contribution
5 designation on the contributions schedule if that contribution
6 designation fails to raise \$50,000.00 in any tax year for 2
7 consecutive tax years.

8 (4) If an individual's refund is not sufficient to make a
9 contribution under this section, the individual may designate a
10 contribution amount and that contribution amount shall be added to
11 the individual's tax liability for the tax year.

12 (5) Notwithstanding any other allocations or disbursements
13 required by this act, each year that a contribution designation
14 under this section is in effect, an amount equal to the cumulative
15 designation made under this section, less the amount appropriated
16 to the department to implement this section, shall be appropriated
17 from the general fund and distributed to the department responsible
18 for administering the appropriate fund to which the taxpayer
19 designated his or her contribution and shall be used solely for the
20 purposes of that fund.

21 (6) Money appropriated pursuant to an appropriations act as
22 required by law in accordance with this section to the department
23 responsible for administering each respective fund shall be in
24 addition to any other allocation or appropriation and is intended
25 to enhance appropriations from the general fund and not to replace
26 or supplant those appropriations.

27 (7) Notwithstanding any other provision of law, all of the

1 following apply:

2 (a) Money appropriated from the contributions made pursuant to
3 this section shall be distributed as provided in each respective
4 fund within 1 year and none of the money appropriated pursuant to
5 this section shall be used for the purpose of administering the
6 fund.

7 (b) If the fund to which the taxpayer designated his or her
8 contributions is to be used for donations to multiple organizations
9 located in this state, the department responsible for administering
10 that fund shall designate 1 local representative or agency of that
11 organization to administer and distribute those funds to other
12 similar organizations in this state as provided in each respective
13 act that created the fund.

14 (8) When considering whether to grant legislative approval to
15 amend the state individual income tax return to include additional
16 contribution designations on the contributions schedule, the
17 legislature shall consider all of the following:

18 (a) Whether the organization serves multiple regions
19 throughout this state.

20 (b) Whether the organization has demonstrated that it is
21 capable of raising more than \$50,000.00 in this state during the
22 tax year through means other than the income tax contribution
23 designation.

24 (c) Whether the organization expends 30% or more of its money
25 to cover administrative and fund-raising costs.

26 (d) Whether the organization had previously been included on
27 the contributions schedule within the last immediately preceding 3

1 years and was removed because it failed to raise a sufficient
2 amount of money as prescribed under subsection (3).

3 (e) Whether the organization receives any other state funds or
4 other type of financial assistance from this state.

5 (f) Whether the organization is associated with a nonprofit
6 charitable organization.

7 Enacting section 1. This amendatory act does not take effect
8 unless Senate Bill No. ____ or House Bill No. 5740 (request no.
9 05873'18) of the 99th Legislature is enacted into law.
