## SUBSTITUTE FOR HOUSE BILL NO. 5791

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 1508 and 1526b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1508. (1) NOT LATER THAN JUNE 1, 2019, IN CONSULTATION
- 2 WITH EXPERTS ON SEXUAL ASSAULT AND SEXUAL HARASSMENT, INCLUDING,
- 3 BUT NOT LIMITED TO, THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE
- 4 PREVENTION AND TREATMENT BOARD AND THE MICHIGAN COALITION TO END
- 5 DOMESTIC AND SEXUAL VIOLENCE, THE DEPARTMENT SHALL DEVELOP AGE-
- 6 APPROPRIATE INFORMATIONAL MATERIAL RELATING TO SEXUAL ASSAULT AND
- 7 SEXUAL HARASSMENT AND MAKE THAT MATERIAL AVAILABLE TO ALL SCHOOL
- 8 DISTRICTS, INTERMEDIATE SCHOOL DISTRICTS, AND PUBLIC SCHOOL
- 9 ACADEMIES THAT OPERATE ANY OF GRADES 6 TO 12. THE INFORMATIONAL
- 10 MATERIAL MUST INCLUDE AT LEAST ALL OF THE FOLLOWING:

- 1 (A) INFORMATION REGARDING WHAT CONSTITUTES SEXUAL ASSAULT OR
- 2 SEXUAL HARASSMENT.
- 3 (B) AN EXPLANATION THAT SEXUAL ASSAULT OR SEXUAL HARASSMENT IS
- 4 NOT THE VICTIM'S FAULT.
- 5 (C) RESOURCES AVAILABLE FOR INDIVIDUALS WHO HAVE EXPERIENCED
- 6 SEXUAL ASSAULT OR SEXUAL HARASSMENT, INCLUDING, BUT NOT LIMITED TO,
- 7 INFORMATION ON TITLE IX, AS ENACTED UNDER THE EDUCATION AMENDMENTS
- 8 OF 1972, 20 USC 1681 TO 1688, APPROPRIATE CONTACT INFORMATION FOR
- 9 ORGANIZATIONS THAT OFFER ASSISTANCE TO VICTIMS OF SEXUAL ASSAULT OR
- 10 SEXUAL HARASSMENT, AND ACTIONS THAT THE INDIVIDUAL MAY TAKE.
- 11 (2) A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 12 SCHOOL ACADEMY SHALL DISSEMINATE THE INFORMATIONAL MATERIAL MADE
- 13 AVAILABLE BY THE DEPARTMENT UNDER SUBSECTION (1) TO EACH PUPIL IN
- 14 GRADES 6 TO 12 WHO IS ENROLLED IN A SCHOOL OPERATED BY THE SCHOOL
- 15 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY,
- 16 IN A FORM AND MANNER DETERMINED APPROPRIATE BY THE SCHOOL DISTRICT,
- 17 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY.
- 18 ADDITIONALLY, THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
- 19 PUBLIC SCHOOL ACADEMY SHALL DISSEMINATE TO THOSE PUPILS THE CONTACT
- 20 INFORMATION FOR THE SCHOOL DISTRICT'S, INTERMEDIATE SCHOOL
- 21 DISTRICT'S, OR PUBLIC SCHOOL ACADEMY'S TITLE IX COORDINATOR AND THE
- 22 SCHOOL DISTRICT'S, INTERMEDIATE SCHOOL DISTRICT'S, OR PUBLIC SCHOOL
- 23 ACADEMY'S POLICIES ON SEXUAL ASSAULT AND SEXUAL HARASSMENT,
- 24 INCLUDING SPECIFIC INFORMATION STATING THAT THE POLICIES PROHIBIT
- 25 ADVERSE ACTION AGAINST AN INDIVIDUAL FOR REPORTING SEXUAL ASSAULT
- 26 OR SEXUAL HARASSMENT, IN A FORM AND MANNER DETERMINED APPROPRIATE
- 27 BY THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC

- 1 SCHOOL ACADEMY. THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT,
- 2 OR PUBLIC SCHOOL ACADEMY SHALL ENSURE THAT ALL THE INFORMATION
- 3 DESCRIBED IN THIS SUBSECTION REMAINS ACCESSIBLE TO THOSE PUPILS AND
- 4 THEIR PARENTS OR LEGAL GUARDIANS AND IS INCLUDED IN A STUDENT
- 5 HANDBOOK OR SIMILAR PUBLICATION PREPARED BY THE SCHOOL DISTRICT,
- 6 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY AND ON THE
- 7 SCHOOL DISTRICT'S, INTERMEDIATE SCHOOL DISTRICT'S, OR PUBLIC SCHOOL
- 8 ACADEMY'S WEBPAGE IF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 9 DISTRICT, OR PUBLIC SCHOOL ACADEMY MAINTAINS A WEBPAGE.
- 10 SEC. 1526B. BEGINNING IN THE 2019-2020 SCHOOL YEAR, THE BOARD
- 11 OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR BOARD OF
- 12 DIRECTORS OF A PUBLIC SCHOOL ACADEMY, TOGETHER WITH A LOCAL
- 13 ORGANIZATION THAT RECEIVES FUNDING FROM THE MICHIGAN DOMESTIC AND
- 14 SEXUAL VIOLENCE PREVENTION AND TREATMENT BOARD AND THAT SERVES THE
- 15 GEOGRAPHIC AREA OF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 16 DISTRICT, OR PUBLIC SCHOOL ACADEMY, IS ENCOURAGED TO PROVIDE ALL
- 17 EDUCATORS AND SCHOOL PERSONNEL WHO HAVE CONTACT WITH PUPILS
- 18 TRAINING AT LEAST EVERY 5 YEARS IN RESPONDING TO PUPILS WHO HAVE
- 19 EXPERIENCED SEXUAL ASSAULT OR SEXUAL HARASSMENT. THIS TRAINING MAY
- 20 BE PROVIDED AS PART OF THE PROFESSIONAL DEVELOPMENT PROVIDED UNDER
- 21 SECTION 1527. IF A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT,
- 22 OR PUBLIC SCHOOL ACADEMY IS LOCATED IN AN AREA WITHOUT A LOCAL
- 23 ORGANIZATION THAT RECEIVES FUNDING FROM THE MICHIGAN DOMESTIC AND
- 24 SEXUAL VIOLENCE PREVENTION AND TREATMENT BOARD, THE SCHOOL
- 25 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY IS
- 26 ENCOURAGED TO PROVIDE THE TRAINING DESCRIBED IN THIS SECTION
- 27 TOGETHER WITH THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE PREVENTION

- AND TREATMENT BOARD OR THE MICHIGAN COALITION TO END DOMESTIC AND 1
- 2 SEXUAL VIOLENCE.
- Enacting section 1. This amendatory act takes effect 90 days 3
- 4 after the date it is enacted into law.
