

HOUSE BILL No. 6200

June 12, 2018, Introduced by Reps. Chatfield, Allor, Cole, LaFave, Hughes, Alexander, Hornberger, Kahle and Barrett and referred to the Committee on Michigan Competitiveness.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 80158a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 80158A. (1) EXCEPT IN AN EMERGENCY OR WITH PRIOR WRITTEN
- 2 PERMISSION GRANTED BY THE DIRECTOR, THE OPERATOR OF A VESSEL SHALL
- 3 NOT DEPLOY, DRAG, SET, OR USE ANY ANCHOR OR ANY OTHER VESSEL
- 4 EQUIPMENT THAT MAY COME INTO CONTACT WITH THE LAKE BOTTOMLANDS IN
- 5 THE AREA BOUNDED ON THE WEST BY A LINE BEGINNING AT LATITUDE N 45°
- 5 46' 48.883" LONGITUDE W 84° 47' 34.705" AND EXTENDING NORTH TO
- 7 POINT LATITUDE N 45° 50' 23.169" LONGITUDE W 84° 46' 8.476" AND
- BOUNDED ON THE EAST BY A LINE BEGINNING AT LATITUDE N $45\,^\circ$ $47\,^\circ$
- 9 18.4812" LONGITUDE W $84\degree$ 43' 55.2396" AND EXTENDING NORTH TO POINT

- 1 LATITUDE N 45° 50' 46.086" LONGITUDE W 84° 43' 24.1392".
- 2 (2) A PERSON THAT WISHES TO RECEIVE PERMISSION TO USE AN
- 3 ANCHOR OR OTHER VESSEL EQUIPMENT THAT MAY CONTACT THE BOTTOMLANDS
- 4 IN THE AREA DESCRIBED IN SUBSECTION (1) MAY SUBMIT A REQUEST, IN
- 5 WRITING, TO THE DEPARTMENT. THE REQUEST MUST CONTAIN A PRECISE
- 6 DESCRIPTION OF THE AREA WHERE USE OF AN ANCHOR OR OTHER EQUIPMENT
- 7 IS REQUESTED AND THE REASON FOR THE REQUEST.
- 8 (3) SUBSECTION (1) DOES NOT APPLY TO VESSELS EXERCISING TRIBAL
- 9 USUFRUCTUARY RIGHTS RESERVED IN THE MARCH 28, 1836 TREATY OF
- 10 WASHINGTON (7 STAT 491) AND AS STATED IN THE NOVEMBER 2, 2007
- 11 CONSENT DECREE (DKT. 1799 IN W.D. MICH. CASE NO. 2:73-CV-000026).
- 12 (4) EXCEPT AS PROVIDED IN SUBSECTION (5), A PERSON WHO
- 13 KNOWINGLY VIOLATES THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY
- 14 IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN
- 15 \$10,000.00, OR BOTH.
- 16 (5) A PERSON WHO IS CONVICTED OF A SECOND OR SUBSEQUENT
- 17 VIOLATION OF THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY
- 18 IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF NOT MORE THAN
- 19 \$15,000.00, OR BOTH.
