

**SENATE SUBSTITUTE FOR
HOUSE BILL NO. 6205**

A bill to amend 1988 PA 466, entitled
"Animal industry act,"
by amending the title and sections 1, 3, 7, 9, 11b, 12, 14, 19, 20,
22, 31, 39, 40, 43, and 44 (MCL 287.701, 287.703, 287.707, 287.709,
287.711b, 287.712, 287.714, 287.719, 287.720, 287.722, 287.731,
287.739, 287.740, 287.743, and 287.744), the title and section 43
as amended by 1996 PA 369, sections 1, 20, 39, and 40 as amended by
2000 PA 323, sections 3, 9, 11b, 14, 19, 22, and 44 as amended by
2002 PA 458, section 7 as amended by 1994 PA 41, and sections 12
and 31 as amended by 2003 PA 271, and by adding sections 3a, 3b,
12a, 12b, 14a, 17b, 17c, 17d, 40a, 40b, and 43a; and to repeal acts
and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

1 An act to authorize and require the appointment of a state
 2 veterinarian within the department of agriculture **AND RURAL**
 3 **DEVELOPMENT**; to protect the human food chain and the livestock ~~and~~
 4 ~~aquaculture industries~~ **INDUSTRY** of ~~the~~ **THIS** state through
 5 prevention, control, and eradication of infectious, contagious, or
 6 toxicological diseases of livestock and other animals; to prevent
 7 the importation of certain nonindigenous animals under certain
 8 circumstances; to safeguard the human population from certain
 9 diseases that are communicable between animals and humans; to
 10 prevent or control the contamination of livestock with certain
 11 toxic substances through certain livestock or livestock products;
 12 to provide for indemnification for livestock under certain
 13 circumstances; to provide for certain powers and duties for certain
 14 state agencies and departments; to provide for the promulgation of
 15 rules; to provide for certain hearings; to provide for remedies and
 16 penalties; and to repeal acts and parts of acts.

17 Sec. 1. (1) This act shall be known and may be cited as the
 18 "animal industry act".

19 (2) This act is intended to protect the health ~~—AND~~ safety ~~—~~
 20 ~~and welfare~~ of humans and **THE HEALTH, SAFETY, AND WELFARE OF**
 21 animals ~~—AND~~ to be consistent with applicable federal and state
 22 laws ~~—and~~ shall be so construed.

23 Sec. 3. **AS USED IN THIS ACT:**

24 **(A)** ~~(1)~~—"Accredited veterinarian" means a veterinarian
 25 approved by the administrator of the United States ~~department~~
 26 **DEPARTMENT** of agriculture, ~~animal~~ **AGRICULTURE, ANIMAL** and ~~plant~~
 27 ~~health inspection service~~ **PLANT HEALTH INSPECTION SERVICE** in

1 accordance with ~~provisions of 9 C.F.R.~~ **CFR** part 161, and considered
2 preapproved to perform certain functions of federal and cooperative
3 state/federal programs.

4 (B) ~~(2)~~ "Animal" means mollusks, crustaceans, and vertebrates
5 other than human beings including, but not limited to, livestock,
6 exotic animals, aquaculture **SPECIES**, and domestic animals.

7 (C) ~~(3)~~ "Animal movement certificate" means animal movement
8 authorization established in a manner approved and issued by the
9 director that contains, at a minimum, the following information
10 regarding animals or an animal:

11 (i) ~~(a)~~ The point of origin and point of destination.

12 (ii) ~~(b)~~ Official identification.

13 (iii) ~~(c)~~ Anticipated movement date.

14 (iv) ~~(d)~~ Any required official test results. ~~for bovine~~
15 ~~tuberculosis.~~

16 (D) "ANIMAL WELFARE" MEANS THE WELL-BEING OF ANIMALS BASED
17 UPON ANIMAL HUSBANDRY, ANIMAL SCIENCE, AND VETERINARY SCIENCE
18 PRACTICES AND STANDARDS.

19 (E) "APPROVED LABORATORY" MEANS A STATE, FEDERAL, OR PRIVATE
20 VETERINARY DIAGNOSTIC LABORATORY APPROVED BY THE UNITED STATES
21 DEPARTMENT OF AGRICULTURE ANIMAL AND PLANT HEALTH INSPECTION
22 SERVICE, VETERINARY SERVICES, TO CONDUCT APPROVED OFFICIAL
23 LABORATORY TESTS FOR A SPECIFIC REPORTABLE ANIMAL DISEASE.

24 (F) "APPROVED VACCINE" MEANS A VETERINARY BIOLOGICAL AS
25 DESCRIBED IN 9 CFR SUBCHAPTER E THAT IS ADMINISTERED TO LIVESTOCK
26 OR OTHER ANIMALS TO INDUCE IMMUNITY IN THE RECIPIENT AND APPROVED
27 BY THE STATE VETERINARIAN.

PROPAGATION AND REARING of aquaculture species on the approved list
of aquaculture species under the Michigan aquaculture development

~~—— (6) "Approved vaccine" means a veterinary biological~~
~~administered to livestock or other animals to induce immunity in~~
~~the recipient and approved by the state veterinarian.~~

(I) **"AQUACULTURE SPECIES" MEANS THAT TERM AS DEFINED IN THE**
MICHIGAN AQUACULTURE DEVELOPMENT ACT, 1996 PA 199, MCL 286.871 TO
286.884.

(J) **"AUTOGENOUS VETERINARY BIOLOGICAL" MEANS ALL BACTERIA,**
VIRUSES, SERUMS, TOXINS, OR ANALOGOUS PRODUCTS FROM A SPECIFIC HERD
THAT ARE CUSTOM-MADE WITH HERD-SPECIFIC ANTIGENS.

(K) ~~(7)~~—"Carcasses" means the dead bodies of animals, poultry,
or aquaculture. Carcasses do not include rendered products.

(L) ~~(8)~~—"Cattle" means all bovine (genus bos) animals,
bovinelike animals (genus bison) also commonly referred to as

1 American buffalo or bison, and any cross of these species unless
2 otherwise specifically provided.

3 ~~—— (9) "Cattle importation lot" means a premises registered with~~
4 ~~the department and used only to feed cattle in preparation for~~
5 ~~slaughter.~~

6 (M) ~~(10)~~ "Commingling" means concurrently or subsequently
7 sharing or subsequent use by livestock or other domestic animals of
8 the same pen or same section in a facility or same section in a
9 transportation unit where there is physical contact or contact with
10 bodily excrements, aerosols, or fluids from other livestock or
11 domestic animals.

12 (N) ~~(11)~~ "Consignee" means ~~the~~ **A** person receiving ~~the~~ animals
13 at the point of destination named on ~~the~~ **AN** official interstate or
14 intrastate health certificate, official interstate certificate of
15 veterinary inspection or animal movement certificate, entry
16 authorization form, fish disease inspection report, owner-shipper
17 statement, or sales invoice.

18 (O) **"CONSIGNOR" MEANS A PERSON SENDING ANIMALS AT THE POINT OF**
19 **ORIGIN NAMED ON AN OFFICIAL INTERSTATE OR INTRASTATE HEALTH**
20 **CERTIFICATE, OFFICIAL INTERSTATE CERTIFICATE OF VETERINARY**
21 **INSPECTION OR ANIMAL MOVEMENT CERTIFICATE, ENTRY AUTHORIZATION**
22 **FORM, FISH DISEASE INSPECTION REPORT, OWNER-SHIPPER STATEMENT, OR**
23 **SALES INVOICE.**

24 (P) ~~(12)~~ "Contagious disease" means an illness due to a
25 specific infectious agent or suspected infectious agent or its
26 toxic products ~~which~~ **THAT** arises through transmission of that agent
27 or its products from an infected animal, or inanimate reservoir to

1 a susceptible host, either directly or indirectly through an
 2 intermediate plant or animal host, vector, or the inanimate
 3 environment, or via an airborne mechanism.

4 (Q) ~~(13)~~ "Dealer" means ~~any~~ **A** person required to be licensed
 5 under 1937 PA 284, MCL 287.121 to 287.131, and engaged in the
 6 business of buying, receiving, selling, exchanging, transporting,
 7 negotiating, or soliciting the sale, resale, exchange,
 8 transportation, or transfer of livestock.

9 (R) ~~(14)~~ "Department" means the ~~Michigan~~ department of
 10 agriculture **AND RURAL DEVELOPMENT**.

11 (S) ~~(15)~~ "Direct movement" means transfer of animals to a
 12 destination without unloading the animals en route. ~~and without~~
 13 ~~exposure to any other animals or bodily excrements, aerosols, or~~
 14 ~~fluids from other animals.~~

15 (T) ~~(16)~~ "Director" means the director of the ~~Michigan~~
 16 ~~department of agriculture~~ or his or her authorized representative.

17 (U) ~~(17)~~ "Disease" means any animal health condition with
 18 potential for economic impact, public or animal health concerns, or
 19 food safety concerns.

20 (V) **"DISEASE FREE ZONE" MEANS AN AREA IN THIS STATE WITH A**
 21 **DEFINED DIMENSION DETERMINED BY THE DIRECTOR TO BE FREE OF A**
 22 **SPECIFIC REPORTABLE ANIMAL DISEASE.**

 24 administering or dispensing a veterinary biological.

25 (X) ~~(19)~~ "Domestic animal" means ~~those~~ **A** species of animals

3 viral hemorrhagic septicemia, infectious hematopoietic necrosis,
4 eceratomyxosis, and proliferative kidney disease.~~

(Z) ~~(22)~~—"Exhibition or exposition" means a congregation,
9 gathering, or collection of ~~livestock~~ **ANIMALS** that are presented or
10 exposed to public view for show, display, swap, exchange,
11 entertainment, educational event, instruction, advertising, or
12 competition. Exhibition or exposition does not include livestock
13 for sale at public stockyards, auctions, saleyards, ~~and~~ **OR**
14 livestock yards licensed under ~~the provisions of~~ 1937 PA 284, MCL
15 287.121 to 287.131.

(AA) ~~(23)~~—"Exhibition facility" means any facility used or
17 intended to be used for public view, show, display, swap, exchange,
18 entertainment, advertisement, educational event, or competition
19 involving livestock. Exhibition facility does not include a public
20 stockyard, an auction saleyard, ~~and~~ **OR** a livestock yard where
21 livestock are accepted on consignment and the auction method is
22 used in the marketing of the livestock.

(BB) ~~(24)~~—"Exhibitor" means ~~any~~ **A** person who presents
24 livestock for public display, exhibition, or competition or enters
25 livestock in a fair, show, exhibition, or exposition.

(CC) ~~(25)~~—"Exotic animal" means ~~those animals~~ **A SPECIES OF**

1 ~~ANIMAL~~ that are ~~IS~~ not native to ~~North America~~. **THE UNITED STATES.**

2 (DD) ~~(26)~~ "Fair" means a competition and educational
3 exhibition of agricultural commodities and manufactured products
4 for which premiums may be paid. ~~and which is conducted by an~~
5 ~~association or governmental entity.~~

6 (EE) ~~(27)~~ "Feral swine" means swine ~~which~~ **THAT** have lived
7 their life or any part of their life as free roaming. ~~or not under~~
8 ~~the husbandry of humans.~~

9 (FF) "FISH DISEASE INSPECTION REPORT" MEANS A DOCUMENT
10 PREPARED BY A FISH HEALTH LABORATORY APPROVED BY THE DIRECTOR, A
11 VETERINARIAN, OR A FISH HEALTH OFFICIAL GIVING EVIDENCE OF
12 INSPECTIONS AND DIAGNOSTIC WORK PERFORMED.

13 (GG) "FISH HEALTH OFFICIAL" MEANS A VETERINARIAN OR A FISH
14 HEALTH SPECIALIST APPROVED BY THE DIRECTOR WHO IS RESPONSIBLE FOR
15 CONDUCTING AQUACULTURE FACILITY INSPECTIONS AND ISSUING FISH
16 DISEASE INSPECTION REPORTS.

17 (HH) "FLOCK" MEANS ALL OF THE POULTRY ON 1 PREMISES OR, IN THE
18 DISCRETION OF THE DEPARTMENT, A GROUP OF POULTRY THAT IS SEGREGATED
19 FROM ALL OTHER POULTRY ON THE SAME PREMISES.

20 (II) "GARBAGE" MEANS ANY ANIMAL ORIGIN PRODUCTS, INCLUDING
21 THOSE OF POULTRY AND FISH ORIGIN, OR OTHER ANIMAL MATERIAL
22 RESULTING FROM THE HANDLING, PROCESSING, PREPARATION, COOKING, OR
23 CONSUMPTION OF FOODS. GARBAGE INCLUDES, BUT IS NOT LIMITED TO, ANY
24 REFUSE OF ANY TYPE THAT HAS BEEN ASSOCIATED WITH ANY SUCH MATERIAL
25 AT ANY TIME DURING THE HANDLING, PREPARATION, COOKING, OR
26 CONSUMPTION OF FOOD. GARBAGE DOES NOT INCLUDE RENDERED PRODUCTS OR
27 MANURE.

(JJ) "GENETICALLY ENGINEERED" REFERS TO AN ORGANISM WHOSE GENOME, CHROMOSOMAL OR EXTRACHROMOSOMAL, IS MODIFIED PERMANENTLY AND HERITABLY USING RECOMBINANT NUCLEIC ACID TECHNIQUES, OR THE PROGENY THEREOF.

(KK) "GRADE" MEANS AN ANIMAL FOR WHICH NO PROOF OF REGISTRATION WITH AN APPROPRIATE BREED REGISTRY IS PROVIDED.

(//) "HERD OR FLOCK OF ORIGIN" MEANS ANY HERD OR FLOCK IN WHICH ANIMALS ARE BORN AND REMAIN UNTIL MOVEMENT OR ANY HERD OR FLOCK IN WHICH ANIMALS REMAIN FOR AT LEAST 30 DAYS IMMEDIATELY FOLLOWING DIRECT MOVEMENT INTO THE HERD OR FLOCK FROM ANOTHER HERD OR FLOCK. HERD OR FLOCK OF ORIGIN INCLUDES THE PLACE OF ORIGIN, PREMISES OF ORIGIN, AND FARM OF ORIGIN.

(MM) "HIGH-RISK AREA" MEANS AN AREA IN THIS STATE THAT HAS A DEFINED DIMENSION DETERMINED BY THE DIRECTOR IN WHICH A SPECIFIC REPORTABLE ANIMAL DISEASE HAS BEEN DIAGNOSED IN DOMESTICATED ANIMALS.

(NN) "INFECTIOUS DISEASE" MEANS A DISORDER CAUSED BY AN ORGANISM, INCLUDING, BUT NOT LIMITED TO, A BACTERIA, VIRUS, FUNGUS, PARASITE, OR ANALOGOUS ORGANISM, AND THAT CAN BE DIRECTLY OR INDIRECTLY PASSED FROM ANIMAL TO ANIMAL.

(OO) "INFECTED ZONE" MEANS AN AREA IN THIS STATE THAT HAS A DEFINED DIMENSION DETERMINED BY THE DIRECTOR IN WHICH A SPECIFIC REPORTABLE ANIMAL DISEASE IS PRESENT IN ANIMALS AND SEPARATED FROM A DISEASE FREE ZONE BY A SURVEILLANCE ZONE.

(PP) "INTRASTATE MOVEMENT" MEANS MOVEMENT FROM 1 PREMISES TO ANOTHER WITHIN THIS STATE. INTRASTATE MOVEMENT DOES NOT INCLUDE THE MOVEMENT OF ANIMALS FROM 1 PREMISES WITHIN THIS STATE DIRECTLY TO

1 ANOTHER PREMISES WITHIN THIS STATE IF BOTH PREMISES ARE PART OF THE
2 SAME OPERATION UNDER COMMON OWNERSHIP AND BOTH PREMISES ARE
3 DIRECTLY INTERRELATED. UNLESS INTRASTATE MOVEMENT CAUSES LIVESTOCK
4 TO CROSS FROM 1 ZONE INTO ANOTHER ZONE, LIVESTOCK SHALL MEET THE
5 TESTING REQUIREMENTS FOR ITS ZONE OF ORIGIN.

6 (QQ) "ISOLATED" MEANS THE PHYSICAL SEPARATION OF ANIMALS BY A
7 PHYSICAL BARRIER IN SUCH A MANNER THAT OTHER ANIMALS DO NOT HAVE
8 ACCESS TO THE ISOLATED ANIMALS' BODIES, EXCREMENT, AEROSOLS, OR
9 DISCHARGES, AS APPROVED BY THE DIRECTOR.

10 (RR) "LAW ENFORCEMENT AGENCY" MEANS THE DEPARTMENT OF STATE
11 POLICE, THE DEPARTMENT OF NATURAL RESOURCES, A LAW ENFORCEMENT
12 AGENCY OF A COUNTY, TOWNSHIP, CITY, OR VILLAGE, OR A TRIBAL LAW
13 ENFORCEMENT AGENCY THAT IS RESPONSIBLE FOR THE PREVENTION AND
14 DETECTION OF CRIME AND ENFORCEMENT OF THE CRIMINAL LAWS OF THIS
15 STATE.

16 (SS) "LIVESTOCK" MEANS THOSE SPECIES OF ANIMALS USED FOR HUMAN
17 FOOD AND FOR FIBER OR THOSE SPECIES OF ANIMALS USED FOR SERVICE TO
18 HUMANS. LIVESTOCK INCLUDES, BUT IS NOT LIMITED TO, CATTLE, SHEEP,
19 NEW WORLD CAMELIDS, OLD WORLD CAMELIDS, GOATS, BISON, PRIVATELY
20 OWNED CERVIDS, RATITES, SWINE, EQUINE, POULTRY, AQUACULTURE
21 SPECIES, AND RABBITS. LIVESTOCK DOES NOT INCLUDE DOGS OR CATS.

22 (TT) "LIVESTOCK AUCTION MARKET" MEANS A LIVESTOCK MARKET WHERE
23 LIVESTOCK IS ACCEPTED ON CONSIGNMENT AND THE AUCTION METHOD IS USED
24 IN THE MARKETING OF CONSIGNED LIVESTOCK AS DEFINED IN 1937 PA 284,
25 MCL 287.121 TO 287.131.

26 (UU) "NATIONAL POULTRY IMPROVEMENT PLAN" MEANS A PLAN FOR THE
27 CONTROL OR ERADICATION OF CERTAIN POULTRY DISEASES THAT IS

1 PUBLISHED IN 9 CFR PARTS 145 AND 147.

2 (VV) "NATIVE" MEANS AN ANIMAL BORN AND RAISED IN THIS STATE,
3 OR LEGALLY IMPORTED INTO THIS STATE AND HAVING COMPLIED WITH ENTRY
4 REQUIREMENTS PRESCRIBED BY THE DIRECTOR, AND HAVING BEEN MAINTAINED
5 IN THIS STATE FOR AT LEAST 30 DAYS.

6 (WW) "NEW WORLD CAMELIDS" MEANS ANIMALS BELONGING TO THE GENUS
7 LLAMA AND VICUNA OF THE FAMILY CAMELIDAE OF THE ORDER ARTIODACTYLA
8 INCLUDING, BUT NOT LIMITED TO, THE LLAMA, ALPACA, VICUNA, AND
9 GUANACO.

10 (XX) "OFFAL" MEANS THE WASTE PARTS RESULTING FROM THE
11 PROCESSING OF ANIMALS, POULTRY, FISH, AND AQUACULTURE SPECIES.
12 OFFAL DOES NOT INCLUDE RENDERED PRODUCTS.

13 (YY) "OFFICIAL IDENTIFICATION" MEANS AN IDENTIFICATION EAR
14 TAG, TATTOO, ELECTRONIC IDENTIFICATION, OR OTHER IDENTIFICATION
15 APPROVED BY THE UNITED STATES DEPARTMENT OF AGRICULTURE OR THE
16 DEPARTMENT.

17 (ZZ) "OFFICIAL INTERSTATE HEALTH CERTIFICATE" OR "OFFICIAL
18 INTERSTATE CERTIFICATE OF VETERINARY INSPECTION" MEANS A FORM IN
19 PAPER OR ELECTRONIC FORMAT WITH A UNIQUE IDENTIFIER THAT IS ADOPTED
20 BY ANY STATE THAT DOCUMENTS THE INFORMATION REQUIRED UNDER SECTION
21 20 AND THAT IS ISSUED FOR ANIMALS BEING IMPORTED TO OR EXPORTED
22 FROM THIS STATE WITHIN 30 DAYS BEFORE THE IMPORTATION OR
23 EXPORTATION OF THE ANIMALS IT DESCRIBES. A PHOTOCOPY OF AN OFFICIAL
24 INTERSTATE HEALTH CERTIFICATE OR AN OFFICIAL INTERSTATE CERTIFICATE
25 OF VETERINARY INSPECTION IS CONSIDERED AN OFFICIAL COPY IF
26 CERTIFIED AS A TRUE COPY BY THE ISSUING VETERINARIAN OR A LIVESTOCK
27 HEALTH OFFICIAL OF THE STATE OF ORIGIN.

1 (AAA) "OFFICIAL TEST" MEANS A SAMPLE OF SPECIFIC MATERIAL
2 COLLECTED FROM AN ANIMAL BY AN ACCREDITED VETERINARIAN, STATE OR
3 FEDERAL VETERINARY MEDICAL OFFICER, OR OTHER PERSON AUTHORIZED BY
4 THE DIRECTOR AND ANALYZED BY A LABORATORY CERTIFIED BY THE UNITED
5 STATES DEPARTMENT OF AGRICULTURE OR THE DEPARTMENT TO CONDUCT THE
6 TEST, OR A DIAGNOSTIC INJECTION ADMINISTERED AND ANALYZED BY AN
7 ACCREDITED VETERINARIAN OR A STATE OR FEDERAL VETERINARY MEDICAL
8 OFFICER. AN OFFICIAL TEST IS CONDUCTED ONLY BY AN ACCREDITED
9 VETERINARIAN OR A STATE OR FEDERAL VETERINARY MEDICAL OFFICER
10 EXCEPT UNDER SPECIAL PERMISSION BY THE DIRECTOR.

11 (BBB) "OFFICIAL VACCINATION" MEANS A VACCINATION THAT THE
12 DIRECTOR HAS DESIGNATED AS REPORTABLE, ADMINISTERED BY AN
13 ACCREDITED VETERINARIAN OR A STATE OR FEDERAL VETERINARY MEDICAL
14 OFFICER, AND DOCUMENTED ON A FORM SUPPLIED BY THE DEPARTMENT.

15 (CCC) "OLD WORLD CAMELID" MEANS A BACTRIAN OR AN ARABIAN OR
16 DROMEDARY CAMEL.

17 (DDD) "ORIGINATE" MEANS THE DIRECT MOVEMENT OF ANIMALS FROM A
18 HERD OR FLOCK OF ORIGIN.

19 (EEE) "PERSON" MEANS AN INDIVIDUAL, PARTNERSHIP, CORPORATION,
20 COOPERATIVE, ASSOCIATION, JOINT VENTURE, OR OTHER LEGAL ENTITY
21 INCLUDING, BUT NOT LIMITED TO, CONTRACTUAL RELATIONSHIPS.

22 (FFF) "POTENTIAL HIGH-RISK AREA" MEANS AN AREA IN THIS STATE

25 (MMM) "QUARANTINE" MEANS ENFORCED ISOLATION OF ANY ANIMAL OR

27 OF ANIMALS, EQUIPMENT, OR VEHICLES TO OR FROM ANY STRUCTURE,

3 (NNN) "RATITE" MEANS FLIGHTLESS BIRDS HAVING A FLAT BREASTBONE

5 BIRDS. RATITES INCLUDE, BUT ARE NOT LIMITED TO, CASSOWARIES, KIWIS,

7 (OOO) "REASONABLE ASSISTANCE" MEANS SAFELY CONTROLLING AN
8 ANIMAL BY CORRALLING, STABLING, KENNELING, HOLDING, TYING,
9 CHEMICALLY RESTRAINING, OR CONFINING BY HALTER OR LEASH OR CROWDING
10 THE ANIMAL IN A SAFE AND SENSIBLE MANNER SO AN EXAMINATION OR
11 TESTING PROCEDURE CONSIDERED NECESSARY BY THE DIRECTOR CAN BE
12 PERFORMED.

13 (PPP) "RECOMBINANT NUCLEIC ACID TECHNIQUES" MEANS LABORATORY

16 (QQQ) "RENDERED PRODUCTS" MEANS WASTE MATERIAL DERIVED IN

18 AND OTHER REFUSE OF ANY CHARACTER THAT HAS BEEN ASSOCIATED WITH ANY

4 (SSS) "SLAUGHTER PREMISES" MEANS ALL FACILITIES, BUILDINGS,

6 OCCURS UNDER FEDERAL OR STATE INSPECTION, OR OTHERWISE AUTHORIZED
7 BY THE DIRECTOR.

8 (TTT) "SOW" MEANS ANY FEMALE SWINE THAT HAS FARROWED OR GIVEN

10 (UUU) "STATE VETERINARIAN" MEANS THE CHIEF ANIMAL HEALTH
11 OFFICIAL OF THIS STATE AS APPOINTED BY THE DIRECTOR UNDER SECTION
12 7, OR HIS OR HER AUTHORIZED REPRESENTATIVE.

13 (VVV) "SURVEILLANCE ZONE" MEANS AN AREA IN THIS STATE THAT HAS

15 SPECIFIC REPORTABLE ANIMAL DISEASE AND IS LOCATED ADJACENT AND
16 CONTIGUOUS TO AN INFECTED ZONE.

17 (WWW) "SWINE" MEANS ANY OF THE UNGULATE MAMMALS OF THE FAMILY
18 SUIDAE.

19 (XXX) "TOXIC SUBSTANCE" MEANS A NATURAL OR SYNTHETIC CHEMICAL
20 OR RADIOLOGIC MATERIAL IN CONCENTRATIONS THAT ALONE OR IN
21 COMBINATION WITH OTHER NATURAL OR SYNTHETIC CHEMICALS PRESENTS A
22 THREAT TO THE HEALTH, SAFETY, OR WELFARE TO HUMAN OR ANIMAL LIFE OR
23 THAT HAS THE CAPACITY TO PRODUCE INJURY OR ILLNESS THROUGH

6 ORIGIN, OR PRODUCTS PREPARED FROM ANY TYPE OF GENETIC ENGINEERING,
7 SUCH AS DIAGNOSTICS, ANTITOXINS, VACCINES, LIVE MICROORGANISMS,
8 KILLED MICROORGANISMS, OR THE ANTIGENIC OR IMMUNIZING COMPONENTS OF

1 THE DIRECTOR, AND SIGNED PERMISSION ALLOWING THE BREED ASSOCIATION
2 TO DISCLOSE INFORMATION REQUESTED BY THE DIRECTOR.

3 (8) THE DIRECTOR MAY REQUIRE ADDITIONAL BIOSECURITY AND
4 WILDLIFE RISK MITIGATION MEASURES, AS DETERMINED BY THE DIRECTOR IN
5 AN ORDER UNDER THIS ACT, FOR FUTURE INDEMNIFICATION ELIGIBILITY
6 UNDER THIS ACT.

7 (9) THE DEPARTMENT MAY COOPERATE AND COORDINATE WITH THE
8 UNITED STATES SECRETARY OF AGRICULTURE OR THE SECRETARY'S
9 AUTHORIZED REPRESENTATIVE OR OTHER GOVERNMENTAL DEPARTMENTS OR

4 FLOCKS, OR AQUACULTURE LOTS AS CERTIFIED, ACCREDITED, VALIDATED,
5 QUALIFIED, MONITORED, CLEAN, OR FREE OF A SPECIFIC DISEASE WHEN THE
6 HERD, FLOCK, OR AQUACULTURE LOT HAS MET THE DIRECTOR'S REQUIREMENTS
7 FOR THAT STATUS.

8 (4) INDIVIDUAL LIVESTOCK THAT IS UNDERGOING AN OFFICIAL TEST
9 SHALL NOT BE REMOVED FROM THE PREMISES UNTIL THE TEST RESULTS ARE
10 AVAILABLE, EXCEPT AS PERMITTED BY THE DIRECTOR.

11 SEC. 17C. (1) AS USED IN THIS SECTION:

16 BY ASSOCIATING WITH EQUIDAE KNOWN OR LATER FOUND TO BE AFFECTED
17 WITH EQUINE INFECTIOUS ANEMIA.

18 (G) "OFFICIAL EQUINE INFECTIOUS ANEMIA TEST" MEANS ANY TEST
19 FOR THE LABORATORY DIAGNOSIS OF EQUINE INFECTIOUS ANEMIA THAT
20 UTILIZES A DIAGNOSTIC PRODUCT THAT IS BOTH OF THE FOLLOWING:

21 (i) PRODUCED UNDER LICENSE FROM THE SECRETARY OF AGRICULTURE
22 OF THE UNITED STATES DEPARTMENT OF AGRICULTURE OR THE SECRETARY'S
23 AUTHORIZED REPRESENTATIVE, UNDER THE VIRUS-SERUM-TOXIN ACT, 21 USC

26 (H) "PERMIT" MEANS AN OFFICIAL DOCUMENT, VS FORM 1-27 OR
27 COMPARABLE STATE FORM, THAT IS ISSUED BY A STATE OR FEDERAL

1 REPRESENTATIVE OR BY AN ACCREDITED VETERINARIAN, REQUIRED TO
2 ACCOMPANY ALL EQUINE INFECTIOUS ANEMIA TEST-POSITIVE EQUIDAE AND
3 THOSE EXPOSED EQUIDAE THAT ARE BEING MOVED UNDER OFFICIAL SEAL

10 WITHIN THE PREVIOUS 12 MONTHS OF ENTRY DOCUMENTED ON AN EQUINE
11 INFECTIOUS ANEMIA LABORATORY TEST FORM:

12 (A) FOR EXHIBITIONS, EXPOSITIONS, OR FAIRS.

13 (B) AT A TIME OF CHANGE OF OWNERSHIP AND LOCATION WITHIN THIS
14 STATE.

15 (C) TO ENTER, REMAIN AT, OR BE PRESENT ON THE PREMISES OF
16 HORSE AUCTIONS OR SALES MARKETS WHETHER OR NOT LICENSED UNDER 1974
17 PA 93, MCL 287.111 TO 287.119, AND 1937 PA 284, MCL 287.121 TO
18 287.131. IF AN EQUINE INFECTIOUS ANEMIA TEST IS NOT POSSIBLE BEFORE
19 EACH SALE, THEN THE EQUIDAE MUST BE HELD ON THE SALE PREMISES UNTIL
20 THE TEST RESULTS ARE KNOWN.

21 (3) SUBSECTION (2) DOES NOT APPLY TO AN EQUIDAE THAT IS BOTH 6
22 MONTHS OR YOUNGER AND NURSING.

23 (4) EQUIDAE THAT CHANGE OWNERSHIP AND LOCATION IN THIS STATE
24 OR THAT ARE MOVED INTO THIS STATE FROM ANOTHER STATE MUST HAVE AN
25 OFFICIAL EQUINE INFECTIOUS ANEMIA TEST WITH A NEGATIVE RESULT
26 WITHIN THE PREVIOUS 12 MONTHS. EQUIDAE MOVED INTO THIS STATE FROM
27 ANOTHER STATE SHALL MEET THE REQUIREMENTS OF SECTION 19.

1 (5) AN EQUINE INFECTIOUS ANEMIA LABORATORY TEST FORM SHALL
2 CONTAIN, AT A MINIMUM, THE COLOR, BREED, SEX, AGE, MARKINGS, NAME
3 OF OWNER, AND LOCATION OR ADDRESS OF THE EQUINE. A PHOTOGRAPHIC OR

1 AN EQUINE INFECTIOUS ANEMIA TEST-POSITIVE EQUINE SHALL PROVIDE TO
2 THE DEPARTMENT THE RECORDS DESCRIBED IN SUBSECTION (10) .

3 (12) THE DIRECTOR MAY CONDUCT EPIDEMIOLOGICAL INVESTIGATIONS
4 ON ALL EQUIDAE THAT HAVE POSSIBLE EXPOSURE TO OFFICIAL EQUINE
5 INFECTIOUS ANEMIA TEST-POSITIVE EQUIDAE TO DETERMINE THE NEED FOR
6 ADDITIONAL QUARANTINING AND OFFICIAL EQUINE INFECTIOUS ANEMIA
7 TESTING.

8 (13) A PERSON SHALL NOT DESTROY OR REMOVE OFFICIAL EQUINE
9 INFECTIOUS ANEMIA TEST-POSITIVE EQUIDAE FROM THE ORIGINAL TEST
10 LOCATION OR PREMISES WITHOUT PRIOR PERMISSION FROM THE DIRECTOR.

11 (14) THE OWNER SHALL NOT DESTROY AN OFFICIAL EQUINE INFECTIOUS
12 ANEMIA TEST-POSITIVE EQUINE WITHOUT PERMISSION FROM THE DIRECTOR.
13 THE DIRECTOR SHALL ISSUE A QUARANTINE RELEASE AND BE PRESENT WHEN
14 THE EQUINE IS DESTROYED OR AN ACCREDITED VETERINARIAN MAY DOCUMENT
15 AND CERTIFY THAT THE OFFICIAL EQUINE INFECTIOUS ANEMIA TEST-
16 POSITIVE EQUINE HAS BEEN DESTROYED.

17 (15) UNLESS IMMEDIATELY DESTROYED, OFFICIAL EQUINE INFECTIOUS
18 ANEMIA TEST-POSITIVE EQUIDAE SHALL BE IDENTIFIED BY THE DIRECTOR
19 WITH THE FREEZE BRAND 34A, WHICH SHALL BE IN CHARACTERS NOT LESS
20 THAN 2 INCHES IN HEIGHT AND PLACED ON THE LEFT CERVICAL AREA OF THE
21 NECK OR SHALL BE IDENTIFIED IN ANOTHER MANNER APPROVED BY THE
22 DIRECTOR.

23 (16) RESTRICTED EQUIDAE MAY MOVE INTERSTATE ONLY IF

6 (A) A FEDERALLY INSPECTED SLAUGHTER FACILITY.

7 (B) A FEDERALLY APPROVED DIAGNOSTIC OR RESEARCH FACILITY.

8 (C) A HERD OR FARM OF ORIGIN.

9 (18) THE INDIVIDUAL ISSUING THE PERMIT SHALL CONSULT WITH THE
10 STATE ANIMAL HEALTH OFFICIAL IN THE STATE OF DESTINATION FOR
11 APPROVAL AND SHALL DETERMINE THAT THE EQUINE INFECTIOUS ANEMIA
12 TEST-POSITIVE EQUINE TO BE MOVED INTERSTATE WILL BE MAINTAINED IN
13 ISOLATION SUFFICIENT TO PREVENT THE TRANSMISSION OF EQUINE
