

**HOUSE SUBSTITUTE FOR
SENATE BILL NO. 932**

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 74101 (MCL 324.74101), as amended by 2010 PA
33.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 74101. As used in this part:

2 (a) "Commercial motor vehicle" means a commercial vehicle as
3 defined in section 7 of the Michigan vehicle code, 1949 PA 300, MCL
4 257.7.

5 **(B) "ENDOWMENT FUND" MEANS THE MICHIGAN STATE PARKS ENDOWMENT**
6 **FUND ESTABLISHED IN SECTION 35A OF ARTICLE IX OF THE STATE**
7 **CONSTITUTION OF 1963 AND PROVIDED FOR IN SECTION 74119.**

8 **(C)** ~~(b)~~—"Improvement program" means the construction,
9 reconstruction, development, improvement, bettering, operating,

1 maintaining, and extending a facility at a state park, including a
2 site improvement, impoundment, road and parking lot, toilet
3 building, concession building, shelter building, bathhouse,
4 utility, outdoor center, visitor service facility, ski area, ski
5 tow, ski shelter, and administration unit.

6 (D) ~~(e)~~—"Motor vehicle" means a vehicle that is self-
7 propelled.

8 (E) ~~(d)~~—"Nonresident motor vehicle" means a motor vehicle
9 other than a commercial motor vehicle that is not registered as a
10 motor vehicle in this state.

11 (F) ~~(e)~~—"Recreation passport fee" means that term as defined
12 in section 2001.

13 (G) ~~(f)~~—"Resident motor vehicle" means a motor vehicle other
14 than a commercial motor vehicle that is registered as a motor
15 vehicle in this state.

16 (H) ~~(g)~~—"State park" means a state park or state recreation
17 area designated by the director.

18 (I) ~~(h)~~—"State park improvement account" means the state park
19 improvement account of the Michigan conservation and recreation
20 legacy fund provided for in section 2030.

21 (J) ~~(i)~~—"State park revenues" means all revenues collected for
22 state parks, including but not limited to, revenue from recreation
23 passport fees, motor vehicle permits, concession fees, nonmotorized
24 trail permits, fees, leases, camping fees, sale of farm animals
25 from Maybury state park, donations, and gifts.

26 Enacting section 1. This amendatory act does not take effect
27 unless all of the following bills of the 99th Legislature are

1 enacted into law:

2 (a) Senate Bill No. 763.

3 (b) Senate Bill No. 931.

4 Enacting section 2. This amendatory act does not take effect
5 unless Senate Joint Resolution O of the 99th Legislature becomes a
6 part of the state constitution of 1963 as provided in section 1 of
7 article XII of the state constitution of 1963.
