## SUBSTITUTE FOR SENATE BILL NO. 1233

A bill to amend 2016 PA 436, entitled "Unmanned aircraft systems act,"

(MCL 259.301 to 259.331) by adding section 7.

- 1 SEC. 7. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (6), A
- 2 DEPARTMENT, AGENCY, BOARD, OR COMMISSION OF THIS STATE OR A PERSON
- 3 UNDER A CONTRACT WITH OR ACTING AT THE DIRECTION OR ON BEHALF OF A
- 4 DEPARTMENT, AGENCY, BOARD, OR COMMISSION OF THIS STATE SHALL NOT
- 5 USE AN UNMANNED AIRCRAFT SYSTEM TO SURVEIL, INSPECT, OR GATHER
- 6 EVIDENCE OR COLLECT INFORMATION ABOUT A FACILITY THAT IS SUBJECT TO
- 7 A PERMIT, LICENSE, OR ORDER ISSUED BY OR A DECREE OR OTHER
- 8 REQUIREMENT GOVERNED BY THAT DEPARTMENT, AGENCY, BOARD, OR
- 9 COMMISSION UNLESS ANY OF THE FOLLOWING APPLY:

- 13 (D) THE DEPARTMENT, AGENCY, BOARD, COMMISSION, OR PERSON IS
- 14 INSPECTING A ROADWAY, HIGHWAY, AIRPORT, AIRPORT APPROACH CORRIDOR,
- 15 PORT, OR SIMILAR INFRASTRUCTURE.
- 16 (2) AN UNMANNED AIRCRAFT SYSTEM THAT IS USED AS DESCRIBED IN
- 17 SUBSECTION (1) MUST BE CLEARLY MARKED AS A STATE-OWNED OR OPERATED
- 18 AIRCRAFT UNLESS IT IS AN UNMANNED AIRCRAFT SYSTEM OPERATED IN
- 19 ACCORDANCE WITH SUBSECTION (3).
- 20 (3) FOR ANY USE THAT IS GOVERNED BY SUBSECTION (1) (A), [BOTH OF THE FOLLOWING APPLY:
  - (A) SUBJECT TO SUBDIVISION (B), THE
- 21 CONSENT OF THE OWNER OR OPERATOR MAY BE CONDITIONED ON THE USE OF
- 22 AN UNMANNED AIRCRAFT SYSTEM THAT IS OWNED AND OPERATED BY THAT
- 23 OWNER OR OPERATOR UNDER, AND IN COMPLIANCE WITH, FEDERAL AVIATION
- 24 ADMINISTRATION REGULATIONS, AUTHORIZATIONS, OR EXEMPTIONS. THE
- 25 DEPARTMENT, AGENCY, BOARD, COMMISSION, OR PERSON UNDER CONTRACT

- 1 SUPERVISION, THE USE OF THE UNMANNED AIRCRAFT SYSTEM BY THE OWNER
- 2 OR OPERATOR TO CONDUCT THE SURVEILLANCE, INSPECTION, EVIDENCE
- 3 GATHERING, OR INFORMATION COLLECTING UNDER THIS SECTION, IF DOING
- 4 SO WILL GATHER INFORMATION OF A QUALITY AND NATURE SUFFICIENT FOR
- 5 THE INTENDED PURPOSE OF THE SURVEILLANCE, INSPECTION, EVIDENCE
- 6 GATHERING, OR INFORMATION COLLECTION.
  - [(B) IF THE OWNER OR OPERATOR PROVIDES CONSENT ON THE CONDITION DESCRIBED IN SUBDIVISION (A), OR IF THE OWNER OR OPERATOR WITHHOLDS CONSENT, THE OWNER OR OPERATOR SHALL PROVIDE TO THE DEPARTMENT, AGENCY, BOARD, OR COMMISSION A STATEMENT, IN WRITING, THAT INDICATES THE HEALTH AND SAFETY REASONS FOR PROVIDING CONSENT ON THE CONDITION DESCRIBED IN SUBDIVISION (A) OR WITHHOLDING CONSENT.]
- 7 (4) ANY SURVEILLANCE, INSPECTION, EVIDENCE GATHERING, OR
- 8 INFORMATION COLLECTING CONDUCTED UNDER SUBSECTION (1)(C) SHALL BE
- 9 UNDER THE DIRECT SUPERVISION OF THE DEPARTMENT, AGENCY, BOARD, OR
- 10 COMMISSION.
- 11 (5) ANY DATA, INCLUDING VIDEOS, PHOTOGRAPHIC IMAGES, OR
- 12 GEOSPATIAL DATA, COLLECTED BY THE OPERATION OF AN UNMANNED AIRCRAFT
- 13 SYSTEM CONCERNING A FACILITY DESCRIBED IN SUBSECTION (1) SHALL BE
- 14 FURNISHED PROMPTLY TO THE FACILITY'S OWNER OR OPERATOR UPON REQUEST
- 15 AND SHALL BE REBUTTABLY PRESUMED TO BE NOT SUBJECT TO DISCLOSURE
- 16 UNDER THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO

- 18 (6) THIS SECTION DOES NOT APPLY TO A LAW ENFORCEMENT AGENCY
- 19 OPERATING AN UNMANNED AIRCRAFT SYSTEM AS PART OF A LAW ENFORCEMENT
- 20 INVESTIGATION.
- 21 Enacting section 1. This amendatory act takes effect 90 days
- 22 after the date it is enacted into law.
