## SUBSTITUTE FOR

## SENATE BILL NO. 983

A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding section 1308a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1308A. (1) BEGINNING IN THE 2019-2020 SCHOOL YEAR, AND AT
- 2 LEAST BIENNIALLY THEREAFTER, A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 3 DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL, IN CONJUNCTION WITH AT
- 4 LEAST 1 LAW ENFORCEMENT AGENCY THAT HAS JURISDICTION OVER THE
- 5 SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 6 ACADEMY, CONDUCT A REVIEW OF THE EMERGENCY OPERATIONS PLAN
- 7 DEVELOPED OR ADOPTED UNDER SUBSECTION (2), INCLUDING A REVIEW OF
- 8 THE VULNERABILITY ASSESSMENT UNDER SUBSECTION (3), OR CONDUCT A
- 9 REVIEW OF THE STATEWIDE SCHOOL SAFETY INFORMATION POLICY DESCRIBED
- 10 UNDER SUBSECTION (4), AS APPLICABLE.

- 1 (2) SUBJECT TO SUBSECTION (3), NOT LATER THAN JANUARY 1, 2020,
- 2 A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 3 ACADEMY SHALL DEVELOP AN EMERGENCY OPERATIONS PLAN FOR EACH SCHOOL
- 4 BUILDING OPERATED BY THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 5 DISTRICT, OR PUBLIC SCHOOL ACADEMY WITH INPUT FROM THE PUBLIC. THE
- 6 BOARD OF THE SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR THE
- 7 BOARD OF DIRECTORS OF THE PUBLIC SCHOOL ACADEMY SHALL ADOPT THE
- 8 EMERGENCY OPERATIONS PLAN BY A MAJORITY VOTE OF THE MEMBERS SERVING
- 9 ON THE BOARD OR BOARD OF DIRECTORS AT A PUBLIC MEETING OF THE BOARD
- 10 OR BOARD OF DIRECTORS HELD IN COMPLIANCE WITH THE OPEN MEETINGS
- 11 ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 12 (3) THE EMERGENCY OPERATIONS PLAN DEVELOPED AND ADOPTED UNDER
- 13 SUBSECTION (2) MUST INCLUDE GUIDELINES AND PROCEDURES THAT ADDRESS
- 14 AT LEAST ALL OF THE FOLLOWING:
- 15 (A) SCHOOL VIOLENCE AND ATTACKS.
- 16 (B) THREATS OF SCHOOL VIOLENCE AND ATTACKS.
- 17 (C) BOMB THREATS.
- 18 (D) FIRE.
- 19 (E) WEATHER-RELATED EMERGENCIES.
- 20 (F) INTRUDERS.
- 21 (G) PARENT AND PUPIL REUNIFICATION.
- 22 (H) THREATS TO A SCHOOL-SPONSORED ACTIVITY OR EVENT WHETHER OR
- 23 NOT IT IS HELD ON SCHOOL PREMISES.
- 24 (I) A PLAN TO TRAIN TEACHERS ON MENTAL HEALTH AND PUPIL AND
- 25 TEACHER SAFETY.
- 26 (J) A PLAN TO IMPROVE SCHOOL BUILDING SECURITY.
- 27 (K) AN ACTIVE VIOLENCE PROTOCOL.

- 1 (1) CONTINUITY OF OPERATIONS AFTER AN INCIDENT.
- 2 (M) A VULNERABILITY ASSESSMENT.
- 3 (4) A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 4 SCHOOL ACADEMY THAT ADOPTS AND IMPLEMENTS A STATEWIDE SCHOOL SAFETY
- 5 INFORMATION POLICY UNDER SECTION 1308 THAT MEETS THE REQUIREMENTS
- 6 UNDER SUBSECTION (3) IS IN COMPLIANCE WITH SUBSECTION (2).
- 7 (5) A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 8 SCHOOL ACADEMY SHALL PROVIDE NOTICE TO THE DEPARTMENT OF A
- 9 COMPLETED EMERGENCY OPERATIONS PLAN REVIEW UNDER SUBSECTION (1) NOT
- 10 LATER THAN 30 DAYS AFTER THE COMPLETION OF THE REVIEW, IN A FORM
- 11 AND MANNER PRESCRIBED BY THE DEPARTMENT. A SCHOOL DISTRICT,
- 12 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL ALSO
- 13 PROVIDE NOTICE TO THE DEPARTMENT OF THE ADOPTION OF AN EMERGENCY
- 14 OPERATIONS PLAN UNDER SUBSECTION (2) NOT LATER THAN 30 DAYS AFTER
- 15 THE ADOPTION OF THE EMERGENCY OPERATIONS PLAN, IN A FORM AND MANNER
- 16 PRESCRIBED BY THE DEPARTMENT.
- 17 (6) AT LEAST ANNUALLY, THE DEPARTMENT SHALL PROVIDE TO THE
- 18 OFFICE OF SCHOOL SAFETY WITHIN THE DEPARTMENT OF STATE POLICE A
- 19 LIST OF EACH SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
- 20 PUBLIC SCHOOL ACADEMY THAT HAS NOT DEVELOPED AND ADOPTED AN
- 21 EMERGENCY OPERATIONS PLAN UNDER SUBSECTION (2).
- 22 (7) THE OFFICE OF SCHOOL SAFETY WITHIN THE DEPARTMENT OF STATE
- 23 POLICE SHALL COORDINATE WITH A LAW ENFORCEMENT AGENCY THAT HAS
- 24 JURISDICTION OVER A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT,
- 25 OR PUBLIC SCHOOL ACADEMY THAT HAS NOT DEVELOPED AND ADOPTED AN
- 26 EMERGENCY OPERATIONS PLAN UNDER SUBSECTION (2) TO NOTIFY THE
- 27 GOVERNING BODY OF THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL

- DISTRICT, OR PUBLIC SCHOOL ACADEMY THAT THE SCHOOL DISTRICT, 1
- 2 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY HAS NOT
- DEVELOPED AND ADOPTED AN EMERGENCY OPERATIONS PLAN. 3
- (8) AN EMERGENCY OPERATIONS PLAN DEVELOPED AND ADOPTED UNDER
- SUBSECTION (2), ANY INFORMATION PROVIDED TO THE DEPARTMENT UNDER 5
- SUBSECTION (5), AND ANY INFORMATION PROVIDED TO THE DEPARTMENT OF
- 7 STATE POLICE UNDER SUBSECTION (6) IS CONFIDENTIAL AND IS EXEMPT
- 8 FROM DISCLOSURE UNDER THE FREEDOM OF INFORMATION ACT, 1976 PA 442,
- MCL 15.231 TO 15.246.
- (9) AS USED IN THIS SECTION, "SCHOOL BUILDING" MEANS ANY OF 10
- 11 THE FOLLOWING:
- 12 (A) A BUILDING INTENDED TO BE USED TO PROVIDE INSTRUCTION FOR
- PUPILS, INCLUDING AN ADDITION TO AN EXISTING BUILDING. 13
- (B) A RECREATIONAL OR ATHLETIC STRUCTURE OR FIELD INTENDED TO 14
- BE USED BY PUPILS. 15
- 16 Enacting section 1. This amendatory act takes effect 90 days
- 17 after the date it is enacted into law.
