SUBSTITUTE FOR

SENATE BILL NO. 1254

A bill to provide for certain duties of the secretary of state relating to the independent citizens redistricting commission; to provide for certain rules and procedures governing the application and selection process for commissioners; to prescribe standards for establishing political party affiliation; to prohibit individuals affiliated with a political party from providing services to the commission; to provide civil sanctions; and to provide for the powers and duties of certain state and local governmental officers and entities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Independent citizens redistricting commission" or
- 3 "commission" means the independent citizens redistricting
- 4 commission established under section 6 of article IV of the state

- 1 constitution of 1963.
- 2 (b) "Michigan registered voter" means an individual who is
- 3 registered to vote in this state.
- 4 Sec. 3. The secretary of state shall promulgate rules and
- 5 procedures, in accordance with the administrative procedures act of
- 6 1969, 1969 PA 306, MCL 24.201 to 24.328, that provide for the form
- 7 and minimum required contents of an application for commissioner of
- 8 the independent citizens redistricting commission, including, but
- 9 not limited to, the method for attesting to political party
- 10 affiliation under oath.
- 11 Sec. 5. For purposes of establishing affiliation with a
- 12 political party in the commissioner application and selection
- 13 process, all of the following apply:
- 14 (a) An individual is affiliated with a political party if the
- 15 individual adheres to or acts to further the purposes or objectives
- 16 of that party or a federal, state, or local chapter or other
- 17 division of that party. An expression of sympathy with a political
- 18 party or its purposes or objectives alone is not sufficient to
- 19 establish affiliation with that political party.
- 20 (b) An individual is conclusively presumed to be affiliated
- 21 with a political party if the individual is presently a member of
- 22 that party or a federal, state, or local chapter or other division
- 23 of that party. If an individual is applying as an independent, the
- 24 individual must state under oath that he or she is not presently a
- 25 member of any political party. If an individual is applying as an
- 26 affiliate of a political party, the individual must state under
- 27 oath that the individual affiliates with that political party and

- 1 is not presently a member of any other political party.
- 2 (c) An individual is conclusively presumed to be affiliated
- 3 with a political party if, within the prior 6 years, the individual
- 4 offered to or did contribute, loan, or promise money or anything of
- 5 value to that political party or a federal, state, or local chapter
- 6 or other division of that political party.
- 7 (d) An individual is conclusively presumed to be affiliated
- 8 with more than 1 political party if, within the prior 6 years, the
- 9 individual offered to or did contribute, loan, or promise money or
- 10 anything of value to more than 1 political party or a federal,
- 11 state, or local chapter or other division of more than 1 political
- 12 party.
- Sec. 7. In making applications for commissioner available to
- 14 the general public, the secretary of state shall make the
- 15 applications available online and circulate the applications
- 16 throughout the state, including at all secretary of state offices.
- 17 Sec. 9. When mailing applications for commissioner to Michigan
- 18 registered voters selected at random, the recipients shall be
- 19 selected from a pool of Michigan registered voters that includes
- 20 all Michigan registered voters.
- 21 Sec. 11. When the secretary of state is required to use a
- 22 random selection process in the implementation of its duties
- 23 related to the commission, it shall, in accordance with the
- 24 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- 25 24.328, promulgate rules to establish the manner of random
- 26 selection to be used and procedures for implementing the random
- 27 selection process.

- 1 Sec. 13. An individual who is affiliated with a political
- 2 party is prohibited from providing services, including, but not
- 3 limited to, legal and accounting services, to the commission.<< This
 section does not apply to an individual serving as a commissioner on the
 commission.>>
- 4 Sec. 15. An individual who violates an oath or provides false
- 5 information on an application under this act is responsible for a
- 6 civil fine of \$500.00.
- 7 Enacting section 1. This act takes effect 90 days after the
- 8 date it is enacted into law.
