SUBSTITUTE FOR HOUSE BILL NO. 4412

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 17766g.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 17766g. (1) Except as otherwise provided in subsection (4), a person shall not knowingly or willfully sell or trade a finished drug product containing any quantity of dextromethorphan to a minor.
 - (2) A person making a retail sale of a finished drug product containing any quantity of dextromethorphan must require and obtain proof of age from the purchaser before completing the sale, unless from the purchaser's outward appearance the person making the sale would reasonably presume the purchaser to be at least 25 years of

- 2 (3) Except as otherwise provided in subsection (4), a minor
- 3 shall not purchase a finished drug product containing any quantity
