SUBSTITUTE FOR HOUSE BILL NO. 5098

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending section 5l (MCL 28.425l), as amended by 2017 PA 95.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:





Sec. 5l. (1) A license to carry a concealed pistol, including a 1 2 renewal license, is valid until the applicant's date of birth that falls not less than 4 years or more than 5 years after the license 3 4 is issued or renewed, as applicable. The county clerk shall notify 5 the licensee that his or her license is about to expire and may be renewed as provided in this section. The notification must be sent 6 by the county clerk to the last known address of the licensee as 7 shown on the records of the county clerk. The notification must be 8 9 sent in a sealed envelope by first-class mail not less than 3 10 months or more than 6 months before the expiration date of the current license. Except as provided in this section, a renewal of a 11 12 license under section 5b must be issued in the same manner as an 13 original license issued under section 5b. An applicant is eligible 14 for a renewal of a license under this section if his or her license 15 is not expired, or expired within a 1-year period before the date of application under this section. Each applicant who submits an 16 17 application for a renewal license to a county clerk under this section shall pay an application and licensing fee of \$115.00 18 19 \$30.00 by any method of payment accepted by that county for 20 payments of other fees and penalties. No other charge, fee, cost, 21 or assessment, including any local charge, fee, cost, or 22 assessment, is required of the applicant except as specifically 23 authorized in this act. The applicant shall pay the application and licensing fee to the county. The county treasurer shall deposit 24 \$36.00 of each the fee collected under this subsection in the 25 26 concealed pistol licensing fund of that county created in section 27 5x. The county treasurer shall forward the balance remaining to the 28 state treasurer. The state treasurer shall deposit the balance of 29 the fee in the general fund to the credit of the department of

2 (2) Subject to subsections (9) (8) and (10), (9), an application to renew a license to carry a concealed pistol may be 3 submitted not more than 6 months before the expiration of the 4 current license. No later than December 1, 2018, the The department 5 6 of state police shall provide a system for an applicant to submit 7 his or her application to renew a license to carry a concealed 8 pistol online or by first-class mail and shall accept those 9 applications on behalf of the county clerk as required under this 10 act. at no additional charge. Each applicant who submits a renewal 11 license online or by first-class mail to the department of state police under this section shall pay an application and licensing 12 fee of \$115.00 \$30.00 by any method of payment accepted by the 13 14 department of state police. No other charge, fee, cost, or 15 assessment is required of the applicant except as specifically 16 authorized in this act. The applicant shall pay the application and 17 licensing fee to the this state. The state treasurer shall forward \$36.00 of each the fee collected under this subsection to the 18 19 county treasurer who shall deposit the \$36.00 fee in the concealed 20 pistol licensing fund of that county created in section 5x. The 21 state treasurer shall deposit the balance of the fee in the general fund to the credit of the department of state police. The 22 23 department of state police shall notify the county clerk of the 24 county in which the applicant resides of a properly submitted 25 online application or application by first-class mail received by 26 the department. If the county clerk issues a renewal license under 27 this section, the county clerk shall send the license to the licensee by first-class mail in a sealed envelope. If the county 28 29 clerk issues the renewal, the effective date of the renewal license

- 13 contain all of the following:
- 14 (a) The name of the applicant.
- 15 (b) The date and time the receipt is issued.
- 16 (c) The amount paid.
- 17 (d) The applicant's state-issued driver license or personal18 identification card number.
- 19 (e) The statement "This receipt was issued for the purpose of
- 20 renewal of a concealed pistol license. As provided in section 5l of
- 21 1927 PA 372, MCL 28.425l, if a license or notice of statutory
- 22 disqualification is not issued within 30 days after the date this
- 23 receipt was issued, this receipt shall serve as a concealed pistol

(5) Until November 30, 2018, a member of the United States 1 2 Armed Forces, the United States Armed Forces Reserve, or the Michigan National Guard who is on orders to a duty station outside 3 of this state may submit his or her application to renew a license 4 to carry a concealed pistol by first-class mail, containing the 5 6 required fee, a notarized application, the licensee's address of 7 record within the state, the licensee's orders to report to a duty 8 station outside of this state, and if the licensee desires to have 9 his or her application receipt, renewal license, or any other 10 notices mailed to his or her address of assignment or deployment, a 11 letter requesting that action including the address of assignment or deployment. If the county clerk issues a renewal license under 12 this section, the county clerk shall send the license to the 13 14 licensee by first-class mail in a sealed envelope. If the licensee 15 is a member of the United States Armed Forces, the United States 16 Armed Forces Reserve, or the Michigan National Guard who is on 17 orders to a duty station outside of this state and requests that his or her license be sent to the address of assignment or 18 deployment, the county clerk shall mail the license to the licensee 19 20 at the address of assignment or deployment provided in the renewal application. Until November 30, 2018, if a renewal application is 21 submitted by a member of the United States Armed Forces, the United 22 23 States Armed Forces Reserve, or the Michigan National Guard who is 24 on orders to a duty station outside of this state, the county clerk 25 shall mail a receipt to the licensee by first-class mail. 26 (5) (6)—If an individual applies for a renewal license before

(5) (6)—If an individual applies for a renewal license before the expiration of his or her license, the expiration date of the current license is extended until the renewal license or notice of statutory disqualification is issued. The county clerk shall notify

- 2 department of state police after he or she receives an application
- 3 for renewal. The department of state police shall immediately enter
- 4 into the law enforcement information network the date that
- 5 application for renewal was submitted and that the renewal

- 3 (9) (10) An applicant who is applying for a renewal of a
 4 license issued under section 5b is not required to have
 5 fingerprints taken again under section 5b(9) if all of the
 6 following conditions have been met:
 - (a) There has been established a system for the department of state police to save and maintain in its automated fingerprint identification system (AFIS) database all fingerprints that are submitted to the department of state police under section 5b.
- (b) The applicant's fingerprints have been submitted to and maintained by the department of state police as described in subdivision (a) for ongoing comparison with the automated fingerprint identification system (AFIS) database.
