SUBSTITUTE FOR HOUSE BILL NO. 5817

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding subpart 11 to part 115.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SUBPART 11 MATERIALS MANAGEMENT PLANS

Sec. 11571. (1) The department shall ensure that each county has an approved materials management plan. The approved solid waste management plan in effect on the effective date of the amendatory act that added this section remains in effect until a materials management plan has been approved for the planning area under this subpart.

(2) The planning area of a single MMP may include 2 or more counties if the county boards of commissioners for those counties

- 1 agree to the joint exercise of their powers and performance of
- 2 their duties under this subpart and to the joint performance by the
- 3 counties of the duties of the county approval agency. In addition,
- 4 if the department is responsible for preparing the MMP for 2 or
- 5 more counties under section 11575, the department may include those
- 6 counties in the planning area of a single MMP and may exercise its
- 7 powers and perform its duties under this subpart for those counties
- 8 jointly.
- 9 (3) Multicounty MMPs are subject to the same procedure for
- 10 approval as single-county MMPs, and each county board of

- 10 Sec. 11572. (1) Within 120 days after the CAA submits a notice
- 11 of intent to the department under section 11571, the CAA shall
- 12 appoint a planning committee. The planning committee is a permanent
- 13 body. Initial planning committee members shall be appointed for 5-
- 14 year terms. Their immediate successors shall be appointed for 2-,
- 15 3-, 4-, or 5-year terms such that, as nearly as possible, the same
- 16 number are appointed for each term length. Subsequently, members
- 17 shall be appointed for terms of 5 years. A member may be
- 18 reappointed.
- 19 (2) If a vacancy occurs on the planning committee, the CAA
- 20 shall make an appointment for the unexpired term in the same manner

- 15 (d) A compost or other organics facility operator that
- 16 provides services in the planning area.
- 17 (e) A waste diversion, reuse, or reduction facility operator
- 18 that provides services in the planning area.
- 19 (f) A representative of an environmental interest group that
- 20 has members residing in the planning area.
- 21 (g) An elected official of the county.
- 22 (h) An elected official of a township in the planning area.
- 23 (i) An elected official of a city or village in the planning
- 24 area.
- 25 (j) An individual who generates a managed material in the
- 26 planning area.
- 27 (k) A representative of the regional planning agency whose
- 28 territory includes the planning area.
- 29 (5) The CAA may appoint to the planning committee 1 additional



- 1 representative that does business in or resides in an adjacent 2 community outside the planning area.
- 3 (6) CAAs preparing a multicounty MMP under section 11571 shall 4 appoint a single planning committee. For each county, both of the 5 following additional members may be appointed to the planning 6 committee:
- 7 (a) An elected official of the county or a municipality in the 8 planning area.
- 9 (b) A representative from a business that generates managed 10 materials within the planning area.
- 11 (7) If, during the MMP development or amendment process, a 12 solid waste landfill is proposed to be developed in the planning 13 area within 2 miles of a municipality in this state that is located 14 adjacent to the planning area, or if a solid waste processing and 15 transfer facility or materials utilization facility is proposed to 16 be developed in the planning area within 1 mile of such a 17 municipality, the CAA shall notify the adjacent municipality in 18 writing. If requested by the adjacent municipality, the CAA shall 19 appoint to the planning committee an additional member 20 representative of the adjacent municipality to serve as a regular
 - (8) If the CAA has difficulty finding qualified individuals to serve on the planning committee, the department may approve a reduction in the number of members of the planning committee. However, at a minimum, the planning committee shall include all of the following members:
- 27 (a) A representative of the solid waste disposal industry 28 providing services in the planning area.
 - (b) A representative of a materials utilization facility

- 3 (b) Under the direction of the planning committee, prepare an 4 MMP.
- 5 (c) During the preparation of an MMP, solicit the advice of 6 and consult with all of the following:
- 7 (i) Periodically, the municipalities, appropriate 8 organizations, and the private sector, including materials 9 management facility operators, in the planning area.
- 10 (ii) The appropriate county or regional planning agency.
- 11 (iii) Counties and municipalities, in adjacent counties, that 12 may be significantly affected by the MMP.
- (d) Not less than 10 days before each public meeting at which
 the DPA will discuss the MMP, give notice of the meeting to the
 chief elected official of each municipality within the planning
 area and any other person within the planning area that requests
 notice. The notice shall indicate as precisely as possible the
 subject matter being discussed.
- 19 (e) Obtain written approval of the MMP from the planning 20 committee.
- 21 (f) Submit a copy of the MMP as approved by the planning 22 committee to all of the following with a notice specifying the end 23 of the public comment period under subdivision (h):
 - (i) The department.
 - (ii) Each municipality within the planning area.
- 26 (iii) Counties and municipalities adjacent to the planning area 27 that may be significantly affected by the MMP or that have 28 requested the opportunity to review the MMP.
- (iv) The regional planning agency for each county included in



1 the planning area.

- 2 (g) Publish a notice in a newspaper or by electronic media 3 having major circulation or viewership in the planning area. The 4 notice shall indicate a location where copies of the proposed MMP 5 are available for public inspection or copying at cost, specify the 6 end of the public comment period under subdivision (h), and solicit 7 public comment.
 - (h) Receive public comments on the MMP for not less than 60 days after the publication of the notice under subdivision (g).
 - (i) During the public comment period under subdivision (h), conduct a public hearing on the MMP. The planning committee shall publish a notice for not less than 30 days before the hearing in a newspaper or by electronic media having major circulation or viewership in the planning area. The notice shall indicate a location where copies of the proposed MMP are available for public inspection or copying at cost and shall indicate the time and place of the public hearing. The same notice may be used to satisfy the requirements of this subdivision and subdivision (g). The planning committee shall submit to the department proof of notice publication under this subdivision and subdivision (g).
 - (j) Submit to the planning committee a summary of the comments received during the public comment period.
 - (2) The DPA, or the department if the department prepares an MMP, shall use a standard format in preparing the MMP. The department shall prepare the standard format and provide a copy of the standard format to each DPA that the department knows will prepare an MMP. The department shall provide the standard format to any other person upon request.
 - (3) The planning committee shall consider the comment summary

- 1 received from the DPA under subsection (1)(j) and may direct the
- 2 DPA to revise the MMP. The DPA shall revise the MMP as directed by
- 3 the planning committee. Not more than 30 days after the end of the
- 4 public comment period, the DPA shall submit the proposed MMP, as
- 5 revised, if applicable, to the planning committee.
- 6 (4) Not more than 30 days after the MMP is submitted to the
- 7 planning committee under subsection (3), the planning committee
- 8 shall take formal action on the MMP and, if the planning committee
- 9 approves the MMP in compliance with section 11572(3), the DPA shall

- 11 Sec. 11575. (1) Not more than 60 days after the MMP is
- 12 submitted to the CAA under section 11574(4), the CAA shall approve
- 13 or reject the MMP and notify the planning committee. A notice that
- 14 the CAA rejects the MMP shall include the specific reasons in
- 15 writing for the rejection.
- 16 (2) Not more than 30 days after notice of the rejection of the
- 17 MMP is sent under subsection (1), the planning committee may revise
- 18 the MMP and submit the revised MMP to the CAA. After a revised MMP
- 19 is timely submitted to the CAA under this subsection or the 30-day
- 20 period expires and a revised MMP is not submitted, the CAA shall
- 21 approve or reject the revised MMP or original MMP, respectively,
- 22 and notify the planning committee.
- 23 (3) If the CAA rejects the MMP under subsection (2), the CAA
- 24 shall prepare and approve an MMP, subject to the continued running

- 26 (4) Not more than 10 business days after the CAA approves an
- 27 MMP under subsection (1), (2), or (3), the DPA shall submit a copy
- 28 of the MMP to the legislative body of each municipality located
- 29 within the planning area.

- 1 (5) Not more than 120 days after the MMP is submitted to the 2 legislative body of a municipality, the legislative body may 3 approve or reject the MMP. The legislative body shall notify the 4 DPA of an approval or rejection.
- 5 (6) Within 30 days after the deadline for municipal 6 notification to the DPA under subsection (5), the DPA shall notify 7 the department which municipalities timely approved the MMP, which 8 timely rejected the MMP, and which did not timely notify the DPA of 9 approval or rejection. The notice shall be accompanied by a copy of 10 the MMP. If the MMP is not approved by at least 2/3 of the 11 municipalities that timely notify the DPA of their approval or rejection under subsection (5), then the department shall proceed 12 13 under subsection (7) or (9). If the MMP is approved by at least 2/3 14 of the municipalities that timely notify the DPA of their approval 15 or rejection under subsection (5), then subsection (9) applies.
- 16 (7) The department may approve an extension of a deadline 17 under subsections (2) to (6) if the extension is requested by the 18 entity subject to the deadline within a reasonable time after the 19 issues giving rise to the need for an extension arise.
 - (8) If the MMP is neither approved nor rejected by a deadline established in this subpart, subject to any extension under subsection (7), the MMP is considered automatically approved at that step in the approval process, and the approval process shall continue at the next step. This subsection does not apply to failure of an individual municipality to approve or disapprove the MMP under subsection (5).
- (9) Within 180 days after the MMP is submitted to the department under subsection (6), the department shall approve or reject the MMP. The department shall approve the MMP if the MMP

- 2 is final. If the department rejects the MMP, subsection (11)

- 4 (10) Before approving or rejecting an MMP under subsection
- 5 (9), the department may return the MMP to the CAA with a written
- 6 request for modifications necessary for approval under subsection
- 7 (9) or to clarify the MMP. If the department returns the MMP for
- 8 modifications, the running of the 180-day period is tolled for 90
- 9 days or until the CAA responds to the department's request,
- 10 whichever occurs first. If the CAA does not approve the
- 11 modifications requested by the department, subsection (11) applies.
- 12 (11) Subject to subsection (9), if a CAA does not prepare an
- 13 MMP or the MMP does not timely obtain an approval required by part
- 14 115, the department may prepare and approve an MMP for the county.
- 15 An MMP prepared and approved by the department is final. Once the
- 16 MMP is final, the county shall implement the MMP.
- 17 Sec. 11576. (1) Amendments to an MMP shall be made only as
- 18 provided in subsection (2), (3), or (4).
- 19 (2) The department shall initiate the adoption of 1 or more
- 20 amendments to an MMP if the department determines that the guidance
- 21 provided by legislation, by this state's solid waste policy, or by
- 22 reports and initiatives of the department has significantly changed
- 23 the required contents of an MMP or if as a result of changes in
- 24 conditions in the planning area the MMP no longer complies with the
- 25 requirements of part 115. The procedure for adopting amendments to
- 26 the MMP under this subsection is the same as the procedure for
- 27 adoption of an initial MMP.
- 28 (3) The CAA may initiate 1 or more amendments by filing a
- 29 notice of intent with the department. Except as provided in

- subsection (4), the procedure for adopting an amendment is the same as the procedure for adoption of an initial MMP except as follows:
- 3 (a) The county submits a notice of intent on its own
 4 initiative rather than in response to a request from the department
 5 under section 11571.
- 6 (b) If the CAA rejects a revised amendment under section 7 11575(2), the amendment process terminates.
- 8 (c) Section 11575(11) does not apply. Instead, if any required 9 approval is not timely granted, the amendment process terminates 10 and the amendments are not adopted.
- (4) If, after a notice of intent is filed under subsection
 (3), the department determines that the amendment will increase
 materials utilization or the recovery of managed material and
 complies with part 115, the department may authorize the CAA to
 amend the MMP by simply submitting the amendment to the department
 in writing. The department shall provide the CAA with written
 approval of the submitted amendment.
- 18 (5) A county shall keep its MMP current. The following changes 19 do not require an amendment if made in a supplement to the MMP 20 provided for by the department under section 11574(2) for the 21 purpose of changes not requiring an amendment:
 - (a) Transportation infrastructure.
- 23 (b) Population density.
- 24 (c) Materials management facility inventory.
 - (d) Local ordinances that do not control the development of a materials management facility and that minimally control the operation of the materials management facility, such as ordinances addressing landscaping, screening, and other ancillary construction details; hours of operation; operating records and reporting

- 2 and facility security and safety.
- 3 (6) Changes made without amendment under subsection (5) shall
- 4 be incorporated in the next amendment made under subsection (2) or
- 5 (3).
- 6 (7) By every fifth anniversary date of the approval of the
- 7 initial MMP, the CAA shall do both of the following:
- 8 (a) Complete an MMP review. The purpose of the review is to
- 9 ensure that the MMP complies with part 115 and to evaluate the
- 10 progress that has been made in meeting the MMP's materials
- 11 management goals, including the benchmark recycling standard.
- 12 (b) Submit to the department 1 of the following, as
- 13 appropriate:
- 14 (i) A notice of intent to prepare an MMP amendment.
- 15 (ii) A statement indicating that an amendment is not needed to
- 16 advance the materials management goals.
- 17 (8) The department may review an MMP periodically and
- 18 determine if any amendments are necessary to comply with part 115.
- 19 If the department determines that an amendment is necessary, all of

- 1 Sec. 11577. The goals of an MMP are all of the following:
- 2 (a) To prevent adverse effects on the public health or the
- 3 environment resulting from improper materials management
- 4 collection, processing, recovery, or disposal, including protection
- 5 of surface water and groundwater, air, and land.
- 6 (b) To sustainably manage materials in a way that benefits the
- 7 economy, communities, and the environment.
- 8 (c) To ensure that all managed material generated in the
- 9 planning area is collected and recovered, processed, or disposed at
- 10 materials management facilities that comply with state statutes and
- 11 rules or managed appropriately at out-of-state facilities.
- 12 Sec. 11578. An MMP shall meet all of the following
- 13 requirements:
- 14 (a) Include measurable, objective, and specific goals for the
- 15 planning area for solid waste diversion from disposal areas,
- 16 including, but not limited to, the municipal solid waste recycling
- 17 rate goal under section 11507, the benchmark recycling standard,
- 18 and the material utilization and reduction activities identified by
- 19 the MMP.
- 20 (b) Include an implementation strategy for the county to
- 21 demonstrate progress toward or meet the materials management goals
- 22 by the time of the 5-year MMP review under section 11576(7). The
- 23 implementation strategy shall include, but is not limited to, all
- 24 of the following:
- 25 (i) How progress will be made to reduce the amount of organic
- 26 material being disposed of through food waste reduction,
- 27 composting, and anaerobic digestion.
- 28 (ii) How progress will be made to reduce the amount of
- 29 recyclable materials being disposed of through increased recycling,



- including expanding convenient access and recycling at single and
 multifamily dwellings, businesses, and institutions.
- 3 (iii) A process whereby each of a planning area's materials
 4 utilization facilities are evaluated based on information contained
 5 in reports submitted to the department on an annual basis.
- 6 (iv) A description of the resources needed for meeting the
 7 materials management goals and how the development of necessary
 8 materials utilization facilities and activities will be promoted.
- 9 (v) A description of how the benchmark recycling standards
 10 will be met.
- 11 (vi) A timetable for implementation.
 - (c) Identify by type and tonnage all managed material generated in the planning area, to determine the planning area's managed material capacity need and all managed material that is included in the planning area's materials management goals. Amounts of material may be estimated using a formula provided by the department.
 - (d) Require that a proposed materials management facility meet the requirements of part 115 and be consistent with the materials management goals.
- (e) To the extent practicable, identify and evaluate current and planned materials management infrastructure and systems that contribute or will contribute to meeting the goal under section 11577(c) and other options to meet that goal.
- 25 (f) Include an inventory of the names and addresses of all of 26 the following, subject to subdivision (g):
- 27 (i) Existing disposal areas.
- 28 (ii) Materials utilization facilities that meet both of the 29 following requirements:

- 1 (A) Are in operation on the effective date of the amendatory 2 act that added this section.
- 3 (B) On the effective date of the amendatory act that added 4 this section, comply with part 115 or, within 1 year after that 5 date, are in the process of becoming compliant.
- 6 (iii) Waste diversion centers for which notification has been 7 given to the department under section 11521b.
- 8 (q) Include a materials management facility in the inventory 9 under subdivision (f) only if the owner or operator of the facility 10 has submitted to the county a written acknowledgment indicating 11 that the owner or operator is aware of the proposed inclusion of 12 the facility in the MMP relative to the materials capacity needs 13 identified in subdivision (c) and that the facility has the 14 indicated capacity to manage the materials identified under 15 subdivision (h). The MMP shall include a statement that the owner 16 or operator of each facility listed in the MMP has submitted such 17 an acknowledgment to the county. If the submitted acknowledgments 18 do not document sufficient capacity for disposal or utilization of 19 the identified managed materials to reach the MMP's materials management capacity requirements, including the materials 20 21 management goals, the MMP shall identify specific strategies, 22 including a schedule and approach to develop and fund capacity.
 - (h) Describe the facilities inventoried pursuant to subdivision (f), including a summary of the deficiencies, if any, of the facilities in meeting current materials management needs. The description shall, at a minimum, include all of the following information:
 - (i) The facility latitude and longitude.
 - (ii) The estimated facility acreage.

- 1 (iii) A description of the materials managed.
- 2 (iv) The processes for handling materials at the facility.
- 3 (v) The total authorized capacity of the facility.
- 4 (i) Ensure that the materials management facilities that are
 5 identified as necessary to be sited can be developed in compliance
 6 with state law pertaining to protection of the public health and
 7 the environment, considering the available land in the planning
 8 area and the technical feasibility of, and economic costs
- 9 associated with, the facilities.
