

**SUBSTITUTE FOR  
SENATE BILL NO. 1051**

A bill to amend 1953 PA 232, entitled  
"Corrections code of 1953,"  
by amending section 36 (MCL 791.236), as amended by 2012 PA 623.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 36. (1) All paroles ~~shall~~**must** be ordered by the parole  
2 board and ~~shall~~**must** be signed by the chairperson. Written notice  
3 of the order ~~shall~~**must** be sent by first-class mail or by  
4 electronic means to the prosecuting attorney and the sheriff or  
5 other police officer of the municipality or county in which the  
6 prisoner was convicted and to the prosecuting attorney and the  
7 sheriff or other local police officer of the municipality or county  
8 to which the paroled prisoner is sent or is to be sent. The notice  
9 ~~shall~~**must** be provided ~~within~~**not more than** 10 days after the



1 parole board issues its order to parole the prisoner.

2 (2) A parole order may be rescinded at the discretion of the  
3 parole board for cause before the prisoner is released on parole. A  
4 parole ~~shall~~**must** not be revoked unless an interview with the  
5 prisoner is conducted by 1 member of the parole board. The purpose  
6 of the interview is to consider and act upon information received  
7 by the board after the original parole release decision. A  
8 revocation interview ~~shall~~**must** be conducted ~~within~~**not more than**  
9 45 days after ~~receiving~~**the board received** the new information. ~~At~~  
10 ~~least~~**Not less than** 10 days before the interview, the parolee ~~shall~~  
11 **must** receive a copy or summary of the new evidence that is the  
12 basis for the interview.

13 (3) A parole order may be amended at the discretion of the  
14 parole board for cause **or to adjust conditions as the parole board**  
15 **determines is appropriate**. An amendment to a parole order ~~shall~~  
16 **must** be in writing and is not effective until notice of the  
17 amendment is given to the parolee.

18 (4) When a parole order is issued, the order ~~shall~~**must**  
19 contain the conditions of the parole and ~~shall~~**must** specifically  
20 provide proper means of supervision of the paroled prisoner in  
21 accordance with the rules of the ~~bureau of field~~  
22 ~~services-operations administration~~**. The conditions of the parole**  
23 **must be individualized, must specifically address the assessed**  
24 **risks and needs of the parolee, must be designed to reduce**  
25 **recidivism, and must consider the needs of the victim, if**  
26 **applicable.**

27 (5) The parole order ~~shall~~**must** contain a condition to pay  
28 restitution to the victim of the prisoner's crime or the victim's  
29 estate if the prisoner was ordered to make restitution under the



1 William Van Regenmorter crime victim's rights act, 1985 PA 87, MCL  
2 780.751 to 780.834, or the code of criminal procedure, 1927 PA 175,  
3 MCL 760.1 to 777.69.

4 (6) The parole order ~~shall~~**must** contain a condition requiring  
5 the parolee to pay a parole supervision fee as prescribed in  
6 section 36a.

7 (7) The parole order ~~shall~~**must** contain a condition requiring  
8 the parolee to pay any assessment the prisoner was ordered to pay  
9 under section 5 of 1989 PA 196, MCL 780.905.

10 (8) The parole order ~~shall~~**must** contain a condition requiring  
11 the parolee to pay the minimum state cost prescribed by section 1j  
12 of chapter IX of the code of criminal procedure, 1927 PA 175, MCL  
13 769.1j, if the minimum state cost has not been paid.

14 (9) If the parolee is required to be registered under the sex  
15 offenders registration act, 1994 PA 295, MCL 28.721 to 28.736, the  
16 parole order ~~shall~~**must** contain a condition requiring the parolee  
17 to comply with that act.

18 (10) If a prisoner convicted of violating or conspiring to  
19 violate section 7401(2) (a) (i) or (ii) or 7403(2) (a) (i) or (ii) of the  
20 public health code, 1978 PA 368, MCL 333.7401 and 333.7403, is  
21 released on parole, the parole order ~~shall~~**must** contain a notice  
22 that if the parolee violates or conspires to violate article 7 of  
23 the public health code, 1978 PA 368, MCL 333.7101 to 333.7545, and  
24 that violation or conspiracy to violate is punishable by  
25 imprisonment for 4 or more years, or commits a violent felony  
26 during his or her release on parole, parole ~~shall~~**must** be revoked.

27 (11) A parole order issued for a prisoner subject to  
28 disciplinary time may contain a condition requiring the parolee to  
29 be housed in a community corrections center or a community



1 residential home for not less than the first 30 days but not more  
2 than the first 180 days of his or her term of parole. As used in  
3 this subsection, "community corrections center" and "community  
4 residential home" mean those terms as defined in section 65a.

5 (12) The parole order ~~shall~~**must** contain a condition requiring  
6 the parolee to pay the following amounts owed by the prisoner, if  
7 applicable:

8 (a) The balance of filing fees and costs ordered to be paid  
9 under section 2963 of the revised judicature act of 1961, 1961 PA  
10 236, MCL 600.2963.

11 (b) The balance of any filing fee ordered to be paid by a  
12 federal court under 28 USC 1915 and any unpaid order of costs  
13 assessed against the prisoner.

14 (13) In each case in which payment of restitution is ordered  
15 as a condition of parole, a parole officer assigned to ~~a~~**the** case  
16 shall review the case not less than twice yearly to ensure that  
17 restitution is being paid as ordered. The final review ~~shall~~**must**  
18 be conducted not less than 60 days before the expiration of the  
19 parole period. If the parole officer determines that restitution is  
20 not being paid as ordered, the parole officer shall file a written  
21 report of the violation with the parole board on a form prescribed  
22 by the parole board. The report ~~shall~~**must** include a statement of  
23 the amount of arrearage and any reasons for the arrearage known by  
24 the parole officer. The parole board shall immediately provide a  
25 copy of the report to the court, the prosecuting attorney, and the  
26 victim.

27 (14) If a parolee is required to register under the sex  
28 offenders registration act, 1994 PA 295, MCL 28.721 to 28.736, the  
29 parole officer shall register the parolee as provided in that act.



1           (15) ~~Beginning August 28, 2006, if~~ **If** a parolee convicted of  
2 violating or conspiring to violate section 520b or 520c of the  
3 Michigan penal code, 1931 PA 328, MCL 750.520b and 750.520c, other  
4 than a parolee who is subject to lifetime electronic monitoring  
5 under section 85, is placed on parole, the parole board may require  
6 that the parolee be subject to electronic monitoring. The  
7 electronic monitoring required under this subsection ~~shall~~ **must** be  
8 conducted in the same manner, and ~~shall be~~ **is** subject to the same  
9 requirements, as is described in ~~section 85 of this act and section~~  
10 520n(2) of the Michigan penal code, 1931 PA 328, MCL 750.520n, **and**  
11 **section 85**, except as follows:

12           (a) The electronic monitoring shall continue only for the  
13 duration of the term of parole.

14           (b) A violation by the parolee of any requirement prescribed  
15 in section ~~520n(2)(a) to (c)~~ **520n(2)** is a violation of a condition  
16 of parole, not a felony violation.

17           (16) If the parole order contains a condition intended to  
18 protect 1 or more named persons, the department shall enter those  
19 provisions of the parole order into the corrections management  
20 information system, accessible by the law enforcement information  
21 network. If the parole board rescinds a parole order described in  
22 this subsection, the department within 3 business days shall remove  
23 from the corrections management information system the provisions  
24 of that parole order.

25           (17) Each prisoner who is required to be registered under the  
26 sex offenders registration act, 1994 PA 295, MCL 28.721 to 28.736,  
27 before being released on parole or being released upon completion  
28 of his or her maximum sentence, shall provide to the department  
29 notice of the location of his or her proposed place of residence or



1 domicile. The department then shall forward that notice of location  
2 to the appropriate law enforcement agency as required under section  
3 5(3) of the sex offenders registration act, 1994 PA 295, MCL  
4 28.725. A prisoner who refuses to provide notice of the location of  
5 his or her proposed place of residence or domicile or knowingly  
6 provides an incorrect notice of the location of his or her proposed  
7 place of residence or domicile under this subsection is guilty of a  
8 felony punishable by imprisonment for not more than 4 years or a  
9 fine of not more than \$2,000.00, or both.

10 (18) If a prisoner is serving a sentence for violating section  
11 411i of the Michigan penal code, 1931 PA 328, MCL 750.411i,  
12 ~~(aggravated stalking)~~, and if a victim of that crime has registered  
13 to receive notices about that prisoner under the William Van  
14 Regenmorter crime victim's rights act, 1985 PA 87, MCL 780.751 to  
15 780.834, the parole order for that prisoner ~~shall~~**must** require that  
16 the prisoner's location be monitored by a global positioning  
17 monitoring system during the entire period of the prisoner's  
18 parole. If, at the time a prisoner described in this subsection is  
19 paroled, no victim of the crime has registered to receive notices  
20 about that prisoner under the William Van Regenmorter crime  
21 victim's rights act, 1985 PA 87, MCL 780.751 to 780.834, but a  
22 victim of the crime subsequently registers to receive those  
23 notices, the prisoner's order of parole ~~shall~~**must** immediately be  
24 modified to require that the prisoner's location be monitored by a  
25 global positioning system during the balance of the period of that  
26 prisoner's parole. As used in this subsection, "global positioning  
27 monitoring system" means a system that electronically determines  
28 and reports the location of an individual by means of an ankle  
29 bracelet transmitter or similar device worn by the individual,



1 which transmits latitude and longitude data to monitoring  
2 authorities through global positioning satellite technology but  
3 does not include any radio frequency identification technology,  
4 global positioning technology, or similar technology that would be  
5 implanted in the parolee or would otherwise violate the corporeal  
6 body of the parolee.

7 (19) The parole order ~~shall~~**must** require the parolee to  
8 provide written consent to submit to a search of his or her person  
9 or property upon demand by a peace officer or parole officer. The  
10 written consent ~~shall~~**must** include the prisoner's name and date of  
11 birth, his or her physical description, the date for release on  
12 parole, and the ending date for that parole. The prisoner shall  
13 sign the written consent before being released on parole. The  
14 department shall promptly enter this condition of parole into the  
15 department's corrections management information system or offender  
16 management network information system or into a corresponding  
17 records management system that is accessible through the law  
18 enforcement information network. Consent to a search as provided  
19 under this subsection does not authorize a search that is conducted  
20 with the sole intent to intimidate or harass.

21 (20) As used in this section, "violent felony" means an  
22 offense against a person in violation of section 82, 83, 84, 86,  
23 87, 88, 89, 316, 317, 321, 349, 349a, 350, 397, 520b, 520c, 520d,  
24 520e, 520g, 529, 529a, or 530 of the Michigan penal code, 1931 PA  
25 328, MCL 750.82, 750.83, 750.84, 750.86, 750.87, 750.88, 750.89,  
26 750.316, 750.317, 750.321, 750.349, 750.349a, 750.350, 750.397,  
27 750.520b, 750.520c, 750.520d, 750.520e, 750.520g, 750.529,  
28 750.529a, and 750.530.
