SENATE SUBSTITUTE FOR HOUSE BILL NO. 4067

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16605 and 16608 (MCL 333.16605 and 333.16608), section 16605 as amended by 2018 PA 463 and section 16608 as amended by 2002 PA 643.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 16605. The following words, titles, or letters, or acombination of any of those words, titles, or letters, with or
- 3 without qualifying words or phrases, are restricted in use only to
- 4 those individuals who are authorized under this part to use the
- 5 following terms and in a way prescribed in this part: "dentist",
- 6 (a) "Dentist", "doctor of dental surgery", "oral and
- 7 maxillofacial surgeon", "orthodontist", "prosthodontist",

- 1 "periodontist", "endodontist", "oral pathologist", "pediatric
- 2 dentist", "dental hygienist", "registered dental hygienist",
- 3 "dental assistant", "registered dental assistant", "dental
- 4 therapist", "r.d.a.", "d.d.s.", "d.m.d.", "r.d.h.", and "d.t.".
- 5 (b) Beginning September 1, 2022, "oral and maxillofacial
- 6 radiologist", "dental anesthesiologist", "oral medicine doctor",
- 7 "public health dentist", and "orofacial pain specialist".
- 8 Sec. 16608. (1) The board may issue a health profession
- 9 specialty field license to a licensed dentist who has advanced
- 10 training beyond that required for initial licensure and who has
- 11 demonstrated competency through examination or other evaluative
- 12 processes in 1 or more of the following health profession specialty
- 13 fields: prosthodontics,
- 14 (a) Prosthodontics, endodontics, oral and maxillofacial
- 15 surgery, orthodontics, pediatric dentistry, periodontics, or oral
- 16 pathology.
- 17 (b) Beginning September 1, 2022, oral medicine, orofacial
- 18 pain, dental public health, oral and maxillofacial radiology, or
- 19 dental anesthesiology.
- 20 (2) A licensed dentist who holds held a health profession
- 21 specialty certification in 1 or more of the health profession
- 22 specialty fields listed in this subsection on the effective date of
- 23 the amendatory act that added subsections (3) and (4) (1) (a) on
- 24 December 23, 2002 is considered to hold a health profession
- 25 specialty field license on that date in each of those health
- 26 profession specialty fields and may obtain renewal of each health
- 27 profession specialty field license on the expiration date of the
- 28 specialty certification.
- 29 (3) (2) A health profession specialty field license issued

- pursuant to subsection (1) shall under this section must be renewed
 concurrently with the license to practice dentistry.
- 3 (4) (3)—This section does not prohibit a licensed dentist who
 4 has not been issued a health profession specialty field license
 5 under subsection (1)—this section from performing services in 1 or
 6 more of the health profession specialty fields listed in subsection
 7 (1).
- 8 (5) (4) For purposes of the administration of the general
 9 rules of the board of dentistry in the Michigan administrative
 10 code, Administrative Code, a reference to specialty certification
 11 is a reference to a health profession specialty field license.
