A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 201, 202a, 206, 207a, 207b, 207c, 209a, 210h,
226d, 226g, 229a, and 230 (MCL 388.1801, 388.1802a, 388.1806,
388.1807a, 388.1807b, 388.1807c, 388.1809a, 388.1810h, 388.1826d,
388.1826g, 388.1829a, and 388.1830), sections 201, 206, 207a, 207b,
207c, 209a, 226d, 229a, and 230 as amended and sections 210h and
226g as added by 2021 PA 86 and section 202a as amended by 2020 PA
165, and by adding section 226f; and to repeal acts and parts of
acts.
