## SUBSTITUTE FOR HOUSE BILL NO. 4667

A bill to amend 1986 PA 182, entitled "State police retirement act of 1986,"

(MCL 38.1601 to 38.1674) by adding sections 24c, 24d, 24e, and 24f.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 24c. (1) Subject to subsection (5), the retirement system shall grant service under this act for service rendered under the state employees' retirement act, 1943 PA 240, MCL 38.1 to 38.69, to a member described in section 4(1)(b) if the member pays to the retirement system an amount equal to the actuarial value of the service as determined by the retirement system's actuary.
