SUBSTITUTE FOR HOUSE BILL NO. 4156

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 1278a and 1278b (MCL 380.1278a and 380.1278b), as amended by 2022 PA 105, and by adding section 1278e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1278a. (1) Except as otherwise provided in this section or section 1278b, the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil meets all of the following:
- 5 (a) Has successfully completed all of the following credit 6 requirements of the Michigan merit standard before graduating from 7 high school:
- 8 (i) At least 4 credits in mathematics that are aligned with





subject area content expectations developed by the department and 1 2 approved by the state board under section 1278b, including completion of at least 1 credit in algebra I - and 1 credit in 3 geometry. , and algebra II, or an integrated sequence of this 4 course content that consists of 3 credits, and an additional 5 6 mathematics credit, such as trigonometry, statistics, precalculus, 7 calculus, applied math, accounting, business math, a retake of 8 algebra II, or, for only pupils entering grade 8 before 2023, a 9 course in financial literacy as described in section 1165. A pupil 10 may complete algebra II over 2 years with 2 credits awarded or over 11 1.5 years with 1.5 credits awarded for the purposes of this section and section 1278b. A pupil also may partially or fully fulfill the 12 algebra II requirement by completing a department-approved formal 13 14 career and technical education program or curriculum, such as a 15 program or curriculum in electronics, machining, construction, 16 welding, engineering, computer science, or renewable energy, and in 17 that program or curriculum successfully completing the same content 18 as the algebra II benchmarks assessed on the department-prescribed state high school assessment, as determined by the department. The 19 20 department shall post on its website quidelines for implementation 21 of the immediately preceding sentence. Each pupil must successfully 22 complete at least 1 mathematics course during his or her the 23 pupil's final year of high school enrollment. This subparagraph 24 does not require completion of mathematics courses in any 25 particular sequence.A pupil may fulfill the remaining 2 credits in 26 mathematics through completion of any of the following courses. This subparagraph does not require the board of a school district 27 or intermediate school district or the board of directors of a 28 29 public school academy to offer all of the following courses.

- 1 However, each high school operated by the board or board of
- 2 directors must offer at least sufficient courses for pupils to be
- 3 able to complete the requirements of this subparagraph:
- 4 (A) 1 credit in trigonometry.
- 5 (B) 1 credit in algebra II.
- 6 (C) 1 credit in precalculus.
- 7 (D) 1 credit in calculus.
- 8 (E) 1 credit in applied mathematics.
- 9 (F) 1 credit in statistics.
- 10 (G) 1 credit in computer science. A course in computer science
- 11 used to fulfill a credit under this subparagraph may not be used to
- 12 fulfill any other credit requirement under this section or section
- 13 **1278b**.
- 14 (H) 1/2 credit in accounting.
- 15 (I) 1/2 credit in business mathematics.
- 16 (J) 1/2 credit in construction mathematics.
- 17 (K) 1/2 credit in algebra-based physics.
- 18 (L) 1/2 credit in algebra-based chemistry.
- 19 (M) 1/2 credit in economics with a focus on mathematics.
- 20 (N) Up to 2 credits from a department-approved formal career 21 and technical education program.
- 22 (O) Up to 2 credits from mathematics courses developed or 23 approved by the board of the school district or intermediate school 24 district or board of directors of the public school academy in
- 25 which the pupil is enrolled.
- 26 (ii) At least 3 credits in social science that are aligned with
- 27 subject area content expectations developed by the department and
- 28 approved by the state board under section 1278b, including
- 29 completion of at least 1 credit in United States history and

- 1 geography, 1 credit in world history and geography, 1/2 credit in
- 2 economics, and the civics course described in section 1166(2). For
- 3 only pupils entering grade 8 before 2023, the 1/2-credit economics
- 4 requirement may be satisfied by completion of at least a 1/2-credit
- 5 course in personal economics that includes a financial literacy
- 6 component as described in section 1165, if that course covers the
- 7 subject area content expectations for economics developed by the
- 8 department and approved by the state board under section 1278b. The
- 9 1/2 credit in economics required under this subparagraph cannot be
- 10 fulfilled by completion of the 1/2 credit course in personal
- 11 finance described in subsection (3).
- 12 (iii) At least 1 credit in subject matter that includes both
- 13 health and physical education aligned with guidelines developed by
- 14 the department and approved by the state board under section 1278b,
- or at least 1/2 credit in health aligned with guidelines developed
- 16 by the department and approved by the state board under section
- 17 1278b and at least 1/2 credit awarded by the school district or
- 18 public school academy for approved participation in extracurricular
- 19 athletics or other extracurricular activities involving physical
- 20 activity.
- 21 (iv) At least 1 credit in visual arts, performing arts, or
- 22 applied arts , as defined by the department, that is aligned with
- 23 quidelines developed by the department and approved by the state
- 24 board under section 1278b. A school district or public school
- 25 academy is strongly encouraged to offer visual arts and performing
- 26 arts courses. The credit in visual arts, performing arts, or applied
- 27 arts under this subparagraph may be fulfilled through completion of
- 28 any of the following courses. This subparagraph does not require
- 29 the board of a school district or intermediate school district or

- 1 the board of directors of a public school academy to offer all of
- 2 the following courses. However, each high school operated by the
- 3 board or board of directors must offer at least sufficient courses
- 4 for pupils to be able to complete the requirements of this
- 5 subparagraph:
- 6 (A) 1 credit in general music.
- 7 (B) 1 credit in marching band.
- 8 (C) 1 credit in concert band.
- 9 (D) 1 credit in orchestra.
- 10 (E) 1 credit in choral music.
- 11 (F) 1 credit in strings.
- 12 (G) 1 credit in music theory.
- 13 (H) 1 credit in keyboard.
- 14 (I) 1 credit in jazz ensemble.
- 15 (J) 1 credit in wind ensemble.
- 16 (K) 1 credit in choir.
- 17 (L) 1 credit in art.
- 18 (M) 1 credit in visual arts.
- 19 (N) 1 credit in visual studies.
- 20 (O) 1 credit in drawing.
- 21 (P) 1 credit in painting.
- 22 (Q) 1 credit in ceramics and pottery.
- 23 (R) 1 credit in design.
- 24 (S) 1 credit in art appreciation.
- 25 (T) 1 credit in illustration.
- 26 (U) 1 credit in computer graphics and design.

- 8 (FF) 1 credit in culinary studies.
- 9 (GG) 1 credit in computer science. A course in computer
 10 science used to fulfill a credit under this subparagraph may not be
 11 used to fulfill any other credit requirement under this section or
 12 section 1278b.
- 13 (HH) 1 credit from a department-approved formal career and technical education program.
- (II) 1 credit in a visual arts course developed or approved by the board of the school district or intermediate school district or board of directors of the public school academy in which the pupil is enrolled.
 - (v) Beginning with pupils entering high school in the 2029-2030 school year, at least 1 credit in future skills that is aligned with subject area content expectations developed by the department and approved by the state board under section 1278b. The credit in future skills required under this subparagraph is fulfilled through completion of the 1/2 credit course in personal finance described in subsection (3) and the 1/2 credit course in workplace development described in subsection (4).
 - (vi) $\frac{(v)}{(v)}$ The credit requirements specified in section 1278b(1).
- 28 (b) Meets the online course or learning experience requirement 29 of this subsection. A school district or public school academy

- 1 shall provide the basic level of technology and internet access
- 2 required by the state board to complete the online course or
- 3 learning experience. For a pupil to meet this requirement, the
- 4 pupil must meet either of the following, as determined by the
- 5 school district or public school academy:
 - (i) Has successfully completed at least 1 course or learning experience that is presented online, as defined by the department.
- 8 (ii) The pupil's school district or public school academy has
- 9 integrated an online experience throughout the high school
- 10 curriculum by ensuring that each teacher of each course that
- 11 provides the required credits of the Michigan merit curriculum has
- 12 integrated an online experience into the course.
- 13 (2) Except as otherwise provided in this section, and in
- 14 addition to the requirements under subsection (1), the board of a
- 15 school district or board of directors of a public school academy
- 16 shall not award a high school diploma to a pupil unless the pupil
- 17 has successfully completed during grades K to 12 at least 2 credits
- 18 that are grade-appropriate in a language other than English or
- 19 course work coursework or other learning experiences that are
- 20 substantially equivalent to 2 credits in a language other than
- 21 English, based on quidelines developed by the department. A pupil
- 22 may partially or fully fulfill 1 credit of this requirement by
- 23 completing a department-approved formal career and technical
- 24 education program or curriculum or by completing visual or
- 25 performing arts instruction that is in addition to the requirements
- 26 under subsection (1)(a)(iv). The board of a school district or board

- 9 (3) Beginning with pupils entering grade 8 in 2023, the board 10 of a school district or board of directors of a public school 11 academy shall not award a high school diploma to a pupil unless the pupil completes a 1/2 credit course in personal finance that aligns 12 with subject area content expectations developed by the department 1.3 and approved by the state board under section 1278b. The 1/2 credit 14 15 course in personal finance must fulfill 1/2 credit of mathematics required under subsection (1)(a)(i), 1/2 credit of visual arts, 16 17 performing arts, or applied arts required under subsection 18 (1) (a) (iv), or 1/2 credit of a language other than English required under subsection (2), as determined by the board of the school 19 2.0 district or board of directors of the public school academy in 21 which the pupil is enrolled. future skills required under 22 subsection (1)(a)(ν). The 1/2 credit course in personal finance 23 required under this subsection may be fulfilled through a 24 department-approved formal career and technical education program 25 or curriculum that aligns with the subject area content 26 expectations developed by the department and approved by the state board for the credit under section 1278b. 2.7
 - (4) Beginning with pupils entering grade 8 in 2029, the board of a school district or board of directors of a public school

 - (c) A school district or public school academy shall also grant a pupil a credit if the pupil earns a qualifying score, as determined by the department, on assessments developed or selected for the subject area by the department or the pupil earns a qualifying score, as determined by the school district or public school academy, on 1 or more assessments developed or selected by the school district or public school academy that measure a pupil's understanding of the subject area content expectations or guidelines that apply to the credit.
 - (7) (6)—If a high school is designated by the superintendent of public instruction as a specialty school and the high school meets the requirements of subsection (7), (8), the pupils of the high school are not required to successfully complete the 4 credits in English language arts required under section 1278b(1)(a) or the 3 credits in social science required under subsection (1)(a)(ii) and the school district or public school academy is not required to ensure that each pupil is offered the curriculum necessary for meeting those English language arts or social science credit requirements. The superintendent of public instruction may designate up to 15 high schools that meet the requirements of this

A student must complete at least 1 credit in biology and either 1 credit in chemistry, earth science, agricultural science, 12 13 or physics. , anatomy, or agricultural science, or successfully 14 completing a program or curriculum that provides the same content 15 as the chemistry or physics benchmarks, as determined by the department.  - (iv) The department shall complete the development of the subject area content expectations that apply to algebra I and the guidelines for the online course or learning experience under section 1278a(1)(b) not later than August 1, 2006.
 - (ν) The department shall complete development of the subject area content expectations or guidelines that apply to each of the other credits required in the Michigan merit standard under subsection (1) and section 1278a(1)(a) not later than 1 year before the beginning of the school year in which a pupil entering high school in 2007 would normally be expected to complete the credit.
 - (vi) If the department has not completed development of the subject area content expectations that apply to a particular credit required in the Michigan merit standard under subsection (1) or section 1278a(1)(a) by the date required under this subdivision, a school district or public school academy may align the content of the credit with locally adopted standards.
 - (vii) Until all of the subject area content expectations and guidelines have been developed by the department and approved by the state board, the department shall submit a report at least every 6 months to the senate and house standing committees responsible for education legislation on the status of the development of the subject area content expectations and guidelines. The report must detail any failure by the department to meet a deadline established under subparagraph (iv) or (v) and the reasons for that failure.
 - (b) Develop and implement a process for developing the subject area content expectations and guidelines required under this

- 1 section. This process must provide for all of the following:
- 2 (i) Soliciting input from all of the following groups:
- 3 (A) Recognized experts in the relevant subject areas.
- 4 (B) Representatives from 4-year colleges or universities,
- 5 community colleges, and other postsecondary institutions.
- 6 (C) Teachers, administrators, and school personnel who have 7 specialized knowledge of the subject area.
 - (D) Representatives from the business community.
- 9 (E) Representatives from vocational and career and technical 10 education providers.
- 11 (F) Government officials, including officials from the 12 legislature.
 - (G) Parents of public school pupils.
- 14 (ii) A review of the subject area content expectations or 15 guidelines by national experts.
- (iii) An opportunity for the public to review and provide input on the proposed subject area content expectations or guidelines before they are submitted to the state board for approval. The time period allowed for this review and input must be at least 15 business days.
- (c) Determine the basic level of technology and internet access required for pupils to complete the online course or learning experience requirement of section 1278a(1)(b), and submit that determination to the state board for approval.
 - (d) Develop and make available material to assist school districts and public school academies in implementing the requirements of this section and section 1278a. This must include developing guidelines for alternative instructional delivery methods as described in subsection (7).

- (4) The state board shall approve subject area content expectations and guidelines developed by the department under subsection (3) before those subject area content expectations and guidelines may take effect. The state board also shall approve the basic level of technology and internet access required for pupils to complete the online course or learning experience requirement of section 1278a(1)(b).

Sec. 1278e. (1) By not later than June 30, 2028, the department shall develop or adopt, and provide to schools, model programs of instruction for all courses described in sections 1278a and 1278b. The model programs of instruction must align with subject area content expectations and guidelines developed by the department and approved by the state board under section 1278b.

(2) The board of a school district or intermediate school district or board of directors of a public school academy is not required to adopt or implement the model programs of instruction developed or adopted by the department under subsection (1).
