## HOUSE SUBSTITUTE FOR SENATE BILL NO. 99

A bill to amend 2023 PA 281, entitled "Public officers financial disclosure act," by amending sections 3, 5, 7, 8, 11, 13, and 15 (MCL 15.703, 15.705, 15.707, 15.708, 15.711, 15.713, and 15.715) and by adding section 6.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3. As used in this act:
- (a) "Blind trust" means a qualified blind trust or qualified diversified trust as those terms are defined in 5 CFR 2634.403.
- (b) "Consumer Price Index" means the most comprehensive index of consumer prices available for the Detroit-Warren-Dearborn area from the Bureau of Labor Statistics of the United States Department of Labor.

- 19 value for the purpose of listing each asset, excluding a business
- 20 asset, held for investment or production of income under this
- 21 subdivision must be adjusted for inflation every 4 years using the
- 22 Detroit Consumer Price Index, and rounded up to the nearest

- 10 investment company, pension or deferred compensation plan, or other
- 11 investment fund, if both of the following apply:
- 12 (i) Either the fund is publicly traded or the assets of the
- 13 fund are widely diversified.
- 14 (ii) The public officer or the public officer's spouse does not
- 15 exercise control over or have the ability to exercise control over
- 16 the financial interests held by the fund.
- 17 (j) A list of any real property in which the public officer
- 18 holds an ownership or other financial interest. For purposes of
- 19 this subdivision, the public officer is required to include a real
- 20 property in the report only if that real property has a fair market
- 21 value of \$1,000.00 or more during the reporting period. A public
- 22 officer filing a report may exclude the street number of a parcel

- Sec. 8. A-Not later than 10 days after entering into an

- 4 must report to the department within 10 days after entering into
- 5 any agreement or arrangement described in section 7(1)(k) disclose

- (1) (2) The Except as otherwise provided in subsection (2),
- 19 the department shall, no later not less than March 15, 2024, 30
- 20 days before a report is due each year, make the most current
- 21 version of the financial disclosure report form created under this
- 22 section 6 easily accessible on its website.
- (2) For the financial disclosure report due on June 13, 2025,
- 24 the department shall make the financial disclosure report form
- 25 provided under section 6 easily accessible on its website not later
- 26 than May 31, 2025.
- Sec. 13. (1) The secretary of state shall do all of the
- 28 following:
- 29 (a) Make available through the secretary of state's offices

- 1 appropriate forms, instructions, and manuals required by this act.
- 2 (b) Create and operate an electronic, internet-accessible
  3 system to receive all—statements and reports required by—under this
  4 act to be filed with the secretary of state.
  - (c) Accept statements and reports required by this act to be filed with the secretary of state that are filed via email as an acceptable alternative to the electronic filing system created under subdivision (b). This subdivision applies retroactively to statements and reports filed by email for the reporting period of January 1, 2023 to December 31, 2023.
  - (d) (c) Create all forms, Publish the financial disclosure report form described in section 6, and create the instructions  $\tau$  and manuals required under this act.
- (e) (d)—Issue declaratory rulings to implement this act under the administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.
- (f) (e) On receiving a written request and the required
  filing, waive payment of a late filing fee if the request for the
  waiver is based on good cause and accompanied by adequate
  documentation. One or more of the following reasons constitute good
  cause for a late filing fee waiver:
  - (i) The incapacitating physical illness, hospitalization, accident involvement, death, or incapacitation for medical reasons of a public officer or an individual whose participation is essential to the preparation of the report.
  - (ii) Other unique, unintentional factors beyond the control of the public officer that are not the result of a negligent act or nonaction so that a reasonably prudent person would excuse the filing on a temporary basis. These factors include the loss or

- 5 issue a declaratory ruling within not later than 60 business days
- 6 after receiving a request for a declaratory ruling. The secretary
- 7 of state may refuse to issue a declaratory ruling or an
- 8 interpretive statement under this act if the request is anonymous,
- 9 the secretary of state determines that the subject matter of the
- 10 request is frivolous on its face, or the request is indefinite or
- 11 lacks specificity. If the secretary of state refuses to issue a
- 12 declaratory ruling, the secretary of state shall notify the person
- 13 making the request of the reasons for the refusal and issue an
- 14 interpretive statement providing an informational response to the
- 15 question presented within the 60-day period. A declaratory ruling
- 16 or interpretive statement issued under this section must not state
- 17 a general rule of law, other than that which is stated in this act,
- 18 or under judicial order.
- 19 (3) Under extenuating circumstances, the secretary of state
- 20 may issue a notice extending, for not more than 30 business days,
- 21 the period during which the secretary of state shall respond to a
- 22 request for a declaratory ruling. The secretary of state shall not
- 23 issue more than 1 notice of extension for a particular request. A
- 24 person requesting a declaratory ruling may waive, in writing, the
- 25 time limitations provided by this section.
- 26 (4) The secretary of state shall make available to the public
- 27 an annual summary of the declaratory rulings and interpretive
- 28 statements issued by the secretary of state under this section.
- 29 (5) A person may file with the secretary of state a complaint

- 1 that alleges a violation of this act. Within Not later than 5
- 2 business days after a complaint that meets the requirements of
- 3 subsection (6) is filed, the secretary of state shall mail notice
- 4 to the person against whom the complaint is filed. The notice must
- 5 include a copy of the complaint. Within Not later than 15 business
- 6 days after the notice is mailed, the person against whom the
- 7 complaint was filed may submit a response to the secretary of
- 8 state. The secretary of state may extend the period for submitting
- 9 a response an additional 15 business days for good cause. The
- 10 secretary of state shall mail a copy of a response received to the
- 11 complainant. Within Not later than 10 business days after the
- 12 response is mailed, the complainant may submit a rebuttal statement
- 13 to the secretary of state. The secretary of state may extend the
- 14 period for submitting a rebuttal statement an additional 10
- 15 business days for good cause. The secretary of state shall provide
- 16 a copy of the rebuttal statement to the person against whom the
- 17 complaint was filed. If, on review of the complaint, the secretary
- 18 of state determines that the complaint is frivolous, illegible,
- 19 indefinite, or unsigned, or does not identify an alleged violator,
- 20 allege a violation of the act, or contain a verification statement,
- 21 the secretary of state may summarily dismiss the complaint without
- 22 prejudice. If a complaint is summarily dismissed, the complainant
- 23 must be notified in writing as to the reason the complaint was
- 24 dismissed. The secretary of state may consolidate similar
- 25 complaints.
- 26 (6) A complaint filed under subsection (5) must satisfy all of
- 27 the following requirements:
- 28 (a) Be signed by the complainant.
- 29 (b) State the name, address, and telephone number of the

- 2 (c) Include the complainant's certification that, to the best of the complainant's knowledge, information, and belief, formed 3 after a reasonable inquiry under the circumstances, each factual 4 5 contention of the complaint is supported by evidence. However, if, 6 after a reasonable inquiry under the circumstances, the complainant is unable to certify that certain factual contentions are supported 8 by evidence, the complainant may certify that, to the best of the 9 complainant's knowledge, information, or belief, there are grounds 10 to conclude that those specifically identified factual contentions 11 are likely to be supported by evidence after a reasonable opportunity for further inquiry. 12
  - (7) A person shall not file a complaint with a false certificate under subsection (6)(c). A person may file a complaint under subsection (5) alleging that another person has filed a complaint with a false certificate under subsection (6)(c).
  - (8) The secretary of state shall investigate allegations brought under this act. If an allegation involves the secretary of state, or the secretary of state's spouse, the secretary of state shall refer the matter to the attorney general to determine whether a violation of this act occurred.
  - (9) No Not later than 45 business days after receiving a rebuttal statement submitted under subsection (5) or, if no response or rebuttal is received under subsection (5), 45 business days after receiving a complaint under subsection (5), the secretary of state shall post on the secretary of state's website whether there may be reason to believe that a violation of this act occurred. If the secretary of state determines there may be reason to believe that a violation of this act occurred or determines to

- 1 terminate its proceedings, the secretary of state shall, within not
- 2 later than 30 days after that determination, post on the secretary
- 3 of state's website any complaint, response, or rebuttal statement
- 4 received under subsection (5) regarding that violation or alleged
- 5 violation and any correspondence that is dispositive of that
- 6 violation or alleged violation between the secretary of state and
- 7 the complainant or the person against whom the complaint was filed.
- 8 If the secretary of state determines that there may be reason to
- 9 believe that a violation of this act occurred, the secretary of
- 10 state shall endeavor to correct the violation or prevent a further
- 11 violation by using informal methods such as a conference,
- 12 conciliation, or persuasion, and may enter into a conciliation
- 13 agreement with the person involved. Unless violated, a conciliation
- 14 agreement is a complete bar to any further civil action with
- 15 respect to matters covered in the conciliation agreement. The
- 16 secretary of state shall, within not later than 30 days after a
- 17 conciliation agreement is signed, post that agreement on the
- 18 department's website. If, after 90 business days, the secretary of
- 19 state is unable to correct or prevent further violation by these
- 20 informal methods, the secretary of state may commence a hearing as
- 21 provided in subsection (10) for enforcement of this act.
- 22 (10) The secretary of state may commence a hearing to
- 23 determine whether a violation of this act occurred. The hearing
- 24 must be conducted in accordance with chapter 4 of the
- 25 administrative procedures act of 1969, 1969 PA 306, MCL 24.271 to
- 26 24.288.
- 27 (11) A final decision or order issued by the secretary of
- 28 state under this act is subject to judicial review as provided
- 29 under chapter 6 of the administrative procedures act of 1969, 1969

- 1 PA 306, MCL 24.301 to 24.306. The secretary of state shall deposit
- 2 a civil fine imposed under this act in the general fund. The
- 3 secretary of state may bring an action in circuit court to recover
- 4 the amount of a civil fine.
- 5 (12) The secretary of state shall review a report or statement
- 6 filed under this act and may investigate an apparent violation of
- 7 this act. If the secretary of state determines that there may be
- 8 reason to believe a violation of this act occurred and the
- 9 procedures prescribed in subsection (9) have been complied with,
- 10 the secretary of state may commence a hearing under subsection (10)
- 11 to determine whether a violation of this act occurred.
- 12 (13) There is no private right of action, either in law or in
- 13 equity, under this act. The remedies provided in this act are the
- 14 exclusive means by which this act may be enforced and by which any
- 15 harm resulting from a violation of this act may be redressed.
- 16 (14) The secretary of state shall preserve a report filed
- 17 under this act for 15 years after the date the report is filed. If
- 18 the secretary of state or attorney general determines under this
- 19 section that a violation of this act occurred, the secretary of
- 20 state shall preserve all complaints, orders, decisions, or other
- 21 documents related to that violation for 15 years after the date of
- 22 the determination or the date the violation is corrected, whichever
- 23 is later. Reports filed under this act may be reproduced under the
- 24 records reproduction act, 1992 PA 116, MCL 24.401 to 24.406. After
- 25 the required preservation period, the reports, or the reproductions
- 26 of the reports, may be disposed of in the manner prescribed in the
- 27 management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594, and
- 28 section 11 of the Michigan history center act, 2016 PA 470, MCL
- 29 399.811.

- 1 Sec. 15. (1) An individual who fails to file a report as 2 required under this act shall pay a late filing fee of \$25.00 for each business day after the first 10 business days that the report 3 remains unfiled. The fee imposed under this subsection must not 4 exceed \$1,000.00. 5
  - (2) A late filing fee collected under this act must be deposited into the general fund.
  - (3) An individual who knowingly files an incomplete or inaccurate report in violation of this act may be ordered to pay a civil fine of not more than \$2,000.00.
- 11 (4) A late filing fee assessed or civil fine imposed under this act that remains unpaid for more than 180 days must be 12 referred to the department of treasury for collection. 13
- 14 (5) The amount of a late filing fee assessed or civil fine 15 imposed under this act must be adjusted for inflation every 4 years 16 using the Detroit Consumer Price Index.
