HOUSE BILL No. 4105

February 12, 1987, Introduced by Reps. Gagliardi, Bartnik, Demars, Sofio, Connors and Alley and referred to the Committee on State Affairs.

A bill to amend sections 1 and 2 of Act No. 209 of the Public Acts of 1911, entitled

"An act to adopt and prescribe the design of a state coat-of-arms and state flag, and their use, and to prohibit the use of the same for advertising purposes, and to provide a punishment for such forbidden use,"

being sections 2.21 and 2.22 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 1 and 2 of Act No. 209 of the Public
- 2 Acts of 1911, being sections 2.21 and 2.22 of the Michigan
- 3 Compiled Laws, are amended to read as follows:
- 4 Sec. 1. The device and inscriptions of the great seal of
- 5 the state of Michigan, Anno Domini 1835, presented by Lewis Cass
- 6 to the forthcoming state, through the constitutional convention
- 7 and adopted June 2, 1835, and filed with the secretary of the
- 8 territory, June 24, 1835, and illustrated by a seal with said

- 1 device and inscriptions attached to a state document, bearing
- 2 date 1838, and to the constitution of 1850 received and filed in
- 3 the office of the secretary of state, August 15, 1850, and now on
- 4 file in said office, omitting the legend "The great seal of the
- 5 state of Michigan, Anno Domini 1835," is hereby adopted as the
- 6 coat-of-arms of the state, WITH THE FOLLOWING CHANGES:
- 7 (A) THE LEGEND "THE GREAT SEAL OF THE STATE OF MICHIGAN,
- 8 ANNO DOMINI 1835" IS OMITTED.
- 9 (B) THE MOTTO "SI QUAERIS PENINSULAM AMOENAM CIRCUMSPICE" IS
- 10 CHANGED TO "SI QUAERIS PENINSULAS AMOENAS CIRCUMSPICE."
- 11 Sec. 2. The coat-of-arms shall be blazoned as follows:
- 12 Chief, Azure, motto argent Tuebor;
- 13 Charge, Azure, sun-rayed rising sinister proper, lake wavey
- 14 proper, peninsula dexter grassy proper, man dexter on peninsula,
- 15 rustic, habited, dexter arm-raised, dexter turned, sinister arm
- 16 with gun stock resting, all proper;
- 17 Crest, On a wreath azure and or, an American eagle rising to
- 18 the dexter, tips of wings partly lowered to base, all proper,
- 19 dexter talon holding an olive branch with 13 fruit, sinister
- 20 talon holding a sheaf of 3 arrows, all proper. Over his head a
- 21 sky azure environed with a scroll gules with the motto "E
- 22 Pluribus Unum" argent;
- 23 Supporters;
- 24 Dexter, An elk rampant, proper;
- 25 Sinister, A moose rampant, proper;

- 1 Mottoes, On the scroll unending superior narrow argent, in
- 2 sable, the motto, "Si quaeris -peninsulam, amoenam PENINSULAS
- 3 AMOENAS."
- 4 On the scroll unending inferior, broader argent in sable the
- 5 motto "circumspice."
- 6 Observations:
- 7 Scroll support and conventional leaf design between shield
- 8 and scroll superior or;
- 9 Escutcheon supporters rest on the scroll supports and leaf
 10 design.
