

# HOUSE BILL No. 4317

March 10, 1987, Introduced by Reps. Clack, Dobronski, Webb, Jonker, Farhat, Bartnik, Scott, Griffin, Lynn Owen, Maynard, Stallworth, Hoffman, Van Regenmorter, Emerson, Trim, Bankes, Martin, Stabenow, Gubow, Browne, Joe Young, Sr., Bennett, Niederstadt, Honigman, Murphy, Kilpatrick and Gire and referred to the Committee on Judiciary.

A bill to amend section 3801 of Act No. 236 of the Public Acts of 1961, entitled as amended  
"Revised judicature act of 1961,"  
being section 600.3801 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Section 3801 of Act No. 236 of the Public Acts  
2 of 1961, being section 600.3801 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4       Sec. 3801. Any building, vehicle, boat, aircraft, or place  
5 used for the purpose of lewdness, assignation or prostitution or  
6 gambling, or used by, or kept for the use of prostitutes or other  
7 disorderly persons, or used for the unlawful manufacture, stor-  
8 ing, possessing, transporting, sale, keeping for sale, giving  
9 away, bartering, furnishing, or otherwise disposing of any  
10 ~~narcotic and/or hypnotic drug~~ CONTROLLED SUBSTANCE as defined

1 by law or of any vinous, malt, brewed, fermented, spirituous, or  
2 intoxicating liquors or any mixed liquors or beverages, any part  
3 of which is intoxicating, is ~~hereby~~ declared a nuisance, and  
4 the furniture, fixtures, and contents of ~~any such~~ THE building,  
5 vehicle, boat, aircraft, or place and all ~~such~~ intoxicating  
6 liquors therein are also declared a nuisance, and all ~~such nar-~~  
7 ~~cotic and/or hypnotic drugs~~ CONTROLLED SUBSTANCES and nuisances  
8 shall be enjoined and abated as ~~hereinafter~~ provided ~~—~~ IN  
9 THIS ACT and as provided in the court rules. Any person ~~—~~ or  
10 his OR HER servant, agent, or employee who ~~shall own, lease,~~  
11 ~~conduct or maintain~~ OWNS, LEASES, CONDUCTS, OR MAINTAINS any  
12 building, vehicle, or place used for any of the purposes ~~or by~~  
13 ~~any of the persons above set forth or where any of the acts above~~  
14 ~~enumerated are conducted, permitted or carried on,~~ OR ACTS SET  
15 FORTH IN THIS SECTION is guilty of a nuisance.
