## **HOUSE BILL No. 4527**

April 15, 1987, Introduced by Reps. Van Singel, Weeks, Allen, DeMars, Kosteva, Stacey, Gnodtke, Bender, Niederstadt and Dunaskiss and referred to the Committee on Towns and Counties.

A bill to amend section 2 of Act No. 285 of the Public Acts of 1931, entitled as amended

"An act to provide for city, village and municipal planning; the creation, organization, powers and duties of planning commissions; the regulation and subdivision of land; and to provide penalties for violation of the provisions of this act,"

being section 125.32 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2 of Act No. 285 of the Public Acts of
- 2 1931, being section 125.32 of the Michigan Compiled Laws, is
