- (2) The fee for a certificate of need shall be \$691.00 for leach application for a project requiring a projected capital expenditure of \$150,000.00 or less and \$1,621.00 for a project requiring a projected capital expenditure of more than \$150,000.00.
- (3) With the exception of health maintenance organizations,
 When licensure is for more than 1 year, the fees described in
 subsection (1) shall be multiplied by the number of years for
 which the license is issued, and the total amount of the fees
 shall be collected in the year in which the license is issued.
- (4) Fees described in this section shall be payable to the department at the time an application for a license, permit, or certificate is submitted. If an application for a license, permit, or certificate is denied or if a license, permit, or certificate is denied or if a license, permit, or certificate is revoked before its expiration date, the fees paid to the department shall not be refunded.
