

HOUSE BILL No. 5466

March 8, 1988, Introduced by Rep. Jacobetti and referred to the Committee on Appropriations.

A bill to make appropriations for certain purposes relating to education for the fiscal year ending September 30, 1989; and to provide for the expenditure of the appropriations.

1 (a) "EIC" means educational instructions centers.

2 (b) "LSCA" means the library services and construction act,
3 20 U.S.C. 351 to 364.

4 (c) "NFAH" means the national foundation on the arts and
5 humanities.

6 Sec. 5. The amounts appropriated shall be paid out of the state
7 treasury at the times and in the manner provided by law.

8 Sec. 6. The library of Michigan shall be under the direction of the
9 legislative council pursuant to Act No. 540 of the Public Acts of 1982,
10 being sections 397.11 to 397.24 of the Michigan Compiled Laws.
