## **SENATE BILL No. 16**

January 27, 1987, Introduced by Senator FESSLER and referred to the Committee on State Affairs, Tourism, and Transportation.

A bill to amend section 475 of Act No. 281 of the Public Acts of 1967, entitled

"Income tax act of 1967,"

as amended by Act No. 211 of the Public Acts of 1982, being section 206.475 of the Michigan Compiled Laws; and to add section 438.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 475 of Act No. 281 of the Public Acts of
- 2 1967, as amended by Act No. 211 of the Public Acts of 1982, being
- 3 section 206.475 of the Michigan Compiled Laws, is amended and
- 4 section 438 is added to read as follows:
- 5 SEC. 438. EFFECTIVE FOR TAX YEARS BEGINNING AFTER DECEMBER
- 6 31, 1986, A TAXPAYER WHO IS ENTITLED TO A TAX REFUND UNDER THIS
- 7 ACT, SUFFICIENT TO MAKE A DESIGNATION UNDER THIS SECTION, MAY
- 8 DESIGNATE THAT \$2.00 OR MORE OF THE TAXPAYER'S REFUND BE CREDITED

- 1 TO THE HISTORIC PRESERVATION AND DEVELOPMENT FUND CREATED IN
- 2 SECTION 3 OF ACT NO. 10 OF THE PUBLIC ACTS OF 1955, BEING SECTION

- 12 (2) Each year that the refund designation -program PROGRAMS

- 15 -section 440 EACH OF THOSE SECTIONS, less the annual amount
- 16 appropriated to the department of treasury for the purpose of

- 18 UNDER SECTIONS 438 AND 440 and THE EXPENDITURES INCURRED IN

- 1 (3) All remittances of taxes imposed by this act shall be
- 2 made to the department by bank draft, check, cashier's check,
- 3 money order, certificate of deposit, or money. No remittance
- 4 other than cash is a final discharge of liability for the tax
- 5 herein levied BY THIS ACT unless and until it has been paid in
- 6 cash.
- 7 Section 2. This amendatory act shall not take effect unless
- 8 Senate Bill No.  $\frac{7}{7}$  of the 84th
- 9 Legislature is enacted into law.
