

# SENATE BILL No. 111

March 10, 1987, Introduced by Senators NICHOLS, CROPSEY, WELBORN, GEAKE, BINSFELD and GAST and referred to the Committee on Human Resources and Senior Citizens.

A bill to amend section 6 of Act No. 388 of the Public Acts of 1913, entitled as amended

"An act to provide for state insurance on state property and against liability arising or that may arise under certain laws,"

being section 550.706 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Section 6 of Act No. 388 of the Public Acts of  
2 1913, being section 550.706 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4       Sec. 6. ~~Upon July 1, 1951, and annually thereafter, the~~  
5 ~~state accident fund shall determine in such detail as the state~~  
6 ~~controller may require the premium or assessment necessary to pay~~  
7 ~~all benefits accruing under Act No. 10 of the First Extra Session~~  
8 ~~of 1912, as amended, to persons in the service of the state,~~  
9 ~~which shall be transmitted to the controller, who shall then~~

~~1 order the state treasurer to credit to the "state accident fund"~~  
~~2 created by the above mentioned act the total amount so~~  
~~3 determined. The controller~~ THE DIRECTOR OF THE DEPARTMENT OF  
 4 MANAGEMENT AND BUDGET SHALL PROVIDE FOR WORKER'S DISABILITY COM-  
 5 PENSATION BENEFITS FOR EMPLOYEES OF THE STATE BY 1 OF THE METHODS  
 6 UNDER SECTION 611 OF THE WORKER'S DISABILITY COMPENSATION ACT OF  
 7 1969, ACT NO. 317 OF THE PUBLIC ACTS OF 1969, BEING SECTION  
 8 418.611 OF THE MICHIGAN COMPILED LAWS. THE DIRECTOR OF THE  
 9 DEPARTMENT OF MANAGEMENT AND BUDGET shall charge the amounts ~~so~~  
 10 ~~determined~~ EXPENDED FOR THE PURPOSE OF PROVIDING WORKER'S DIS-  
 11 ABILITY COMPENSATION BENEFITS to the appropriations made for this  
 12 purpose. ~~and for the purposes of this act the state shall be~~  
 13 ~~entitled to all of the benefits and subject to all of the liabil-~~  
 14 ~~ities of an individual employer who has availed himself of the~~  
 15 ~~provisions of part 5 of Act No. 10 of the First Extra Session of~~  
 16 ~~1912, as amended.~~ Any credits that may be due the state under  
 17 ~~such act~~ THE METHOD SELECTED UNDER SECTION 611 OF ACT NO. 317  
 18 OF THE PUBLIC ACTS OF 1969, shall be credited to the respective  
 19 funds or accounts contributing FINANCING to the ~~accident fund~~  
 20 METHOD SELECTED.

21 Section 2. This amendatory act shall not take effect unless

 23 Legislature is enacted into law.
