SUMMARY OF SENATE BILLS 402 through 417 as introduced 5-3-89:

The bills would amend various Acts to delete references to, or repeal sections of law that pertain to, justices of the peace.

Senate Bill 402 would amend Public Acts 211 of 1893 and 110 of 1909. Senate Bill 403 would amend Public Act 78 of 1917. Senate Bill 404 would amend Public Act 44 of 1899. Senate Bill 405 would amend Public Act 237 of 1879. Senate Bill 406 would amend Public Act 3 of 1895, Public Act 5 of the Extra Session of 1870, Public Act 272 of 1909, Public Act 352 of 1925, and Public Act 192 of 1929. Senate Bill 407 would amend Public Act 244 of 1881. Senate Bill 408 would amend Public Acts 215 of 1895 and 76 of 1917. Senate Bill 409 would amend the Insurance Code. Senate Bill 410 would amend Chapter 84 of the Revised Statutes of 1846. Senate Bill 411 would amend Public Act 229 of 1887, Public Act 263 of 1861, Chapter 126 of the Revised Statutes of 1846, Public Act 116 of 1911, and Public Act 160 of 1897. Senate Bill 412 would repeal a section of Public Act 279 of 1909. Senate Bill 413 would amend Chapter 65 of the Revised Statutes of 1846. Senate Bill 414 would amend Public Act 248 of 1879. Senate Bill 415 would amend Public Acts 68 of 1913 and 198 of 1873. Senate Bill 416 would repeal 21 sections of the Revised Judicature Act. Senate Bill 417 would amend the Michigan Penal Code and Chapter 158 of the Revised Statutes of 1846.
