- 25 BREASTS, USING EQUIPMENT DESIGNED AND DEDICATED SPECIFICALLY FOR
- 26 MAMMOGRAPHY, IN ORDER TO DETECT UNSUSPECTED BREAST CANCER.

- 1 (D) "BREAST CANCER TREATMENT SERVICES" MEANS A PROCEDURE
- 2 INTENDED TO TREAT CANCER OF THE HUMAN BREAST, DELIVERED ON AN
- 3 INPATIENT OR OUTPATIENT BASIS, INCLUDING BUT NOT LIMITED TO, SUR-
- 4 GERY, RADIATION THERAPY, CHEMOTHERAPY, HORMONAL THERAPY, AND
- 5 RELATED MEDICAL FOLLOW-UP SERVICES.
- 6 (E) "SERVICE-SPECIFIC CERTIFICATE" MEANS A GROUP OR NONGROUP
- 7 CERTIFICATE PROVIDING COVERAGE SOLELY FOR 1 OF THE FOLLOWING:
- 8 DENTAL CARE, HEARING CARE, VISION CARE, PRESCRIPTION DRUGS, OR
- 9 ANOTHER TYPE OF HEALTH CARE BENEFIT.
