- 4 population of 100,000 or more BUT LESS THAN 1,500,000, the fol-
- 5 lowing fees shall be paid to the clerk of the court:

- 2 Failure to pay the fee within the time provided in the court
- 3 rules constitutes a waiver of the right to a jury trial. The sum
- 4 shall be taxed in favor of the party paying the fee, -in case IF
- 5 the party recovers a judgment for costs.
- 6 (d) Before entry of a final judgment by default in pleading
- 7 in an action without a jury or by consent without trial, -or the
- 8 entry of a judgment against a garnishee defendant upon a district
- 9 or municipal court transcript, or the entry of a judgment on an

- 11 the entry of judgment, the sum of \$10.00.
- (e) Before entry of a final judgment in an action where
- 13 trial has been had, or where a jury is called to render a verdict
- 14 upon default in pleading, the sum of \$10.00.
- (f) In addition to the judgment fee provided in subdivision
- 16 (d) or (e), before entry of a final judgment in an action for
- 17 divorce or separate maintenance where minor children are
- 18 involved, or the entry of a final judgment in a child custody
- 19 dispute submitted to the circuit court as an original action, 1
- 20 of the following sums, which shall be deposited by the county
- 21 treasurer as provided in section 2530:
- 22 (i) If the matter was contested or uncontested and was not
- 23 submitted to domestic relations mediation or investigation by the
- 24 friend of the court, \$30.00.

- 9 (C) FOR EACH TRIAL WITHOUT A JURY, THE PLAINTIFF SHALL PAY
- 10 THE SUM OF \$15.00. IF A TRIAL BY JURY IS DEMANDED, THE PARTY
- 11 MAKING THE DEMAND AT THE TIME SHALL PAY THE SUM OF \$30.00.
- 12 FAILURE TO PAY THE FEE WITHIN THE TIME PROVIDED IN THE COURT
- 13 RULES CONSTITUTES A WAIVER OF THE RIGHT TO A JURY TRIAL. THE SUM
- 14 SHALL BE TAXED IN FAVOR OF THE PARTY PAYING THE FEE, IF THE PARTY
- 15 RECOVERS A JUDGMENT FOR COSTS.
- (D) BEFORE ENTRY OF A FINAL JUDGMENT BY DEFAULT IN PLEADING
- 17 IN AN ACTION WITHOUT A JURY OR BY CONSENT WITHOUT TRIAL, THE
- 18 ENTRY OF A JUDGMENT AGAINST A GARNISHEE DEFENDANT UPON A DISTRICT
- 19 OR MUNICIPAL COURT TRANSCRIPT, OR THE ENTRY OF A JUDGMENT ON AN
- 20 AWARD FROM A BOARD OR REFEREE UPON WHOSE AWARD THE LAW PERMITS
- 21 THE ENTRY OF JUDGMENT, THE SUM OF \$10.00.
- 22 (E) BEFORE ENTRY OF A FINAL JUDGMENT IN AN ACTION WHERE
- 23 TRIAL HAS BEEN HAD, OR WHERE A JURY IS CALLED TO RENDER A VERDICT
- 24 UPON DEFAULT IN PLEADING, THE SUM OF \$10.00.
- 25 (F) IN ADDITION TO THE JUDGMENT FEE PROVIDED IN SUBDIVISION
- 26 (D) OR (E), BEFORE ENTRY OF A FINAL JUDGMENT IN AN ACTION FOR
- 27 DIVORCE OR SEPARATE MAINTENANCE WHERE MINOR CHILDREN ARE

- 1 INVOLVED, OR THE ENTRY OF A FINAL JUDGMENT IN A CHILD CUSTODY
- 2 DISPUTE SUBMITTED TO THE CIRCUIT COURT AS AN ORIGINAL ACTION, 1
- 3 OF THE FOLLOWING SUMS, WHICH SHALL BE DEPOSITED BY THE COUNTY
- 4 TREASURER AS PROVIDED IN SECTION 2530:
- 5 (i) IF THE MATTER WAS CONTESTED OR UNCONTESTED AND WAS NOT
- 6 SUBMITTED TO DOMESTIC RELATIONS MEDIATION OR INVESTIGATION BY THE
- 7 FRIEND OF THE COURT, \$30.00.
- 8 (ii) IF THE MATTER WAS CONTESTED OR UNCONTESTED AND WAS SUB-
- 9 MITTED TO DOMESTIC RELATIONS MEDIATION, \$50.00.
- 10 (iii) IF THE MATTER WAS CONTESTED OR UNCONTESTED AND THE
- 11 OFFICE OF THE FRIEND OF THE COURT CONDUCTED AN INVESTIGATION AND
- 12 MADE A RECOMMENDATION TO THE COURT, \$70.00.
- (G) UPON THE FILING OF A MOTION, THE SUM OF \$10.00.
- 14 (H) IF CAUSES OF ACTION ARE CONSOLIDATED OR TRIED SIMULTA-
- 15 NEOUSLY AND SEPARATE JUDGMENTS RENDERED, THE SUM OF \$10.00 ON THE
- 16 ENTRY OF EACH JUDGMENT.
- 17 (I) FOR SERVICES RELATIVE TO THE RECEIPT, SAFEKEEPING, OR
- 18 PUTTING OUT OF MONEY, OR THE PURCHASING, TAKING, OR TRANSFERRING
- 19 OF A SECURITY, OR THE COLLECTING OF INTEREST ON A SECURITY, UNDER
- 20 THE DIRECTION OF THE COURT, NOT SPECIFICALLY PROVIDED IN THIS
- 21 SECTION, THE CLERK SHALL RECEIVE THE ALLOWANCE AND COMPENSATION,
- 22 FROM THE PARTIES AS THE COURT MAY CONSIDER JUST AND SHALL DIRECT

2 are taxable as costs.

- 6 (5) -(4) The court may order any of the fees prescribed in 7 this section waived or suspended until the conclusion of the 8 litigation, upon a showing by affidavit of indigency or inability 9 to pay.

- 9 shall appropriate the amount received under this subsection for
- 10 the purpose of fulfilling the statutory obligations of the friend
