- (C) "OFFICE" MEANS THE OFFICE OF MINORITY HEALTH CREATED IN 2 SECTION 2503.
- 3 SEC. 2503. THE OFFICE OF MINORITY HEALTH IS CREATED WITHIN
- 4 THE DEPARTMENT.
- 5 SEC. 2505. THE DIRECTOR SHALL APPOINT THE DIRECTOR OF THE
- 6 OFFICE. THE DIRECTOR OF THE OFFICE SHALL REPORT TO THE

- (I) PROVIDE INFORMATION ON PROGRAMS AVAILABLE TO PROMOTE

- 13 (J) EVALUATE THE EFFECT OF FEDERAL AND STATE STATUTES ON
- 14 MINORITY HEALTH AND RECOMMEND APPROPRIATE CHANGES TO THE DIREC-
- 15 TOR, THE GOVERNOR, AND THE LEGISLATURE.
- 16 (K) PROVIDE ADEQUATE AND EFFECTIVE OPPORTUNITIES FOR MINORI-

- 19 (1) OTHER ACTIVITIES RELATED TO MINORITY HEALTH AS ASSIGNED

- 21 SEC. 2509. (1) THE MINORITY HEALTH ADVISORY COMMITTEE IS
- 22 CREATED IN THE DEPARTMENT UNDER THE JURISDICTION OF THE PUBLIC

- 24 (2) THE MINORITY HEALTH ADVISORY COMMITTEE SHALL CONSIST OF

- 19 MITTEE MEETINGS PURSUANT TO SECTION 1216.
- 20 (6) THE MINORITY HEALTH ADVISORY COMMITTEE IS SUBJECT TO
- 21 SECTION 2215.
