A bill to establish a public service work-study employment program and a public service student volunteer program for certain students attending participating postsecondary schools; and to prescribe certain powers and duties of certain state agencies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "public service work-study act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Authority" means the Michigan higher education assist-
- 5 ance authority created by Act No. 77 of the Public Acts of 1960,
- 6 being sections 390.951 to 390.961 of the Michigan Compiled Laws.
- 7 (b) "PSWS" means the Michigan public service work-study
- 8 employment program established in section 3.

- 1 (c) "Public service employer" means a private nonprofit
- 2 agency or a public agency other than a college or university.
- 3 (d) "Public service employment" means employment with a
- 4 public service employer in work that is performed for the state
- 5 or community welfare rather than performed to benefit a particu-
- 6 lar interest or group and that is in 1 or more of the following
- 7 activities:
- 8 (i) Recycling or environmental preservation or protection.
- 9 (ii) Food banks, homeless shelters, or other poverty
- 10 programs.
- 11 (iii) Mental health services.
- 12 Sec. 3. (1) The Michigan public service work-study employ-
- 13 ment program is established to fund up to the full amount of an
- 14 eligible student's wages in part-time public service employment
- 15 and to enable eligible postsecondary schools to help eligible
- 16 students meet educational expenses by placement in that employ-
- 17 ment while attending an eligible postsecondary school.
- 18 (2) The public service student volunteer program is estab-
- 19 lished to provide reimbursement under section 11 for necessary
- 20 expenses incurred by eligible students who work on a volunteer
- 21 basis in activities that would be considered public service
- 22 employment if performed as an employee.
- Sec. 4. A recognized postsecondary school in this state is
- 24 eligible to participate in the PSWS program if the postsecondary
- 25 school is a degree-granting institution approved by the state
- 26 board of education, the instructional programs are not comprised
- 27 solely of sectarian instruction or religious worship, and the

- 1 school participates in the federal work-study program under title
- 2 IV of the higher education act of 1965, Public Law 89-329. A
- 3 participating school, at its option, may offer academic credit to
- 4 students enrolled in the PSWS program.
- 5 Sec. 5. (1) A student is eligible to participate in the
- 6 PSWS program if the student meets all of the following
- 7 requirements:
- 8 (a) Has resided in this state continuously for the 12 months
- 9 preceding his or her application to the PSWS program and is not
- 10 considered a resident of any other state.
- (b) Is not incarcerated in a corrections institute.
- (c) Is enrolled in at least a half-time undergraduate pro-
- 13 gram of study at an eligible postsecondary school or meets the
- 14 requirements of subsection (5).
- (d) Is a citizen or permanent resident of the United
- 16 States.
- (e) Is not in default on a loan guaranteed by the
- 18 authority.
- 19 (f) Is certified by the financial aid officer at the post-
- 20 secondary school as needing employment in order to meet recog-
- 21 nized educational expenses.
- 22 (2) A student is eligible to participate in the public serv-
- 23 ice student volunteer program if he or she meets the requirements
- 24 of subsection (1)(a) through (e) and also meets the requirements
- 25 set forth in section 11.
- 26 (3) A student shall maintain satisfactory academic progress,
- 27 as defined by the postsecondary school in which the student is

- 1 enrolled, to remain eligible to participate in the PSWS program
- 2 or public service student volunteer program under this act.
- 3 (4) A full-time undergraduate student is not eligible to
- 4 participate in the PSWS program or the public service student
- 5 volunteer program for more than 15 terms or its equivalent in
- 6 semesters at any particular school.
- 7 (5) If a student possessing a degree at a given academic
- 8 level enrolls for a second degree at the same or lower academic
- 9 level, the authority shall include PSWS grants received by the
- 10 student when enrolled for the previous degree at the same or
- 11 lower level in determining the student's eligibility under this
- 12 act.
- 13 (6) A student may participate in the PSWS program or public
- 14 service student volunteer program during a period when he or she
- 15 is not enrolled at an eligible postsecondary school if all of the
- 16 following conditions are met:
- 17 (a) The student is otherwise eligible under this section or
- 18 section 11.
- (b) The student was enrolled in at least a half-time under-
- 20 graduate program of study at an eligible postsecondary school for
- 21 the preceding quarter, term, or semester.
- (c) The financial aid officer at the postsecondary school
- 23 determines that the period during which the student is not
- 24 enrolled will not exceed 4 months and the student is enrolled or
- 25 signs a statement of intention to enroll in at least a half-time
- 26 undergraduate program of study at the postsecondary school for
- 27 the next succeeding quarter, term, or semester.

- 1 Sec. 6. A public service employer is eligible to employ
- 2 students through the PSWS program if the employer meets all of
- 3 the following requirements:
- 4 (a) Enters into a signed agreement with an eligible postsec-
- 5 ondary school to provide public service employment for students
- 6 recommended by the school.
- 7 (b) Employs PSWS students only for public service
- 8 employment.
- 9 (c) Does not use PSWS students to displace employed
- 10 workers.
- (d) Does not employ PSWS students to construct, operate, or
- 12 maintain a facility used, or to be used, solely for sectarian
- 13 instruction or as a place for religious worship; or for activity
- 14 espousing or promoting a partisan political position or
- 15 candidate.
- (e) Does not pay PSWS students a wage that is less than the
- 17 full federal minimum wage established for employees more than 19
- 18 years of age.
- 19 Sec. 7. The amount of the PSWS grant to be paid for each
- 20 semester, trimester, or quarter shall be determined by the
- 21 authority based upon an evaluation of the family's financial
- 22 resources. A uniform criteria of need, as defined by the author-
- 23 ity, shall be used in evaluating the family's financial
- 24 resources.
- 25 Sec. 8. A student who receives other student financial aid
- 26 in the form of scholarship or grant may be eligible for PSWS
- 27 funds under this act if the total amount of the student's

- 1 scholarships and grants is less than the student's remaining
- 2 financial need. The PSWS, in combination with other student
- 3 financial aid, shall not exceed the amount of the student's
- 4 financial need as determined by uniform criteria of need as
- 5 defined by the authority.
- 6 Sec. 9. A PSWS grant shall not exceed the amount of educa-
- 7 tional costs for the full academic year as reported by the post-
- 8 secondary school in which the student is enrolled. If there are
- 9 not sufficient appropriated funds for the PSWS program to provide
- 10 each student with the grant amount for which the student is eli-
- 11 gible, the authority shall establish a maximum grant level for
- 12 that academic year.
- 13 Sec. 10. PSWS program funds shall be used only to pay up to
- 14 100% of student wages. PSWS program funds shall not be used for
- 15 the administrative costs of implementing or operating the post-
- 16 secondary school's PSWS program.
- 17 Sec. 11. (1) The authority shall administer the public
- 18 service student volunteer program in cooperation with other
- 19 appropriate public and private agencies.
- 20 (2) The authority shall reimburse an eligible student for
- 21 transportation, equipment, uniform, food, and other necessary
- 22 expenses incurred in providing services for a public service
- 23 employer if all of the following conditions are met:
- 24 (a) The student does not receive or expect to receive pay-
- 25 ment of wages for providing the services.
- 26 (b) The student voluntarily performs the services.

- 1 (c) The services performed would be considered public
- 2 service employment if performed as an employee.
- 3 (d) The public service employer certifies to the authority
- 4 that the student has performed the services and that the expenses
- 5 subject to reimbursement were necessarily incurred by the student
- 6 in providing the services.
- 7 (3) The amount of expenses reimbursed under this section
- 8 shall not exceed \$1,500.00 per academic year for each participat-
- 9 ing student, and the authority may establish a lower maximum
- 10 amount for an academic year if the authority determines that a
- 11 lower maximum amount is necessary because of the amount of funds
- 12 appropriated for the public service student volunteer program for
- 13 that academic year.
- 14 Sec. 12. The authority shall promulgate rules to implement
- 15 this act pursuant to the administrative procedures act of 1969,
- 16 Act No. 306 of the Public Acts of 1969, being sections 24.201 to
- 17 24.328 of the Michigan Compiled Laws.
