## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 641 of the Public Acts of 1978, as

  - 5 SEC. 19C. (1) AS A CONDITION OF MAINTAINING AN OPERATING
- 6 LICENSE UNDER THIS ACT, AN OWNER OR OPERATOR OF A LANDFILL SHALL
- 7 PAY TO THE DEPARTMENT QUARTERLY BY THE THIRTIETH DAY AFTER THE
- 8 END OF EACH CALENDAR QUARTER A SOLID WASTE PROTECTION FEE. THE
- 9 SOLID WASTE PROTECTION FEE SHALL BE 50 CENTS PER TON OR 20 CENTS
