## **HOUSE BILL No. 5570**

March 6, 1990, Introduced by Reps. Knight, Keith, O'Neill, Gilmer, Johnson and Trim and referred to the Committee on Education.

A bill to amend the title and section 1536 of Act No. 451 of the Public Acts of 1976, entitled as amended "The school code of 1976,"

section 1536 as added by Act No. 163 of the Public Acts of 1986, being section 380.1536 of the Michigan Compiled Laws; and to add sections 1531a and 1536a.
