THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 12901 of Act No. 368 of the Public Acts
- 2 of 1978, as amended by Act No. 209 of the Public Acts of 1988,
- 3 being section 333.12901 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 12901. (1) As used in this part:
- 6 (a) "Bed and breakfast" means a private residence that
- 7 offers sleeping accommodations to transient tenants in 14 or
- 8 fewer rooms for rent, is the innkeeper's residence in which the
- 9 innkeeper resides while renting the rooms to transient tenants,

- 1 serves breakfasts at no extra cost to its transient tenants, and
- 2 has a smoke detector in proper working order in every sleeping
- 3 room and a fire extinguisher in proper working order on every
- 4 floor.
- 5 (b) "Continental breakfast" means the serving of only nonpo-
- 6 tentially hazardous food, such as a roll, pastry or doughnut,
- 7 fruit juice, hot beverage, or individual portions of milk, and
- 8 items incidental to such foods.
- 9 (c) "Food service establishment" means a fixed or mobile
- 10 restaurant, coffee shop, cafeteria, short order cafe, luncheon-
- 11 ette, grill, tearoom, sandwich shop, soda fountain, tavern, bar,
- 12 cocktail lounge, nightclub, drive-in, industrial feeding estab-
- 13 lishment, private organization serving the public, rental hall,
- 14 catering kitchen, delicatessen, theater, commissary, or similar
- 15 place in which food or drink is prepared for direct consumption
- 16 through service on the premises or elsewhere, and any other
- 17 eating or drinking establishment or operation where food is
- 18 served or provided for the public. Food service establishment
- 19 does not apply to any of the following:
- 20 (i) An inpatient food service operation located in a health
- 21 facility or agency subject to licensure under article 17.
- 22 (ii) Unless the establishment is carrying out operations
- 23 beyond the scope of its license, an establishment licensed and
- 24 inspected under any of the following acts:

- 8 (iii) A motel that serves continental breakfasts only.
- 9 (iv) A food concession at a state or county fair.
- 10 (v) A charitable, religious, fraternal, or other nonprofit
- 11 organization operating a home-prepared baked goods sale or serv-
- 12 ing only home-prepared food in connection with its meetings or as
- 13 part of a fund-raising event.
- 14 (vi) A CHARITABLE, RELIGIOUS, FRATERNAL, OR OTHER NONPROFIT
- 15 ORGANIZATION THAT SERVES OR PROVIDES FOOD FREE OF CHARGE TO PER-
- 16 SONS WHO ARE NOT MEMBERS OF THE GENERAL PUBLIC AND WHO MEET SPE-
- 17 CIFIC ENTRY CRITERIA FOR THE FUNCTION AT WHICH THE FOOD IS SERVED
- 18 OR PROVIDED.
- 19 (vii) $\overline{(vi)}$ A food establishment that is licensed and
- 20 inspected under the food processing act of 1977, Act No. 328 of
- 21 the Public Acts of 1978, being sections 289.801 to 289.810 of the
- 22 Michigan Compiled Laws, even if the food establishment sells for
- 23 consumption off the premises, in a volume incidental to the total
- 24 volume of the food establishment, any of the following:
- 25 (A) Prepackaged food that is offered for sale in individual
- 26 portions that do not require preparation in the food
- 27 establishment except for temperature modification. As used in

- 1 this subparagraph, "prepackaged food" means food that is prepared
- 2 and packaged either at a facility inspected and approved by the
- 3 United States department of agriculture or a facility that is
- 4 licensed as a food processor under the food processing act of
- 5 1977, Act No. 328 of the Public Acts of 1978.
- 6 (B) Food that is prepared at the food establishment, dis-
- 7 played in bulk form for sale, and sold in quantities other than
- 8 individual portions.
- 9 (C) Beverages, including, but not limited to, hot chocolate,
- 10 coffee, tea, slush, and soda pop.
- (D) Hand dipped ice cream.
- 12 (E) Rotisserie prepared hot dogs.
- (F) Other foods as determined by the director or his or her
- 14 representative, in conjunction with the director of the depart-
- 15 ment of agriculture or his or her representative.
- 16 (viii) -(vii) A bakery that is licensed and inspected under
- 17 the food processing act of 1977, Act No. 328 of the Public Acts
- 18 of 1978, even if the bakery sells hot or cold beverages or tem-
- 19 perature modified bakery products, in a volume incidental to the
- 20 total volume of business of the bakery.
- 21 (ix) $\frac{(viii)}{}$ An establishment otherwise within the scope of
- 22 this act which is licensed and inspected by the department of
- 23 agriculture, if the manner of licensing and inspection is mutu-
- 24 ally agreed upon by the director and the director of the depart-
- 25 ment of agriculture or their designated representatives.

- 1 (x) -(ix) A bed and breakfast that has 8 or fewer sleeping
- 2 rooms, including sleeping rooms occupied by the innkeeper, 1 or
- 3 more of which are available for rent to transient tenants.
- 4 (xi) -(x) A bed and breakfast that has at least 9 but fewer
- 5 than 15 rooms for rent, if the bed and breakfast serves continen-
- 6 tal breakfasts only.
- 7 (xii) $\overline{(xi)}$ A temporary food service establishment using
- 8 only single service articles and serving only food or beverages
- 9 that do not come within the definition of potentially hazardous
- 10 food or beverage. As used in this subparagraph, "potentially
- 11 hazardous food or beverage" means any food that consists in whole
- 12 or in part of milk or milk products, eggs, meat, poultry, fish,
- 13 shellfish, edible crustacea, or other ingredients, including syn-
- 14 thetic ingredients, in a form capable of supporting rapid and
- 15 progressive growth of infectious or toxigenic microorganisms.
- 16 The term does not include clean, whole, uncracked, odor-free
- 17 shell eggs or foods which have a pH level of 4.6 or below or a
- 18 water activity (aw) value of 0.85 or less.
- (d) "Transient tenant" means a person who rents a room in a
- 20 bed and breakfast for fewer than 30 consecutive days.
- 21 (e) "Person" means a person as defined in section 1106 or a
- 22 governmental entity.
- 23 (f) "Temporary food service establishment" means a food
- 24 service establishment which operates at a fixed location for a
- 25 temporary period of time not to exceed 2 weeks.
- 26 (g) "Transitory food unit" means a food service
- 27 establishment that operates from and is regularly transported by

- 1 a motor vehicle, and which does not regularly return to a fixed
- 2 food service establishment licensed by the department for servic-
- 3 ing and maintenance.
- 4 (h) "Vending machine" means a self-service device offered
- 5 for public use which, upon insertion of a coin or token, or by
- 6 other similar means, dispenses unit servings of food or beverages
- 7 without the necessity of replenishing the device between each
- 8 vending operation. The term does not mean a device which dis-
- 9 penses only bottled or canned soft drinks; other packaged nonper-
- 10 ishable foods or beverages; or bulk ball gum, nuts, and panned
- 11 candies.
- (i) "Vending machine location" means the room, enclosure,
- 13 space, or area where 1 or more vending machines are installed and
- 14 operated.
- 15 (2) In addition, article 1 contains general definitions and
- 16 principles of construction applicable to all articles in this
- 17 code.
