A bill to prescribe the powers and duties of certain state agencies and departments; and to provide for the promulgation of rules.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as "the
- 2 intergenerational day care center act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Department" means the department of commerce.
- (b) "Intergenerational day care center" means a child care
- 6 center or day care center as defined in section 1 of Act No. 116
- 7 of the Public Acts of 1973, being section 722.111 of the Michigan
- 8 Compiled Laws, that employs or uses older persons as child care
- 9 workers or volunteers or that is located in a senior center or
- 10 nursing home.

- (c) "Nursing home" means that term as defined in section
- 2 20109 of the public health code, Act No. 368 of the Public Acts
- 3 of 1978, being section 333.20109 of the Michigan Compiled Laws.
- 4 (d) "Office" means the office of services to the aging cre-
- 5 ated in section 5 of the older Michiganians act, Act No. 180 of
- 6 the Public Acts of 1981, being section 400.585 of the Michigan

- 8 (e) "Older person" means a state resident who is 60 years of 9 age or older.
