

# HOUSE BILL No. 5584

March 12, 1990, Introduced by Reps. Hoffman, Bartnik, Martin, DeMars, Clack, Middaugh, Walberg, Strand, Nye and Law and referred to the Committee on Senior Citizens and Retirement.

A bill to amend section 46 of Act No. 240 of the Public Acts of 1943, entitled as amended

"State employees' retirement act,"

being section 38.46 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 46 of Act No. 240 of the Public Acts of  
2 1943, being section 38.46 of the Michigan Compiled Laws, is  
3 amended to read as follows:

4 Sec. 46. (1) A supplemental member may retire with a sup-  
5 plemental early retirement allowance provided in section 47 upon  
6 satisfaction of ~~each~~ ALL of the following conditions:

7 (a) ~~He is age 51 years or older but~~ THE SUPPLEMENTAL  
8 MEMBER IS less than age 62 years.

9 (b) ~~He~~ THE SUPPLEMENTAL MEMBER has 25 or more years of  
10 covered service.

1 (c) ~~His~~ THE SUPPLEMENTAL MEMBER'S last 3 years of credited  
2 service are covered service.

3 (d) ~~He~~ THE SUPPLEMENTAL MEMBER files a written request for  
4 retirement with the retirement board stating the date that he OR  
5 SHE wishes to be retired, which shall not be less than 30 days or  
6 more than 90 days after the date ~~his~~ THE application is filed.

7 (2) A supplemental member may be separated from employment  
8 in a covered position the first day of the calendar month follow-  
9 ing the month in which ~~he~~ THE SUPPLEMENTAL MEMBER attains age  
10 56 years. A supplemental member ~~so~~ separated FROM EMPLOYMENT  
11 UNDER THIS SUBSECTION may retire with a supplemental early  
12 retirement allowance provided in section 47 if ~~he~~ THE SUPPLE-  
13 MENTAL MEMBER satisfies ~~each~~ ALL of the following conditions:

14 (a) ~~He has not attained~~ THE SUPPLEMENTAL MEMBER IS LESS  
15 THAN age 62 years.

16 (b) ~~He~~ THE SUPPLEMENTAL MEMBER has 10 or more years of  
17 covered service.

18 (c) ~~His~~ THE SUPPLEMENTAL MEMBER'S last 3 years of credited  
19 service are covered service.

20 (d) ~~He~~ THE SUPPLEMENTAL MEMBER files a written request for  
21 retirement with the retirement board stating the date that he OR  
22 SHE wishes to be retired, which shall not be less than 30 days or  
23 more than 90 days after the date ~~his~~ THE application is filed.

24 (3) The state personnel director shall determine all ques-  
25 tions on eligibility for supplemental early retirement benefits  
26 within the meaning of sections 45 to 47.
