## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 280 of the Public Acts of 1939, as

- 3 Laws, is amended by adding section 60b to read as follows:
- 4 SEC. 60B. (1) AS USED IN THIS SECTION:
- 5 (A) "OVERPAYMENT" MEANS A PAYMENT OF PUBLIC ASSISTANCE MADE
- 6 TO A PUBLIC ASSISTANCE RECIPIENT IN EXCESS OF THAT TO WHICH HE OR
- 7 SHE IS ENTITLED, OR A PAYMENT MADE TO A PERSON WHO, AT THE TIME
- 8 THE PAYMENT WAS MADE, WAS INELIGIBLE UNDER THIS ACT TO RECEIVE
- 9 THAT PUBLIC ASSISTANCE.

- 1 (B) "PUBLIC ASSISTANCE RECIPIENT" MEANS A PERSON RECEIVING
- 2 ASSISTANCE UNDER THIS ACT.
- (2) THE STATE DEPARTMENT SHALL TAKE ALL NECESSARY STEPS TO 3
- 4 RECOVER AN OVERPAYMENT MADE TO A PUBLIC ASSISTANCE RECIPIENT.
- 5 PROCEDURES FOR THE RECOVERY OF OVERPAYMENTS MADE UNDER FEDERALLY

- (4) IN THE CASE OF AN INDIVIDUAL WHO IS NO LONGER A PUBLIC
- 16 ASSISTANCE RECIPIENT, THE STATE DEPARTMENT MAY WAIVE RECOVERY OF
- 17 AN OVERPAYMENT IF THE COST OF RECOVERY IS EQUAL TO OR GREATER
- 18 THAN THE AMOUNT OF THE OVERPAYMENT. THE COST OF RECOVERY SHALL
- 19 BE DETERMINED BY THE STATE DEPARTMENT IN ACCORDANCE WITH FEDERAL

- 21 IS THE RESULT OF FRAUD ON THE PART OF THE PUBLIC ASSISTANCE
