- TIME OF PAYMENT OF CLAIMS: Indemnities payable under this

- 8 of due written proof of such loss. Subject to due written proof
- 9 of loss, all accrued indemnities for loss for which this policy
- 10 provides periodic payment will be paid ..............

- 2 monthly) and any balance remaining unpaid upon the termination of
- 3 liability will be paid immediately upon receipt of due written

- 5 (2) ALL CLAIMS AND INDEMNITIES PAYABLE UNDER THE TERMS OF A
- 6 HOSPITAL, MEDICAL, OR SURGICAL EXPENSE-INCURRED POLICY SHALL BE
- 7 PAID WITHIN 42 DAYS FOLLOWING RECEIPT BY THE INSURER OF DUE PROOF
- 8 OF LOSS. FAILURE TO PAY WITHIN THIS 42-DAY PERIOD SHALL ENTITLE
- 9 THE INSURED TO INTEREST AT THE RATE OF 9% PER ANNUM FROM THE
- 10 FORTY-SECOND DAY AFTER RECEIPT OF THE PROOF OF LOSS TO THE DATE
- 11 OF LATE PAYMENT. INTEREST AMOUNTING TO LESS THAN \$1.00 NEED NOT
- 12 BE PAID. THIS SUBSECTION APPLIES TO A HOSPITAL, MEDICAL, OR SUR-
- 13 GICAL EXPENSE-INCURRED POLICY DELIVERED, ISSUED FOR DELIVERY,
- 14 RENEWED, OR AMENDED IN THIS STATE 180 DAYS AFTER THE EFFECTIVE
- 15 DATE OF THE AMENDATORY ACT THAT ADDED THIS SUBSECTION.
