- 3 (2) A EXCEPT AS PROVIDED IN SUBSECTION (4), A health care
- 4 corporation shall specify in writing the materials which consti-
- 5 tute a satisfactory claim form not later than 30 days after
- 6 receipt of a claim, unless the claim is settled within 30 days.
- 7 If a claim form is not supplied as to the entire claim, the
- 8 amount supported by the claim form shall be considered to be paid
- 9 on a timely basis if paid within 60 days after receipt of the
- 10 claim form by the corporation.
- 11 (3) A HEALTH CARE CORPORATION SHALL PAY TO A MEMBER OR A

- 25 (4) A HEALTH CARE CORPORATION SHALL SPECIFY IN WRITING THE
- 26 MATERIALS THAT CONSTITUTE A SATISFACTORY CLAIM FORM NOT LATER
- 27 THAN 10 DAYS AFTER RECEIPT OF A CLAIM, UNLESS THE CLAIM IS

- 1 SETTLED WITHIN 10 DAYS. IF A CLAIM FORM IS NOT SUPPLIED AS TO
- 2 THE ENTIRE CLAIM, THE AMOUNT SUPPORTED BY THE CLAIM FORM SHALL BE
- 3 CONSIDERED TO BE PAID ON A TIMELY BASIS IF PAID WITHIN 42 DAYS
- 4 AFTER RECEIPT OF THE CLAIM FORM BY THE CORPORATION. THIS SUBSEC-
- 5 TION APPLIES TO ALL GROUP AND NONGROUP CERTIFICATES DELIVERED,
- 6 ISSUED FOR DELIVERY, RENEWED, OR AMENDED IN THIS STATE 180 DAYS
- 7 AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS
- 8 SUBSECTION.
