- 1 PURPOSE OF THE CORPORATION SHALL BE TO ESTABLISH AND OPERATE A

- 14 PRACTICING IN A COUNTY WITH A POPULATION OF NOT MORE THAN
- 15 100,000.
- 16 (D) THE MICHIGAN HOSPITAL ASSOCIATION OR ITS SUCCESSOR. THE
- 17 REPRESENTATIVE SELECTED UNDER THIS SUBDIVISION SHALL BE FROM A
- 18 HOSPITAL IN A COUNTY WITH A POPULATION OF NOT MORE THAN 100,000.
- 19 (E) THE MICHIGAN PRIMARY CARE ASSOCIATION OR ITS SUCCESSOR.
