- 7 TRATION NUMBERS AND SHALL HAVE THE WORDS "FIRE FIGHTER" INSCRIBED
- 8 BENEATH THE REGISTRATION NUMBERS.

- 1 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 2 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE

- 1 A \$5.00 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO
- 2 FURNISH THE PROOF REQUIRED UNDER SUBSECTION (2).
