 to this act to receive required statements and reports.
- 3 (4) "Fund-raising event" means an event such as a dinner,

- 6 of a ticket, payment of an attendance fee, donations, or
- 7 PURCHASE OF chances for prizes, or -through purchase of goods or

- 19 OR HIS OR HER IMMEDIATE FAMILY AND STAFF.
- 20 SEC. 50. AN ELECTED OR APPOINTED PUBLIC OFFICIAL SHALL NOT
- 21 ACCEPT AN HONORARIUM. A PERSON WHO VIOLATES THIS SECTION IS
- 22 GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN
