

# HOUSE BILL No. 5913

June 21, 1990, Introduced by Reps. Stacey, Gubow, Bandstra, Saunders, Fitzgerald, Stupak, Law, Niederstadt, Berman, Scott and Leland and referred to the Committee on Public Health.

A bill to amend sections 59, 61, 63, 65, 67, 68, 69, 71, 73, 74, and 75 of Act No. 152 of the Public Acts of 1979, entitled as amended
