- 1 (A) A PRIMARY WATER SUPPLY AQUIFER.

- 27 THE AVERAGE AMOUNT OF RAINFALL RECEIVED BY THE AREA PER DAY

- 1 EQUALS THE AVERAGE AMOUNT OF GROUNDWATER PUMPED FROM THE WELL PER
- 2 DAY. AS USED IN THIS SUBPARAGRAPH, AVERAGES SHALL BE CALCULATED
- 3 ON AN ANNUAL BASIS.
