

HOUSE BILL No. 6086

September 25, 1990, Introduced by Rep. Hertel and referred to the Committee on State Affairs.

A bill to amend section 26 of Act No. 327 of the Public Acts of 1945, entitled as amended

"Aeronautics code of the state of Michigan,"

being section 259.26 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 26 of Act No. 327 of the Public Acts of
2 1945, being section 259.26 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 26. (1) ~~Creation of commission and department of~~
5 ~~aeronautics.~~ There is hereby created and established an aeronau-
6 tics commission to be known as the Michigan aeronautics
7 commission. ~~and a department of aeronautics to be known as the~~
8 ~~Michigan department of aeronautics.~~ The commission ~~to~~ SHALL
9 consist of the ~~highway commissioner, the commissioner of the~~
10 ~~Michigan~~ DIRECTOR OF THE STATE TRANSPORTATION DEPARTMENT, THE

1 DIRECTOR OF THE DEPARTMENT OF state police, the director of the
2 ~~conservation~~ department OF NATURAL RESOURCES, THE DIRECTOR OF
3 THE DEPARTMENT OF MILITARY AFFAIRS, together with ~~5~~ 9 other
4 members who shall be appointed by the governor subject to confir-
5 mation by the senate and who shall continue in office until their
6 successors are appointed. ~~The Michigan aeronautics commission,~~
7 ~~together with the director of aeronautics and all employees,~~
8 ~~shall constitute the Michigan department of aeronautics. The~~
9 ~~first appointed members of such commission shall be appointed: 2~~
10 ~~for a term of 2 years; 2 for a term of 3 years; and 1 for a term~~
11 ~~of 4 years; and thereafter~~ THE APPOINTED members shall be
12 appointed for TERMS OF 4 years.

13 (2) THE NEW MEMBERS TO BE APPOINTED PURSUANT TO THE 1989
14 AMENDATORY ACT THAT ADDED THIS SUBSECTION SHALL BE APPOINTED AS
15 FOLLOWS:

16 (A) TWO MEMBERS FOR TERMS TO EXPIRE ON MAY 27, 1990.

17 (B) ONE MEMBER FOR A TERM TO EXPIRE ON MAY 27, 1992.

18 (C) ONE MEMBER FOR A TERM TO EXPIRE ON MAY 27, 1993.

19 AFTER THE INITIAL TERMS, THESE MEMBERS SHALL BE APPOINTED FOR
20 TERMS OF 4 YEARS.
