## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 919 of Act No. 236 of the Public Acts of

- 13 SEC. 2925. (1) A PERSON WITH A CAUSE OF ACTION FOR INJURY
- 14 OR WRONGFUL DEATH RESULTING FROM A MASS DISASTER HAS THE RIGHT TO
- 15 REVOKE A SETTLEMENT AGREEMENT WITH THE TORTFEASOR FOR A PERIOD OF
- 16 60 DAYS FOLLOWING THE OCCURRENCE THAT GIVES RISE TO THE INJURY OR
- 17 WRONGFUL DEATH.
- 18 (2) REVOCATION OCCURS WHEN THE INJURED PERSON OR HIS OR HER
- 19 REPRESENTATIVE, OR THE PERSONAL REPRESENTATIVE OF A DECEASED
- 20 PERSON, MAILS OR DELIVERS A WRITTEN NOTICE OF REVOCATION TO THE
- 21 TORTFEASOR OR HIS OR HER ATTORNEY.
- 22 (3) IF MAILED TO THE TORTFEASOR OR HIS OR HER ATTORNEY, A
- 23 WRITTEN NOTICE OF REVOCATION IS GIVEN WHEN IT IS DEPOSITED IN A
- 24 MAILBOX PROPERLY ADDRESSED AND POSTAGE PREPAID.

- 26 AN OCCURRENCE THAT RESULTS IN THE INJURY OR DEATH OF 100 OR MORE
