HOUSE BILL No. 6277

November 14, 1990, Introduced by Reps. Ciaramitaro and Gire and referred to the Committee on State Affairs.

A bill to authorize the state administrative board to convey certain state owned property in Macomb county; to prescribe conditions for the conveyance; to provide for disposition of certain revenue; and to provide for certain duties of certain state officers.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey to the highest bidder, but for not less than
- 3 fair market value as determined pursuant to section 2, property
- 4 now under the jurisdiction of the department of mental health and
- 5 located at the Joseph Snyder Macomb-Oakland regional center, and
- 6 more specifically described as follows:
- 7 A parcel of land in the NE 1/4 of Section 7, T2N, R13E,
- 8 Clinton Township, Macomb County, Michigan and more specifically
- 9 described as commencing at the N. 1/4 corner of said Section 7;

- 14 Sec. 2. The fair market value of the property described in
- 15 section 1 shall be determined by an appraisal based on the
- 16 property's highest and best use, as prepared by the state tax
- 17 commission or an independent fee appraiser.
- 18 Sec. 3. The money received from the conveyance under this
- 19 act, and any money received by the Joseph Snyder Macomb-Oakland
- 20 regional center from rentals of land or facilities adjoining the
- 21 property described in section 1, shall be deposited by the state
- 22 treasurer in a restricted account and shall not lapse to the gen-
- 23 eral fund at the end of the fiscal year, but shall be appropri-
- 24 ated only to the department of mental health for community place-
- 25 ment of persons requiring mental health services in the area
- 26 served by the Joseph Snyder Macomb-Oakland regional center.

Sec. 4. The conveyance authorized by this act shall be by quitclaim deed approved by the attorney general and shall reserve to the state all rights to coal, oil, gas, and other minerals.
