# ENROLLED HOUSE BILL No. 4583

AN ACT to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 1992; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, and officers.

# The People of the State of Michigan enact:

Sec. 101. There is appropriated for the state institutions of higher education and certain state purposes related to education, and subject to the conditions set forth in this act, for the fiscal year ending September 30, 1992, the following respective amounts:

# **GENERAL SECTIONS**

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending in this appropriation act is \$1,300,547,520.00. There are no state appropriations to be paid to local units of government in section 101.

Sec. 202. (1) For institutions with fiscal years ending June 30, 1992, the sums appropriated in this act are appropriated for their fiscal years ending June 30, 1992 and shall be paid out of the state treasury and distributed by the state treasurer to the respective institutions in 9 monthly installments for the period October 1, 1991 to June 30, 1992. For an institution with a fiscal year ending September 30, 1992, the sums appropriated in this act are appropriated for their fiscal year ending September 30, 1992 and shall be paid out of the state treasury and distributed by the state treasurer in 12 monthly installments for the period October 1, 1991 to September 30, 1992. If the appropriations for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs are not committed or awarded by April 1, 1992 the funds shall become subject to legislative transfer. Any unexpended and unencumbered funds remaining on September 30, 1992 from the amount appropriated for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs shall lapse on September 30, 1992 and shall be returned to the state general fund. The amount distributed to an institution shall not exceed the net appropriations plus additional distributions specifically authorized by this act.

- (2) A detailed description of procedures utilized to arrive at the amounts appropriated in section 101 shall be submitted to each institution by the senate and house fiscal agencies.
- (3) From the amounts appropriated in section 101, institutions shall reimburse the Michigan public school employees' retirement system at the rate of 9.0% of retirement members' salaries.
- Sec. 203. (1) All colleges and universities shall furnish all program and financial information that is required by and in a manner prescribed by the state budget director or the house and senate appropriations committees.
- (2) Pursuant to section 4 of article VIII of the state constitution of 1963, all state institutions of higher education shall furnish an annual accounting of all income and expenditures to the legislature and the state budget director.

Sec. 204. Money received by the state from the federal government or private sources for the use of a college or university is appropriated for the purpose for which it was provided. The acceptance and use of federal or private funds shall not place an obligation upon the legislature to continue the purposes for which the funds are made available.

Sec. 205. The appropriations contained in this act shall not be used for the construction of buildings or operations of institutions of higher education not expressly authorized in section 101.

Sec. 206. The appropriations in this act are subject to section 391 of the management and budget act, Act No. 431 of the Public Acts of 1984, being section 18.1391 of the Michigan Compiled Laws.

Sec. 207. Each institution that is appropriated funds under this act shall comply with requests for data made by the higher education data base policy council which will be established by the house and senate appropriations subcommittees on higher education.

#### GRANTS AND FINANCIAL AID

- Sec. 301. Payments of the amounts included in section 101 for the state competitive scholarship program established under Act No. 208 of the Public Acts of 1964, being sections 390.971 to 390.981 of the Michigan Compiled Laws, shall be made as follows:
- (a) \$1,200.00 maximum per award in accordance with section 3(1) of Act No. 208 of the Public Acts of 1964, being section 390.973 of the Michigan Compiled Laws.
  - (b) \$25,042,651.00 total state general fund.

Sec. 302. (1) The amounts appropriated in section 101 for the state tuition grant program established under Act No. 313 of the Public Acts of 1966, being sections 390.991 to 390.997a of the Michigan Compiled Laws, shall not exceed the following:

- (a) \$2,300.00 maximum per grant.
- (b) \$50,467,266.00 total state general fund.
- (2) Tuition grant awards shall be made to all eligible Michigan residents who apply before September 1, 1991, and who are qualified.
- (3) The Michigan higher education assistance authority shall determine an actual maximum tuition grant award per student that ensures that the aggregate payments for the tuition grant program do not exceed the appropriation contained in section 101 for the state tuition grant program. By October 1, 1991, and again by December 1, 1991, the authority shall analyze the status of award commitments, shall make any necessary adjustments, and shall confirm that those award commitments will not exceed the appropriation contained in section 101 for the tuition grant program. The final determination and actions shall be reported to the department of management and budget and the house and senate appropriation subcommittees on higher education no later than December 15, 1991. If award adjustments are necessary, the students shall be notified of the adjustment by the second Monday in January.
- (4) Any unexpended and unencumbered funds remaining on September 30, 1992 from the amounts appropriated in section 101 for the tuition grant program shall not lapse on September 30, 1992, but shall continue to be available for expenditure for tuition grants provided in the 1992-93 fiscal year.
- (5) The Michigan higher education assistance authority shall continue for the 1991-92 fiscal year a proportional tuition grant maximum award level for recipients enrolled less than full-time in a given semester or term, utilizing an award maximum of 3/4 of the full-time maximum for students enrolled at least 3/4-time but less than full-time and an award maximum of 1/2 of the full-time award maximum for students enrolled at least 1/2-time but less than 3/4-time. The authority shall include the following provisions in implementing these proportional award maximums:
- (a) Students who receive tuition grant awards at the 3/4-time or 1/2-time maximum level shall remain eligible for cumulative awards equal to the full-time equivalency of the total cumulative number of semester awards or their equivalency stipulated for a given academic level in section 3(1) of Act No. 313 of the Public Acts of 1966, being section 390.993 of the Michigan Compiled Laws.
- (b) Full-time, 3/4-time, and 1/2-time enrollment status at the undergraduate level shall be determined in accordance with the formula and procedures currently utilized in the federal Pell grant program. At the graduate and professional level, full-time, 3/4-time, and 1/2-time enrollment status shall be determined according to the definition of the institution.
- (c) Students who are enrolled in special trimester calendar systems, in which they are technically enrolled at 3/4-time or 1/2-time status in a given semester or term but will complete by the end of the academic year a number of credits equal to at least a year's equivalent of full-time enrollment, shall be recognized as full-time students for purposes of tuition grant eligibility.
- (6) The Michigan higher education assistance authority shall review the appropriateness of the student summer earnings expectations used for purposes of the need analysis system used to determine eligibility for the tuition grant program and implement any appropriate changes in the student summer earnings expectations. The final determination and proposed action shall be reported to the department of management and budget and the house and senate subcommittees on higher education by November 1, 1991.

Sec. 303. Included in the appropriation in section 101 is funding for the Michigan work study program established under Act No. 288 of the Public Acts of 1986, being sections 390.1371 to 390.1382 of the Michigan Compiled Laws, and Act No. 303 of the Public Acts of 1986, being sections 390.1321 to 390.1332 of the Michigan Compiled Laws. Of the amount appropriated for the Michigan work study program, at least \$535,800.00 shall be allocated for graduate work study. An effort should be made by each institution participating in the Michigan work study program to assure that not less than 10% of those undergraduate, graduate, and professional students eligible to participate in the program are placed with for-profit employers no later than

December 31, 1991. The authority shall submit a report to the clerk of the house and the secretary of the senate and the department of management and budget no later than March 31, 1992, specifying the level of participation by each institution, the barriers to the achievement of the 10% for-profit participation level by each institution, and recommendations for addressing those barriers.

- Sec. 304. (1) Payments of the amounts included in section 101 for the general degree reimbursement program established under Act No. 75 of the Public Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled Laws, shall be made for all degrees identified in section 1(1) of that act, being section 390.1021 of the Michigan Compiled Laws, except doctor of dental surgery, doctor of dental medicine, juris doctor law and allied health degrees.
- (2) The reimbursement rate per eligible degree shall be the equally prorated amount permitted by the appropriation, except that the amount of the reimbursement for each associate degree shall be 1/2 of the rate of reimbursement for the other degrees eligible under subsection (1) for the general degree reimbursement program.
  - (3) Total general degree reimbursement payments shall not exceed \$4,513,483.00.
- (4) From the general degree reimbursement program, \$135,300.00 shall be provided to Spring Arbor college for the southern Michigan state prison program.
- (5) From the general degree reimbursement program, \$200,500.00 shall be provided to the university of Detroit for graduate research aid.
- (6) From the general degree reimbursement program, \$30,100.00 shall be provided to Marygrove college for learning clinics.
- (7) From the general degree reimbursement program, \$50,000.00 shall be provided to Suomi college for career education programs.
- Sec. 305. Payments of the amounts included in section 101 for the allied health degree reimbursement program established under Act No. 75 of the Public Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled Laws, shall be made as follows:
- (a) The reimbursement rate per eligible degree shall be the equally prorated amount permitted by the appropriation.
  - (b) Total allied health degree reimbursement payments shall not exceed \$726,963.00.
- Sec. 306. Funds disbursed through the degree reimbursement programs shall not be used by any recipient institution for theology or divinity programs.
- Sec. 307. The funds appropriated in section 101 for the American Indian tuition waiver reimbursement established under Act No. 174 of the Public Acts of 1976, being sections 390.1251 to 390.1253 of the Michigan Compiled Laws, are to reimburse tuition waivers granted by colleges before September 30, 1990. Only those expenses classified as tuition assessments are eligible for reimbursement.
- Sec. 308. Included in the appropriations in section 101 for higher education are \$500,000.00 for the establishment of the Robert C. Byrd honors scholarship program. Pursuant to the implementation of this program, the legislature encourages the department of education to distribute funds for this scholarship program to each high school in this state and to allow each high school to select a merit scholar.
- Sec. 309. To enable the legislature to evaluate the appropriation needs of institutions of higher education, each independent college and university shall make available to the legislature, upon request, data regarding grants for the preceding, current, and ensuing fiscal years.
- Sec. 310. The auditor general shall audit selected enrollments, degrees, and awards at selected independent colleges and universities receiving awards administered by the department of education. The audits shall be based upon definitions and requirements established by the department of management and budget and the senate and house fiscal agencies. The auditor general shall submit a report of findings to the senate and house appropriations committees not later than May 1, 1991.
- Sec. 311. (1) The funds appropriated in section 101 for the Michigan nursing opportunity program are for scholarship awards and tutorial and support program awards for nursing students who demonstrate financial need and who are underrepresented minorities.
- (2) The Michigan higher education assistance authority established under Act No. 77 of the Public Acts of 1960, being sections 390.951 to 390.961 of the Michigan Compiled Laws, shall administer the awards. The

scholarship awards shall be available to each eligible Michigan resident student enrolled in an accredited registered nursing program at a four-year public or independent nonprofit college, a university, or a community college in the state. The tutorial and support program awards shall be available to each accredited registered nursing program at a 4-year public or independent nonprofit college, university, or community college in this state with an enrollment of not less than 5% minority students.

- (3) As used in this section:
- (a) "Nursing program" means an accredited degree program in registered nursing which leads to fulfillment of the requirements for the state nursing examination.
- (b) "Michigan resident" means a person who was a resident of the state at the time of graduation from high school or for a minimum of 12 months prior to enrollment in the nursing degree program.
- (4) The amount of the scholarship award to be paid for each semester or trimester shall be determined by the Michigan higher education assistance authority based upon an evaluation of the applicant's family's financial resources. In determining financial resources, the authority shall use the same criteria as used under Act No. 208 of 1964, being sections 390.971 to 390.981 of the Michigan Compiled Laws.
- (5) Each scholarship award shall not exceed the amount of tuition and fees for the full academic year as reported by the college or university in which the applicant is enrolled, or an amount the Michigan higher education assistance authority finds appropriate in relation to the applicant's family's financial resources, whichever is the lesser.
- (6) Each tutorial and support program award shall not exceed the amount of tuition and fees for the full academic year for each minority student as reported by the college or university in which the student is enrolled. Of the amount appropriated in section 101 for the Michigan nursing opportunity program, an amount not to exceed \$72,000.00 is appropriated for tutorial and support program awards.
- Sec. 312. The sums appropriated in section 101 for state competitive scholarships, tuition grants, part-time independent student grants, grant for Michigan resident dental graduates, grant for general degree graduates, grant for allied health graduates, grant for Indian tuition waivers, Michigan education opportunity grants, and Michigan nursing opportunity grants shall be paid out of the state treasury and shall be distributed to the respective institutions in 9 monthly installments from October 1, 1991 to June 30, 1992.
- Sec. 313. Due to the public universities establishing 1991-92 academic year resident undergraduate tuition and fee rates prior to the enactment of the fiscal year 1991-92 state budget, the legislature recommends that the public universities increase need based financial aid expenditures for Michigan resident undergraduate students at the same rate as their increase in the respective tuition and fee rates.

#### STATE UNIVERSITIES

Sec. 401. (1) The research excellence fund, previously appropriated separately, is included in the amount of \$28,538,821.00 in section 101 in university operations. The research supported by these funds should be conducted in accordance with the following guidelines:

- (a) Leads to the development of scientific or technological discoveries.
- (b) Applies scientific or technological discoveries or advances to new applications.
- (c) Provides a tangible, direct benefit to the economy of the state or region.
- (d) Is of general interest to an entire industrial field.
- (e) Contributes directly or indirectly to the development of additional products or processes.
- (f) May generate outside funding sources.
- (g) The research results or technology advances may be transferred to the private sector.
- (h) These funds should not be used for indirect costs or to supplant existing research resources.
- (2) Each state university shall report on the activities and results of the research supported by these funds to the speaker and minority leader of the house, the majority and minority leaders of the senate, the chairs of the house and senate appropriation committees, the chairs of the house and senate higher education appropriation subcommittees, and the director of the department of management and budget by November 1, 1992. The report shall be in a form and contain such information as determined by the department of management and budget and the house and senate fiscal agencies.

Sec. 402. (1) Included in the amounts contained in section 101, Oakland university is granted \$220,000.00 for the labor education service program.

- (2) Included in the amounts contained in section 101, Oakland university is granted \$30,000.00 for community services of Oakland.
- Sec. 403. It is the intent of the legislature in expending funds for the operation of the D. J. Jacobetti vocational skill center that the following activities be performed in order to insure that the integrity and the original role set forth for the vocational skill center be retained:
- (a) Insuring the flexibility and adequate autonomy that will enable the vocational skill center to expand, upgrade, and modify its existing programs as well as to develop new vocational programs in partnership with its industrial, commercial, agency, and labor advisories. The length and content of programs at the skill center, whether they be certificate, 1-year, or 2-year, shall be determined by the performances required in the marketplace rather than by baccalaureate criteria.
- (b) Developing a ladder of articulation at northern Michigan university that grants fair value for vocational skill center credits that constitute a viable portion of a related 2- or 4-year baccalaureate career ladder. This articulation process shall be accomplished without nullifying the intent of the vocational program or consuming those programs into the baccalaureate department.
- (c) Funding the skill center for its credit hour production in a manner equitable to other vocational technical centers.
- (d) Placing the vocational skill center budget funds and the decision making process for housing certificate and 1- or 2-year vocational technical programs within the vocational skill center under the direct supervision of the vocational skill center administration in order to insure the integrity and the continuation of the role of the skill center.
- Sec. 404. The university of Michigan biological station at Douglas lake in Cheboygan county is regarded as a unique resource and is designated as a special research reserve. It is the intent of the legislature to protect and preserve the unique long-term research value and capabilities of the biological station area and Douglas lake. The legislature further intends that no state programs or policies be developed that would have a deleterious impact on the research value of Douglas lake.
- Sec. 405. (1) The teaching excellence fund appropriated in section 101 is created to recognize outstanding teaching performance by faculty members of state universities.
- (2) An award of \$2,500.00 shall be made to faculty members selected by a process administered by each university which provides for participation by students and members of the faculty. The students and faculty members participating in the selection process shall be representative of all segments of the campus community, including academic discipline, academic level, instructional level, race, and sex. Students shall comprise at least 1/3 of the selection committee. All faculty members of a university shall be eligible for selection for an award.
- (3) The criteria to be used in the selection process are to be limited to the following: superior classroom performance, innovative instructional practice, high educational standards, and concern for students in and out of the classroom.
- (4) By May 1, 1992 each university receiving teaching excellence funds shall report to the legislature and the department of management and budget the following: the names of faculty members receiving teaching excellence fund awards, the basis for each award, and a description of the selection process, including the names, sex, and race of the students and faculty members participating in the selection process; and also the names, sex, and race of the recipients shall be provided in each annual report.
  - (5) Each institution shall receive a number of awards based on the number of full-time faculty as follows:
- (a) 2 awards each: Lake Superior state university, Saginaw valley state university, university of Michigan at Flint, university of Michigan at Dearborn, and Grand valley state university.
- (b) 4 awards each: Michigan technological university, northern Michigan university, and Oakland university.
  - (c) 6 awards each: Ferris state university and central Michigan university.
  - (d) 8 awards each: eastern Michigan university and western Michigan university.
  - (e) 12 awards: Wayne state university.
  - (f) 18 awards: university of Michigan at Ann Arbor.
  - (g) 20 awards: Michigan state university.

The funds awarded under this section shall not supplant current institutional expenditures devoted to the selection and monetary recognition of outstanding teaching performance by faculty members.

Sec. 406. Included in section 101 for Michigan state university is \$65,500.00 for the university to maintain its capacity to prepare teachers of the visually impaired. This funding shall not supplant any existing funding for the program.

Sec. 407. The legislature recommends that the ratio of out-of-state students at any state university not exceed 30% of undergraduate student enrollment and 38% of graduate student enrollment.

Sec. 408. Included in the appropriation in section 101 for the agriculture experiment station is \$150,000.00 for the Michigan dry bean initiative project. The \$150,000.00 shall be expended for new varietal and food processing research and shall not be substituted for any funds currently being expended on dry bean research. This funding shall not be considered as part of the base appropriation for the agriculture experiment station and shall not continue beyond the completion of the project.

#### CONSORTIA AND COOPERATIVE PROGRAMS

Sec. 501. Included in the amounts appropriated in section 101, there is appropriated to Wayne state university the sum of \$451,020.00 for cooperative leadership skills programs for trade union minorities and women. This program is to be offered by a consortium consisting of eastern Michigan university, Michigan state university, northern Michigan university, Oakland university, university of Michigan, and Wayne state university. Wayne state university shall act as fiscal agent, and the funds shall be divided among the participating universities.

Sec. 502. Included in the amounts appropriated in section 101 are funds for the following consortia projects:

- (a) Northern inter-collegiate research sharing consortium central Michigan university and Kirtland community college.
  - (b) Industrial development institute Michigan state university and Lansing community college.
- (e) Enabling technology consortium university of Michigan, Michigan state university, and Wayne state university.
- (d) Kalamazoo consortium western Michigan university, Grand Valley state university, Kalamazoo valley community college, Kalamazoo college, Davenport college, and Nazareth college.
- (e) Urban teacher education consortium eastern Michigan university, Wayne state university, and Wayne county community college.
- (f) Michigan higher education institute Michigan state university, Grand Valley state university, and western Michigan university.
  - (g) Grand Rapids applied technology center Ferris state university and Grand Rapids junior college.
  - (h) Race relations consortium Wayne state university and western Michigan university.
- (i) Polymer technology consortium Michigan technological university, central Michigan university, Wayne state university, eastern Michigan university, western Michigan university, Michigan state university, and the Michigan molecular institute.
- Sec. 503. The legislature recognizes the value of cooperative programs between state universities and community colleges aimed at stimulating economic development and diversification in this state. It is the intent of the legislature to encourage continued development and expansion of these cooperative programs in the years ahead.
- Sec. 504. (1) Included in the appropriation in section 101 is \$222,750.00 for scholarships for students participating in a full-year academic year program at the Japan center for Michigan universities. Individual scholarships shall not exceed \$7,500.00. This scholarship program is under the jurisdiction of the presidents council of state universities. A report on the expenditure of these funds shall be submitted to the house and senate higher education appropriations subcommittees and to the Michigan higher education assistance authority no later than March 1, 1992.
- (2) It is the intent of the legislature to enable Michigan university students to study the language and culture of Japan in the prefecture of Shiga, Michigan's sister state. The amount of \$81,000.00 is appropriated for the Japan center for Michigan universities. The amount of \$5,400.00 is included in the appropriation for each university for the administration of the Japan center for Michigan universities. The presidents council of state universities shall submit a progress report to the house and senate higher education appropriations

subcommittees by March 1, 1992. The Japan center for Michigan universities, which is located in Hikone, Japan, has the following 4 major program components:

- (a) Japanese language and culture studies for Michigan students.
- (b) English language studies for Japanese citizens.
- (c) Workshops and seminars for Japanese and American businesses and professional persons.
- (d) Research by faculty and students.

Sec. 505. It is the intent of the legislature to fund the consortium on race relations from the funds appropriated under this act. The consortium is to be comprised of the race relations institute at Wayne state university, and the institute for the study of race and ethnic relations at western Michigan university. The consortium is to be governed by an advisory council consisting of 2 members from Wayne state university, 2 members from western Michigan university, and chairs of the house and senate higher education appropriations subcommittees. The consortium shall conduct research; provide outreach programs; promote racial and ethnic harmony; and encourage participation and commitments from other higher education institutions and communities.

Sec. 506. It is the intent of the legislature to provide financial support to a consortium of state universities and Muskegon community college for the provision of baccalaureate and graduate degree programs in the Muskegon county area. This statement of legislative intent is contingent upon the establishment of the consortium.

Sec. 507. It is legislative intent that the house and senate appropriations subcommittees on higher education will develop a policy for funding the operational costs of new facilities at public universities.

### MARTIN LUTHER KING, JR.-CESAR CHAVEZ-ROSA PARKS PROGRAMS

Sec. 601. (1) Included in the appropriation for each Michigan public university from the amount in section 101 is funding for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program.

- (2) Universities with student head count totals exceeding 20,000 for the fall of 1990 are appropriated \$91,600.00 each. Universities with student head count totals of less than 20,000 for the fall of 1990 are appropriated \$22,900.00 each.
- (3) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program funds shall be expended to increase the number of minority instructors in the classroom and provide role models for underrepresented minority students.
- (4) The office of minority equity in postsecondary education shall report by December 1, 1991 to the house and senate appropriations committees, the house and senate fiscal agencies, and the department of management and budget all of the following Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program information:
  - (a) Names of visiting professors.
  - (b) Courses instructed by visiting professors.
  - (c) Duration and dates of instruction.
- (d) Employment status, excluding Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor duties.
  - (e) Race and sex of visiting professors.
- (5) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor funds shall be equally matched with institution funding devoted to the visiting professor program.
- (6) An applicant for a visiting professor award shall provide all of the following information to the office of minority equity in postsecondary education at the time of application:
  - (a) The name of each institution where the applicant has served in a visiting professor capacity.
  - (b) Courses instructed as a visiting professor at each institution.
  - (c) Money earned for serving as a visiting professor at each institution.
  - (d) The dates during which the applicant served as a visiting professor at each institution.

- Sec. 602. (1) Included in the appropriation for each public university in this state from the amount appropriated in section 101 is funding for a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty program. The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty program is intended to increase the pool of minority candidates pursuing full-time faculty teaching careers in postsecondary education in this state.
- (2) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty program shall be administered by each institution. Each institution may grant a fellowship to a student to attend any Michigan university. An award shall be granted to a candidate considered by the granting institution to be an underrepresented minority in that academic field of study. University of Michigan-Ann Arbor, Michigan state university, Wayne state university, and western Michigan university may grant only fellowships for study toward a doctorate degree under this program.
- (3) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks doctorate level fellowship shall be awarded to a candidate who will:
- (a) Pursue a doctorate at a Michigan postsecondary educational institution in a field or academic discipline where there is demonstrable evidence of significant underrepresentation of minority faculty in Michigan.
- (b) Begin a full-time faculty career in a Michigan postsecondary educational institution within 1 year after attaining his or her doctorate degree.
- (c) Remain in a full-time faculty career in Michigan postsecondary education for a period of not less than 3 years.
- (4) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks masters level fellowship shall be awarded to a candidate who is pursuing a masters degree and who will pursue a doctorate degree at a Michigan postsecondary educational institution or will teach full-time in a postsecondary educational institution within 1 year after attaining his or her masters degree. Masters level fellowship forgiveness will accrue at the rate of \$5,000.00 for each year within the payback period the fellow is employed in a full-time teaching position in a Michigan public or independent 2- or 4-year college or university.
- (5) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty fellowship is intended to offset any educational or living expenses that the fellow may incur, so long as he or she remains in good academic standing as defined by the host institution.
- (6) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship award shall not exceed \$25,000.00 for a student pursuing a doctorate degree, and \$15,000.00 for a student pursuing a master's degree. A fellowship/scholarship candidate shall not receive more than 1 Martin Luther King, Jr.-Cesar Chavez-Rosa Parks award to pursue the same degree or a degree at the same level of study. Recipients of Martin Luther King, Jr.-Cesar Chavez-Rosa Parks masters degree fellowships are to be considered candidates for doctorate degree fellowships when eligible.
- (7) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks doctorate level fellow has 6 years in which to attain his or her doctorate degree. This 6-year period begins after obtaining a master's degree or spending an equivalent 2-1/2 year period at master's level studies. A masters level fellow shall attain the master's degree within 2-1/2 years of receiving the award. The Michigan higher education assistance authority may extend these periods by 1 year for good cause.
- (8) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty fellowship shall be defaulted and considered a loan subject to repayment in full to the state if any 1 of the following occurs:
  - (a) The fellow fails to maintain good academic standing at the postsecondary institution.
  - (b) The fellow fails to attain the appropriate degree in the time required by subsection (7).
- (c) The doctorate level fellow does not meet the requirements of subsection (3)(a), (b), and (c), or the masters level fellow does not meet the requirements of this section.
- (9) The Michigan higher education assistance authority shall cancel 1/3 portion of the fellowship debt upon receipt of the degree for which the fellowship was granted, for fellows who are Michigan residents, as defined by the awarding institution, prior to calculating repayment obligations.
- (10) The first fellowship repayment is due within 1 year of fellowship default, as described in subsection (8). The loan amount to be repaid shall include the fellowship/scholarship award, plus interest calculated at a rate not less than that of the guaranteed student loan at the time of default, and collection fees including attorney fees, according to a schedule established by the Michigan higher education assistance authority. Interest amounts shall be calculated pursuant to the interest computation procedures of the guaranteed student loan program. Repayment shall be made according to a schedule published by the Michigan higher education assistance authority. The schedule shall call for repayment of the loan within a period of not more than 10 years, or monthly repayment of \$100.00, whichever is greater.
- (11) Each university granting Martin Luther King, Jr.-Cesar Chavez-Rosa Parks awards shall require recipients to sign an agreement specifying acceptance of the terms of the award.

- (12) The Michigan higher education assistance authority shall implement and administer the loan repayment provisions of subsections (8), (9), and (10).
- (13) The Michigan higher education assistance authority may extend forbearance in the form of a reduced monthly payment of principal and interest for any period or periods not to exceed a total of 24 months to a defaulted fellow who demonstrates to the satisfaction of the Michigan higher education assistance authority that the fellow is experiencing serious financial hardship, even though the forbearance would extend the loan repayment period beyond 10 years.
- (14) The Michigan higher education assistance authority shall report by September 30, 1992 to the house and senate appropriations committees and the office of minority equity in postsecondary education all of the following information:
  - (a) Names of fellows, the institutions, and fields of study.
- (b) Names of masters level fellows having completed their master's degree requirements and their current educational status or employment status or employing institutions, or both.
- (c) Names of doctorate level fellows having completed their studies, and their current employment status or employing institutions, or both.
- (d) Names of fellows in default as described in subsections (7) and (8), and the status of their Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship repayment.
- (15) The Michigan higher education assistance authority shall cancel the unpaid loan amount of a defaulted fellow who dies or becomes totally and permanently disabled and has such disability certified by a licensed doctor of medicine or osteopathy.
- (16) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks future faculty funds shall not supplant institutional funding devoted to the purpose stated in subsection (1).
- (17) On April 15, 1992, each university shall report to the office of minority equity in postsecondary education the name and social security number of each recipient of a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship, and the amount, date, and duration of the award.
- (18) If any funds are not awarded or committed by a university to a specific recipient by April 1, 1992, the department of management and budget may recommend legislative transfers to other Martin Luther King, Jr.-Cesar Chavez-Rosa Parks line items within a university or to Martin Luther King, Jr.-Cesar Chavez-Rosa Parks line items at another university.
- Sec. 603. (1) Included in section 101 is funding for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program. The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program is an intervention program intended to introduce school children underrepresented in postsecondary education to the potential of a college education.
- (2) The programs shall provide a day, overnight, or extended experience on the college campus for pupils in grades 6 through 11, if the program meets the intent stated in subsection (1), and is designed primarily as a motivational program to inspire targeted pupils to pursue a college education. It is not designed principally as an academic or athletic skills development program.
- (3) If possible and practical, the program shall focus on serving those 35 school districts with the highest percentage of minority pupils as reported to the Michigan department of education. However, all eligible pupils from the participating school districts shall be included in this program, regardless of the pupil's race.
- (4) Each pupil participating in the program shall be provided with standard appropriate background information describing the Michigan postsecondary education system, both 2-year and 4-year public and independent degree granting colleges and universities, the opportunities afforded by a college experience, admissions requirements, and financial aid availability. The Michigan department of education shall develop and make available this material.
  - (5) Individual program plans shall include all of the following:
- (a) A budget of equal contributions from this program, the participating public university, the participating school district, and the participating independent degree granting college. No college day funds may be deducted to cover indirect costs. No more than 20% of the university match may be attributable to indirect costs.
- (b) A letter of support signed by the superintendents of the participating school districts and the presidents or chancellors of the participating colleges and universities named under subdivision (a).
- (c) The formal involvement of the appropriate public 2-year colleges and independent degree granting colleges in the college day program.
- (6) The office of minority equity in postsecondary education shall report by December 1, 1992 to the house and senate fiscal agencies and the department of management and budget all of the following for each participating university and school district:

- (a) Number of pupils participating and their schools.
- (b) Age, race, and sex of participating pupils.
- (c) Description of the college experience offered by the program to the pupils.
- (d) A copy of the program plans described in subsection (5).
- (e) A copy of the program budget.
- (7) The participating school district and the participating colleges and universities shall retain the information as is necessary to assess the long-range impact of the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program on the high school graduation rate, college attendance of participating pupils, or any other benefits that may be realized by this program.
- (8) The universities shall submit a report to the office of minority equity in postsecondary education by November 30, 1991, detailing their plans for college day activities for the 1991-92 fiscal year.
- Sec. 604. (1) From the amount appropriated in section 101 for select student support services programs, \$1,673,100.00 is allocated for developing academically and economically disadvantaged student retention programs for 4-year public and independent educational institutions in this state.
- (2) Not later than January 1, 1992, the office of minority equity in postsecondary education shall develop and make available proposal guidelines to eligible 4-year institutions for programs described in subsection (1). Each proposal shall be submitted to the office not later than February 15, 1992.
- (3) A peer review committee shall be established by the office of minority equity in conjunction with the presidents council of state universities and the association of independent colleges and universities of Michigan to review submitted proposals and to make recommendations.
- (4) A 3-member review panel composed of 1 member appointed by the speaker of the house of representatives, 1 member appointed by the majority leader of the senate, and 1 member appointed by the state budget director shall review all committee recommendations and make awards.
- (5) The review panel shall make its awards to eligible institutions not later than April 1, 1992. An award to any 1 institution shall not be greater than \$150,000.00, and the amount awarded shall be matched on a 70% state, 30% college-university basis.
- (6) An educational institution that receives an award under this section shall report at the end of its grant period to the house and senate appropriations committees, the office of minority equity in postsecondary education, and the department of management and budget all of the following information:
  - (a) A description of select student support services programs initiated.
  - (b) The number of participants, measured in head count, by racial, ethnic, and 4-S program category.
- (c) Other information considered necessary or appropriate by the office of minority equity in postsecondary education.
- Sec. 605. (1) Included in section 101 is funding for a linkage program between public 4-year universities and public community colleges. The purpose of this program is to increase the number of underrepresented minority students who transfer from community colleges into baccalaureate programs.
- (2) The grants shall be made under this program to Michigan public universities. The grants shall reflect geographic diversity.
- (3) Not later than October 1, 1991, the office of minority equity in postsecondary education shall develop and make available proposal guidelines to eligible universities. Each proposal shall be submitted to the office not later than October 30, 1991.
- (4) The office of minority equity in postsecondary education shall review submitted proposals and make recommendations to the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks review panel established in section 604.
- (5) The review panel shall review the recommendations of the office of minority equity in postsecondary education and make awards not later than November 15, 1991. An award to any 1 institution shall not be greater than \$150,000.00, and the amount awarded shall be matched on a 70% state, 30% university basis.
- (6) An educational institution that receives an award under this section shall report at the end of its grant period, to the house and senate appropriations committees, the department of management and budget, and the office of minority equity in postsecondary education in the manner requested by the office of minority equity in postsecondary education on the progress made to increase the number of minority students transferring from the community college into baccalaureate degree programs.

Sec. 606. Included in the appropriation in section 101 for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks program is \$147,233.00 for a college preparatory and financial aid information program. From this

amount, the office of minority equity shall develop programs to motivate minority students to enter higher education and to instruct minority students and their families in college preparatory requirements, procedures, and financial aid opportunities.

Sec. 607. It is the intent of the legislature that funds from the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks program shall not be used for any purpose other than the purposes designated in this act. No part of the funds or the institution's matching funds for any of the Martin Luther King, Jr. -Cesar Chavez-Rosa Parks initiative programs shall supplant institutional funding devoted to similar purposes or shall be deducted to cover indirect costs except as provided in this act.

# UNIVERSITY SERVICE TO K-12 EDUCATION

- Sec. 701. (1) From the amount appropriated in section 101 for state universities, the state universities shall systematically inform Michigan high schools regarding the academic status of students from each high school.
- (2) Not later than September 15, 1992, each state university shall prepare and deliver to each Michigan high school that had at least 3 graduates enrolled as FTIACs at the university in academic year 1991-92 a report on the status of those students, using the standard format developed under subsection (4). Each university shall report all of the following information on FTIACs who had been enrolled at the respective state university in the summer or fall, 1991:
- (a) The total number of FTIACs, the total number of FTIACs from Michigan high schools, and the total number of FTIACs from that high school.
- (b) The average English, math, and composite scores on the American college test (ACT) and the combined scores on the scholastic aptitude test (SAT) for the total number of FTIACs, the total number of FTIACs from Michigan high schools, and the total number of FTIACs from that high school.
- (c) Description of the criteria used in the placement of a FTIAC in a remedial/developmental course or program by subject/course area, if such remedial/developmental courses or programs are provided.
- (d) The total number of FTIACs, the number of FTIACs from Michigan high schools, and the number of FTIACs from that high school participating in remedial developmental activities by course or program.
- (e) Description of the criteria used to award advanced placement credit, by the subject/course area, if such credit is provided.
- (f) The total number of FTIACs, the number of FTIACs from Michigan high schools, and the number of FTIACs from that high school in the following category:
- (i) Applied to the university for advanced placement credit through the college board's advanced placement program (AP) or other examination or instrument.
- (ii) Scored above the minimum threshold for advanced placement credit through the college board's advanced placement program (AP) or other examination or instrument, identifying the subject/course area.
- (3) Confidentiality of individual student records shall be maintained by the recipient high schools in accordance with section 438 of subpart 2 of part C of the general education provisions act, title IV of Public Law 90-247, 20 U.S.C. 12323g, commonly referred to as the family educational rights and privacy act of 1974.
- (4) Not later than March 30, 1992, the presidents council, in cooperation with the Michigan association of secondary school principals, shall review and make changes as required to the current standard format and distribute a revised standard format for reporting the information required under subsection (1) to each state university.
- (5) Not later than October 30, 1992, the presidents council of state universities shall submit a report to the chairs of the house and senate appropriations committee, and the department of management and budget concerning the implementation of the reporting system required under this section.
  - (6) As used in this section "FTIAC" means a student enrolled for the first time in a college or university.

Sec. 702. To encourage more students to study mathematics in high school and to reduce the amount of remediation in the mathematics area at the college and university level, \$190,500.00 is appropriated in section 101 for the Michigan mathematics early placement test. Included within the appropriation in section 101 for each state university is \$12,700.00 for activities to increase both the number of students and high schools participating in the Michigan mathematics early placement test, a program of the presidents council of state universities. A report on the results of the mathematics early placement test program shall be submitted by the presidents council of state universities to the house and senate higher education appropriations subcommittees, the department of management and budget, and the department of education by June 15, 1992.

Sec. 703. Included in the amounts contained in section 101, Wayne state university is granted \$320,000.00 for the college of education to deliver professional school district programs to meet their service needs. A minimum of \$100,000.00 shall be allocated for the establishment and maintenance of a staff development/school improvement program with the intermediate school district servicing its area.

Sec. 704. It is the intent of the legislature that eastern Michigan university shall coordinate a professional teacher development program for local area school districts.

Sec. 705. Included in the appropriations in section 101 is funding for the urban teacher education program. The amount appropriated shall be equally divided among eastern Michigan university, Wayne state university, and Wayne county community college for the sole purpose of development and implementation of the urban teacher education program approved by the state board of education. Not less than 75% of the allocation to each institution for the urban teacher education program shall be spent for operation and support of activities and personnel to advise and counsel students and support the field-based teacher education experiences of students.

#### GENERAL REPORTS AND AUDITS

Sec. 801. (1) The auditor general shall audit enrollments at 5 randomly selected public universities. The audits shall be based upon the definitions and requirements established by the department of management and budget and the senate and house fiscal agencies. The audits shall be based on uniform reporting categories and shall include HEIDI data. The auditor general shall submit a report of findings to the senate and house appropriations committees no later than March 1, 1992.

- (2) Student credit hours reports shall not include the following:
- (a) Student credit hours generated through correspondence courses, credit by examination, or inmate prison programs regardless of teaching location.
- (b) Student credit hours generated in new degree programs after January 1, 1975, that have not been specifically authorized for funding by the legislature, except spin-off programs converted from existing core programs that do all of the following:
  - (i) Represent new options, fields, or concentrations within existing programs.
  - (ii) Are consistent with the current institutional role and mission.
  - (iii) Are accommodated within the continuing funding base of the institution.
- (iv) Do not require a new degree level beyond that which the institution is currently authorized to grant within that discipline or field.
- (v) Do not require special grant funding from the state. As used in this subparagraph, "special grant funding" means funding in addition to that provided by the student credit hours generated within the program, either before program initiation or within the first 3 years of program operation.

- (2) The listing of degree programs in subsection (1) shall not constitute legislative intent to provide additional dollars for those programs.
- Sec. 802. The principal executive officer of each institution of higher education receiving an appropriation under this act shall expend a portion of the funds appropriated to the institution in reporting to the house and senate appropriations committees, the auditor general, the senate and house fiscal agencies, and the department of management and budget within 60 days after the auditor general issues his or her annual report on the operation of the institution. The institution's report shall specify all of the following:
- (a) The recommendations of the auditor general implemented by the institution, including projected dates and resources required, if any, to achieve compliance.
- (b) The recommendations of the auditor general not implemented by the institution or implemented by the institution as modified.
- (c) The rationale for not implementing a recommendation of the auditor general or of implementing a recommendation as modified.
- Sec. 803. Each state university shall submit an annual report to the department of management and budget and to the chairpersons of the house and senate higher education appropriations subcommittees in a manner prescribed by the department of management and budget describing each energy conservation project financed wholly or in part by oil overcharge revenues appropriated in fiscal year 1987 and fiscal year 1988. The report shall include a description of each energy conservation project and the actual expenditures and energy savings estimates. The information contained in the report shall be utilized to meet the annual reporting requirements to the United States district court and the United States secretary of energy regarding state use of oil overcharge refunds.
- Sec. 804. Each university shall submit the following reports by November 1, 1991 to the governor, department of management and budget, speaker and minority leader of the house, majority and minority leader of the senate, chairs of the house and senate appropriations committees and chairs of the house and senate higher education appropriations committees.
  - (a) Efforts to improve and emphasize undergraduate instruction.
  - (b) Efforts to ensure the English language proficiency of teaching faculty.
- (c) Efforts to provide instructional opportunities to nontraditional students, particularly for part-time and continuing education students during evenings and weekends.
- Sec. 805. An institution receiving funding under this act and also subject to the student right-to-know and campus security act, Public Law 101-542, 104 Stat. 2381 shall furnish by September 1, 1992 to the chairpersons of the house and senate appropriations committees, the chairpersons of the house and senate appropriations subcommittees on higher education and the house and senate fiscal agencies a copy of all material prepared pursuant to the public information reporting requirements under the crime awareness and campus security act of 1990, title II of the student right-to-know and campus security act, Public Law 101-542, 104 Stat. 2381.
