ENROLLED HOUSE BILL No. 5589

AN ACT to make and adjust appropriations for the department of military affairs and the department of treasury for the fiscal year ending September 30, 1993; and to provide for the expenditure of the appropriations.

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total spending from state resources in this appropriation act is \$0 and state appropriations to be paid to units of local government in section 101 are \$0.

Sec. 202. The appropriations made and expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

Sec. 203. (1) The department of military affairs shall identify those national guard armories and facilities that would be appropriate for use as temporary shelter for the homeless. Staffing of these national guard armories and facilities shall make maximum use of available Michigan military personnel who shall receive service credit for their efforts.

(2) Prior to disposing of Michigan national guard armories or facilities, the department of military affairs shall make them available to any private organization that provides, as one of its primary purposes, assistance to the homeless.

This act is ordered to take immediate effect.
