ENROLLED SENATE BILL No. 153

AN ACT to make appropriations for the department of natural resources and for capital outlay purposes for the fiscal year ending September 30, 1991; to provide for certain work projects; to prescribe the powers and duties of certain state agencies and officials; and to provide for the expenditure of the appropriations.

The People of the State of Michigan enact:

Sec. 101. There is appropriated for the department of natural resources and for capital outlay purposes to supplement former appropriations for the fiscal year ending September 30, 1991, from the following funds:

Sec. 202. The appropriations made and expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

Sec. 203. For all projects and grant programs funded under this act, the commission of natural resources or the department of natural resources shall notify each legislator whose district is to receive a grant 7 days before the grant is announced.

CAPITAL OUTLAY

Sec. 301. The unexpended portion of the appropriation in section 101 for wildlife management recreation bond projects shall be considered a work project and shall not lapse to the recreation bond fund but shall continue to be available for the purpose for which it was appropriated.

Sec. 401. This act shall not take effect unless Senate Bill No. 152 of the 86th Legislature is enacted into law.

This act is ordered to take immediate effect.
